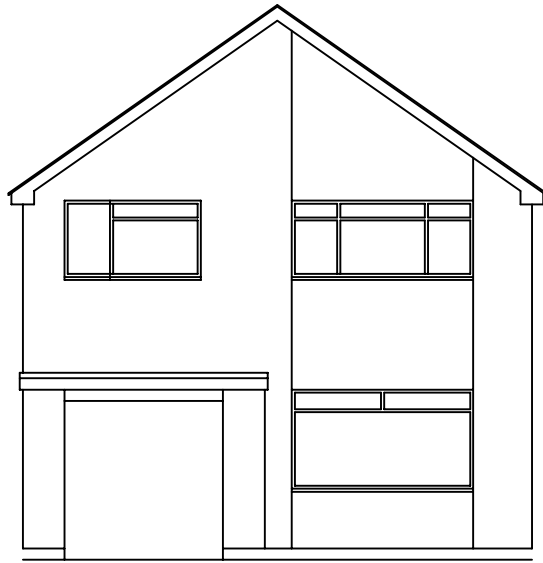

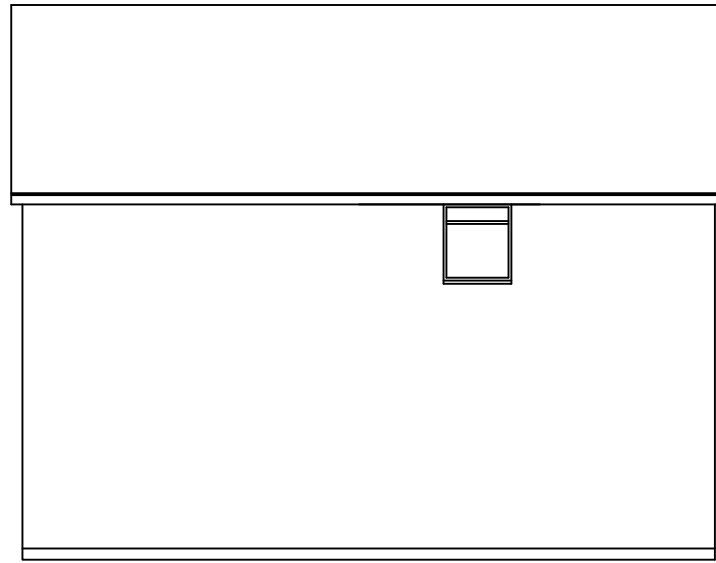

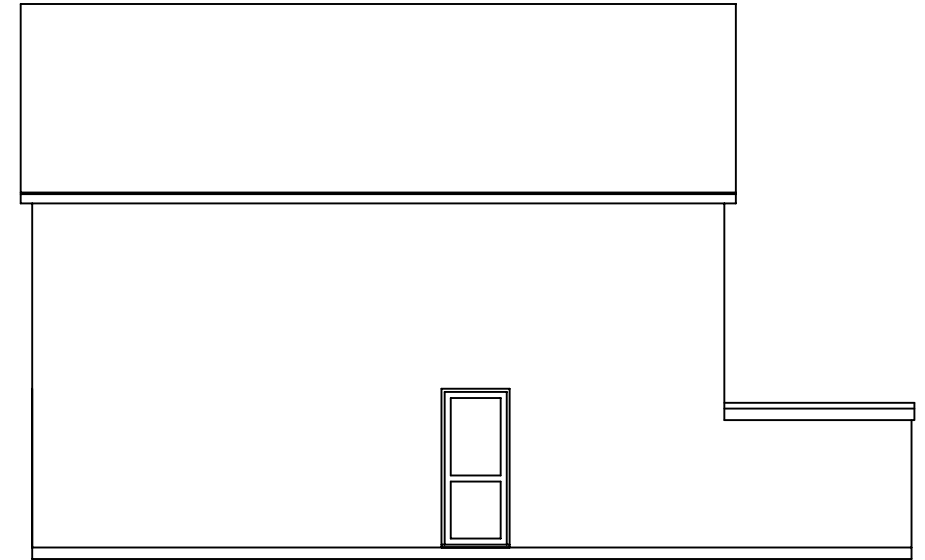

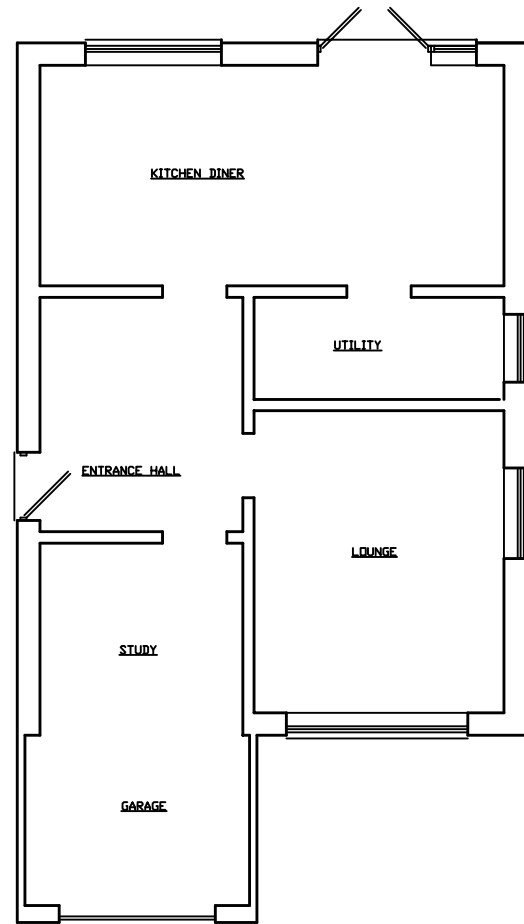
EXISTING FRONT ELEVATION

EXISTING GROUND FLOOR

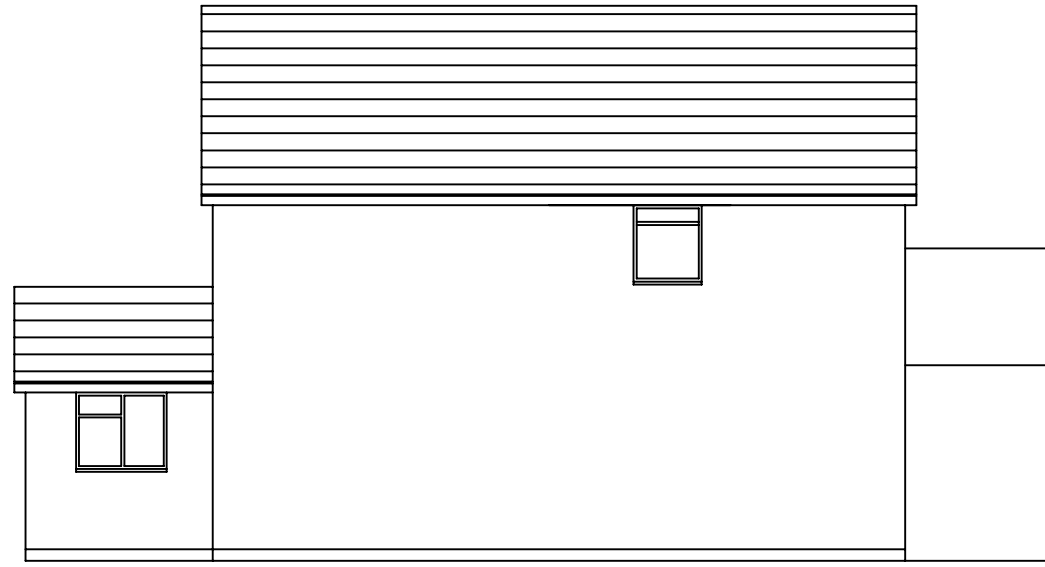

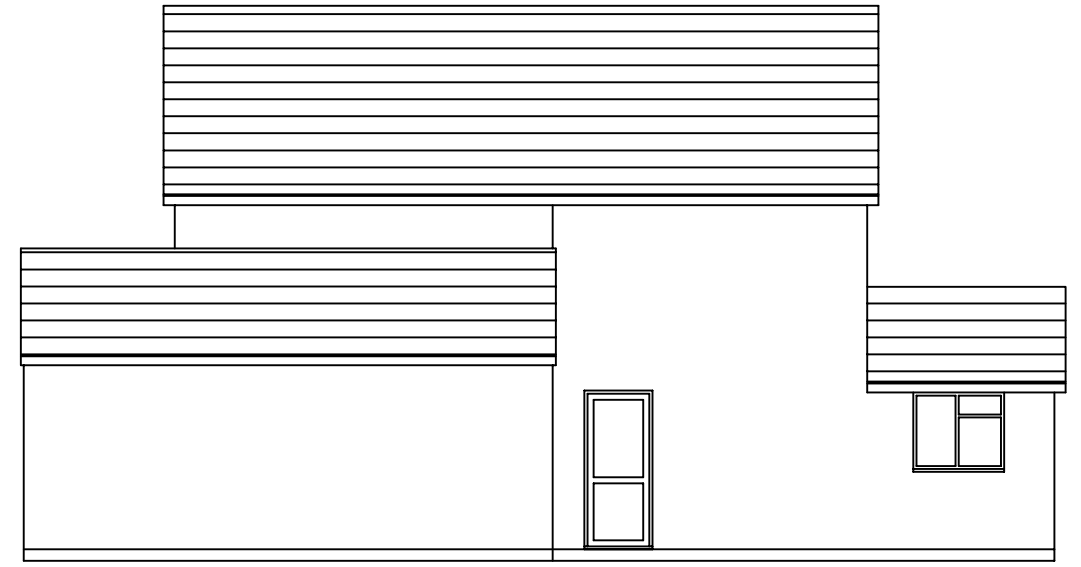

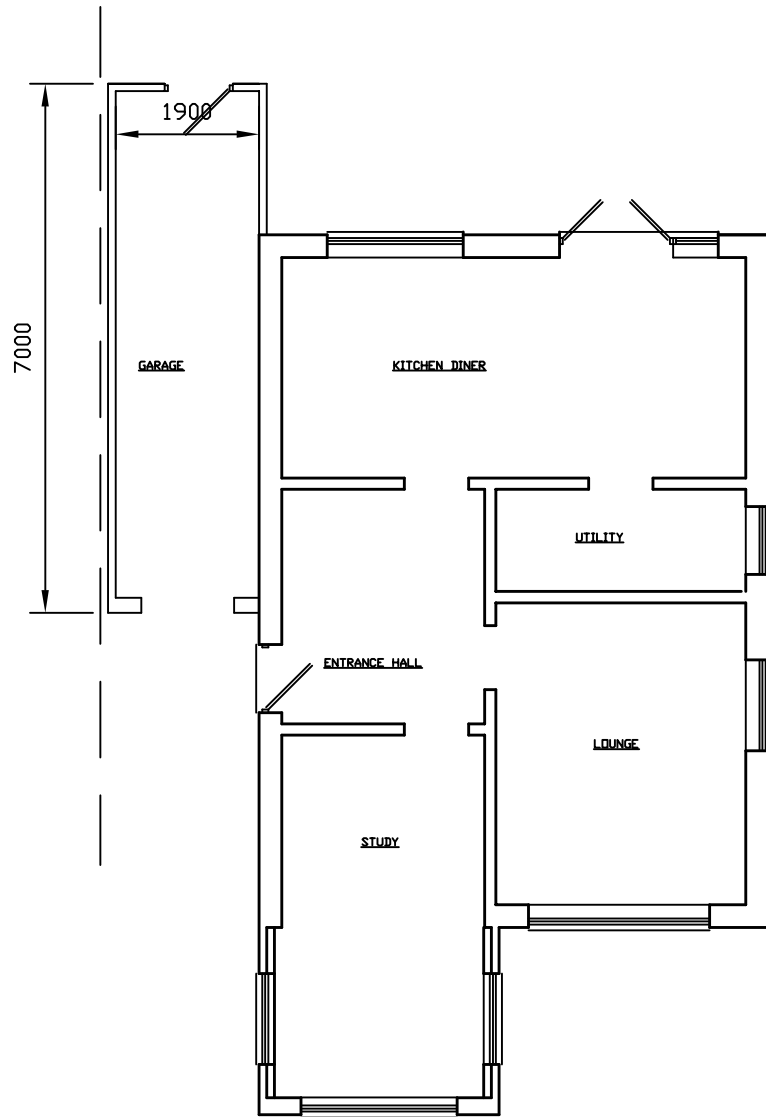

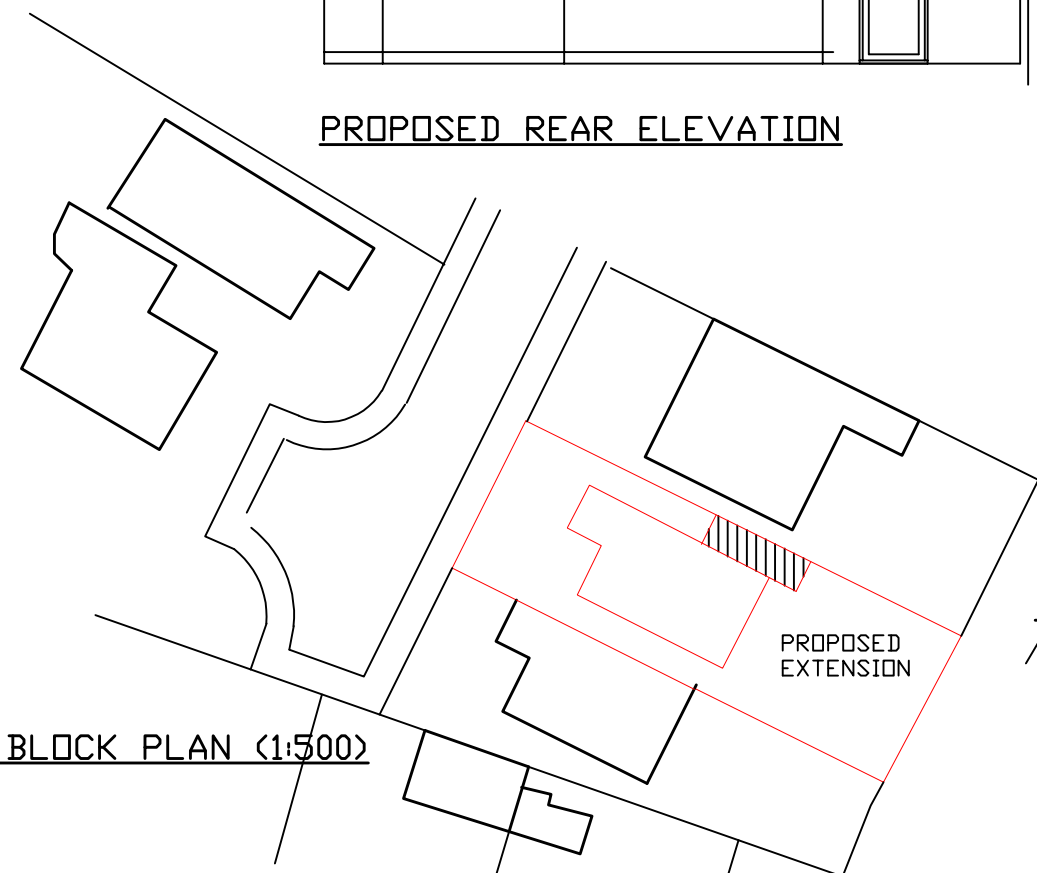
