NOTE: The City of Gloucester will consider permitting advertising signs for a period of 12 months providing the site where the sign is positioned does not become a danger or nuisance. The Pedestrian Scheme for the City of Gloucester seeks to ensure a clear walkway in front of the shops is maintained for the safety and convenience of shoppers and in particular blind and partially sighted people.

Consideration will be given to your application provided the sign meets the following criteria:

- a. The A-Board should be attractive. i.e. is well designed and made and has professional quality sign writing.
- b. The A-Board needs to be carefully sited so that it does not become a nuisance for disabled people.
- c. The A-Board must be directly associated with the business.

Only **ONE** sign will be considered for each business. The Council will remove any unauthorised signs and the costs incurred to carry out this matter will be recharged to the business concerned.

Upon approval of the application a licence will be issued and a permit supplied which shall be kept at the premises and be available at any time for an authorised officer from the Local Authority to inspect.

A sketch or photograph must be enclosed with the application form showing the proposed design and layout of the advertising sign. It is recommended you seek approval of any new A-Board or change to an existing A-Board prior to manufacture because the application could be refused.
