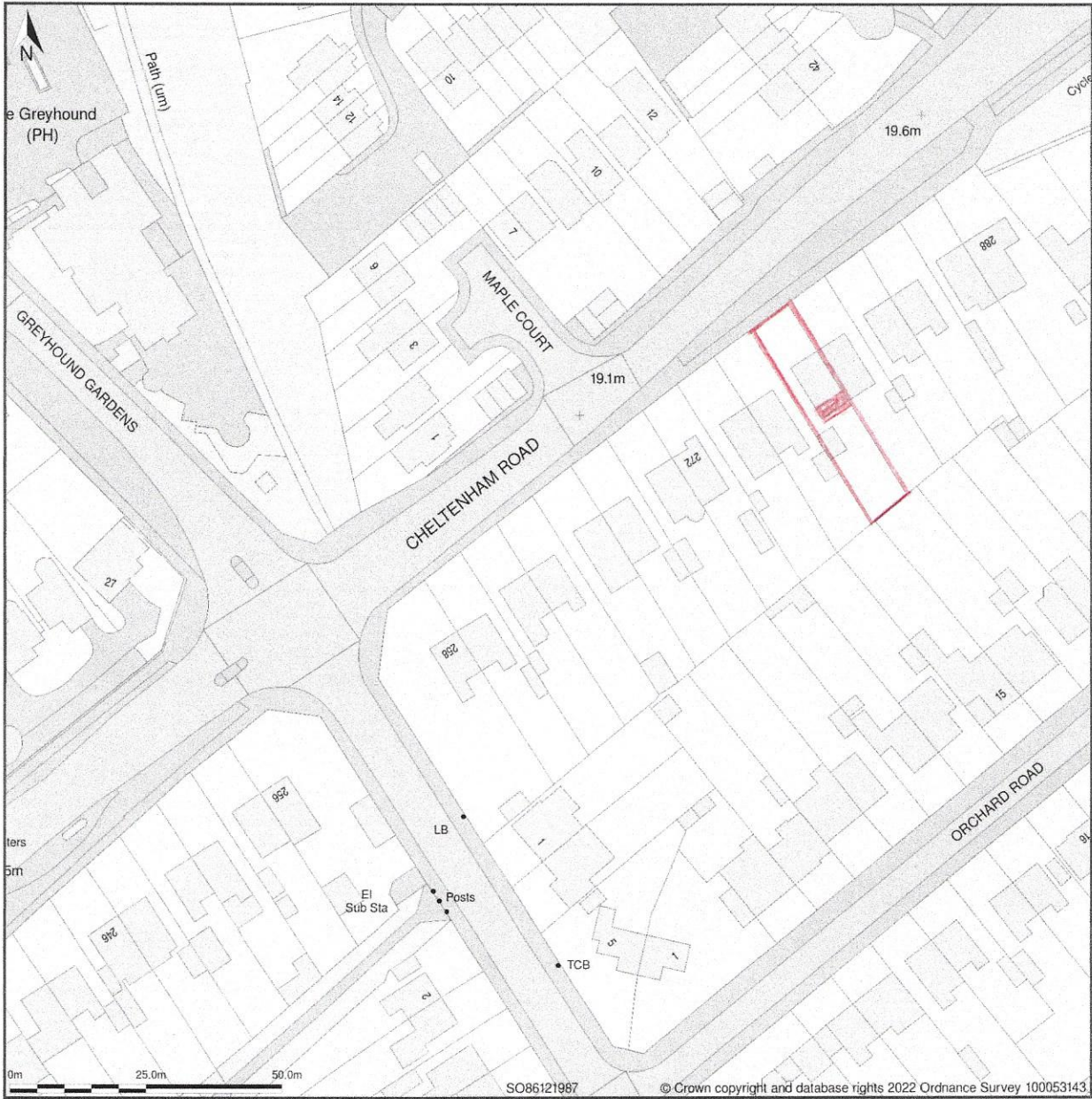

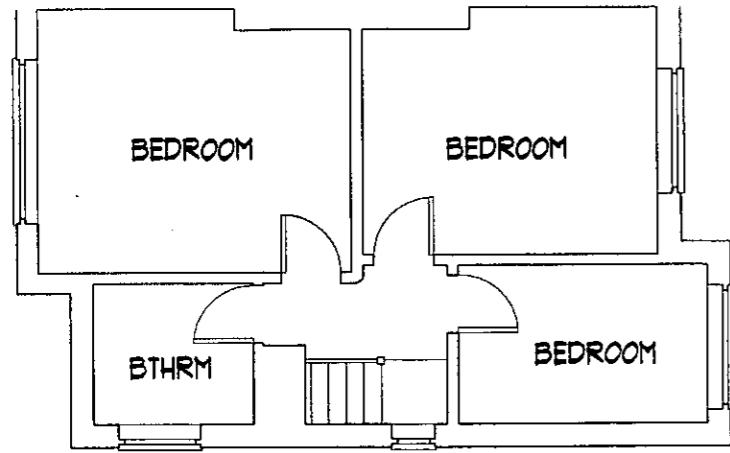

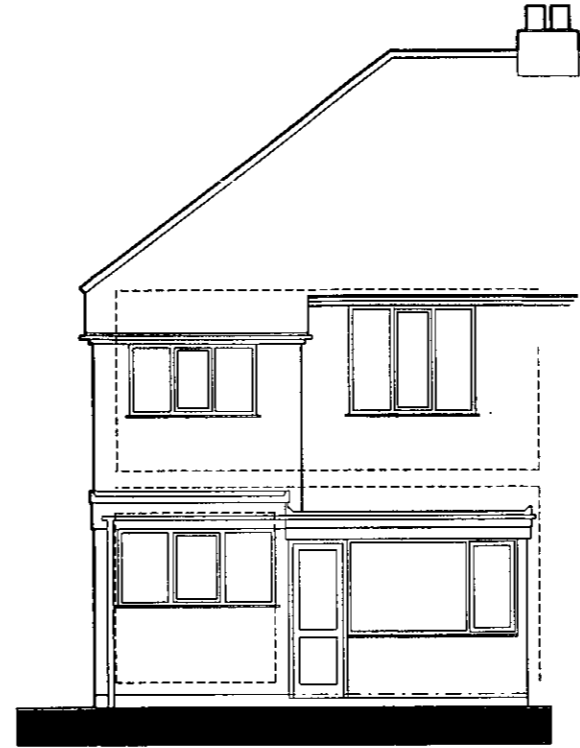

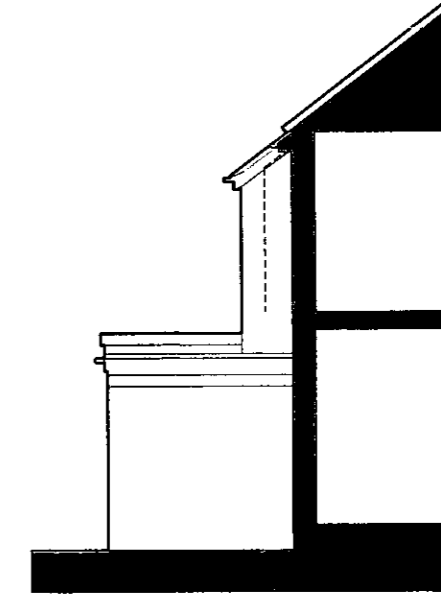

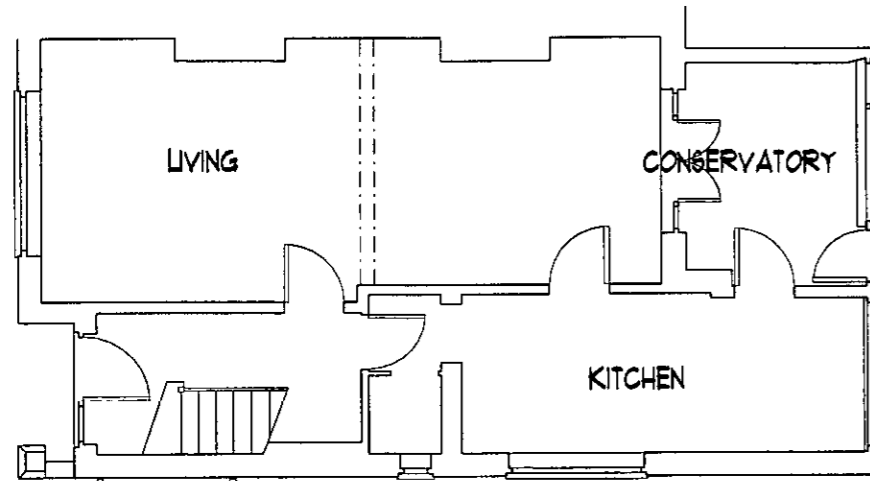
FIRST FLOOR PLAN

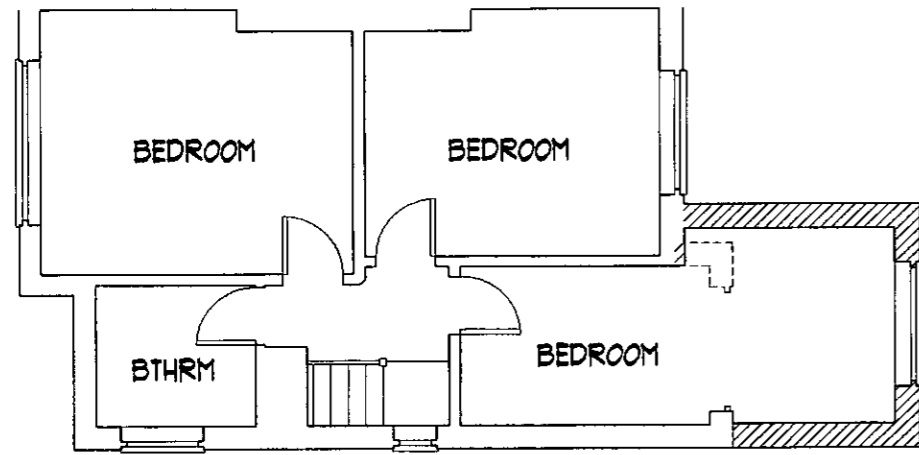

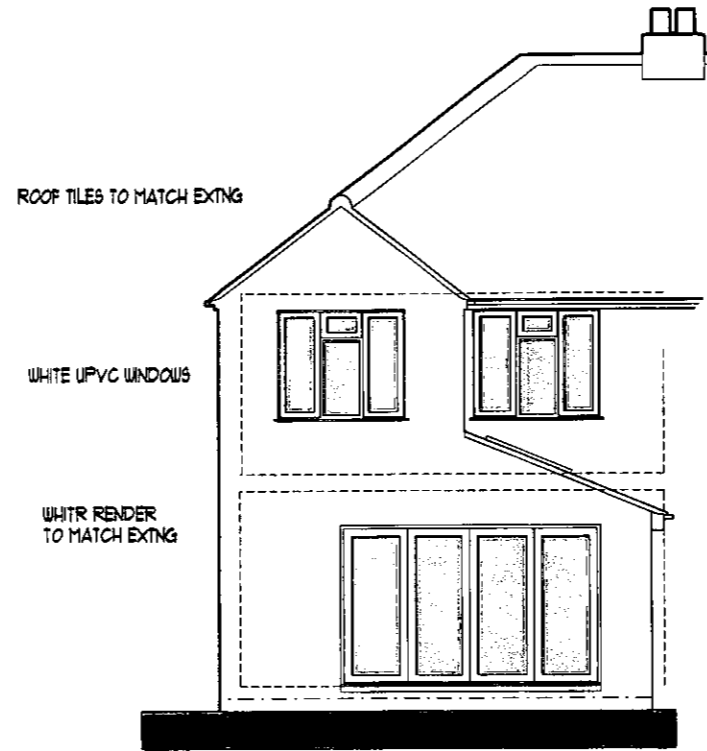

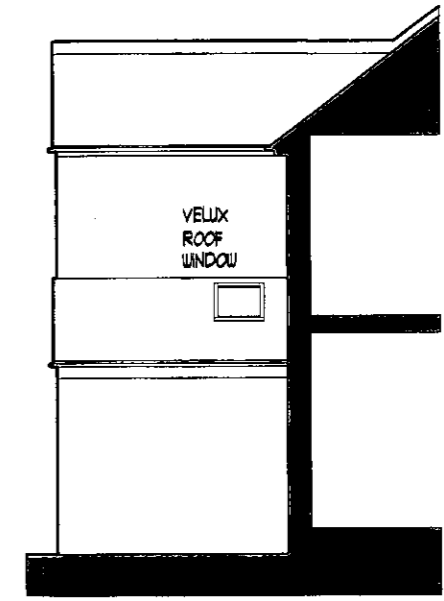

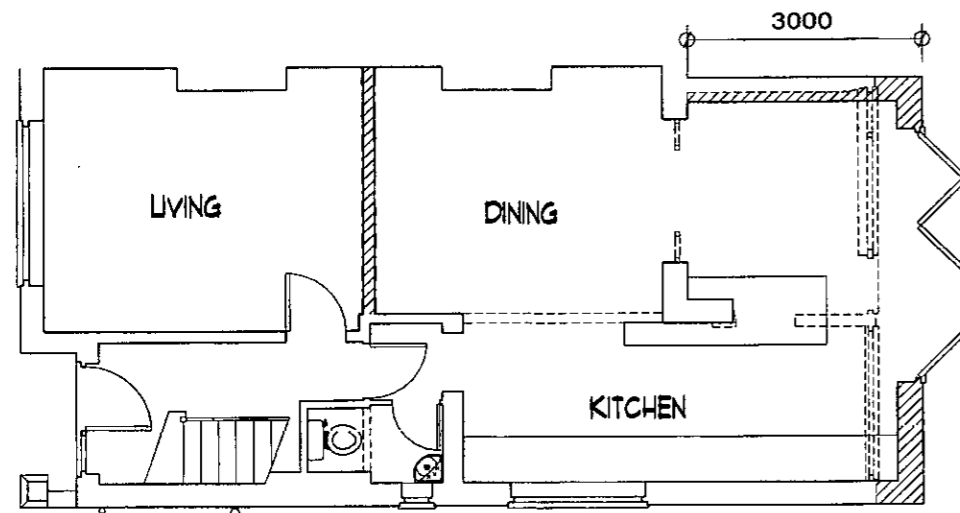
FIRST FLOOR PLAN
