Proposal:	Two storey side extension and rear single storey extension

In exercise of its powers under the above-mentioned Act and Order the City Council as the Local Planning Authority **GRANT PERMISSION** for the development described above in accordance with the terms of the application and the plan/s submitted therewith subject to the following conditions:

Condition 1

The development hereby permitted shall be begun before the expiration of three years from the date of this permission.

Reason

Required to be imposed by Section 91 of the Town and Country Planning Act 1990 as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

Condition 2

Except where these may be modified by any other conditions attached to this permission, the development hereby permitted shall be carried out in accordance with the details of the application form, and drawing numbers:

- 003-Rev.A – Proposed Ground Floor;
- 004-Rev.A – Proposed First Floor;
- 005-Rev.A – Proposed Front Elevation;
- 006-Rev.A – Proposed LHS Elevation;
- 007-Rev.A – Proposed Rear Elevation;
- 008-Rev.A – Proposed RHS Elevation;
- 009 – Location Plans;
- 010 – Block Plans;
- 011 – Notes;
- 012 – Parking Illustration.

Reason

To ensure that the development is carried out in accordance with the approved plans and in accordance with policies contained within the Gloucester, Cheltenham and Tewkesbury Joint Core Strategy (Adopted December 2017).

Condition 3

Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 (or any Order revoking and re-enacting that Order with or without modification), no windows or other openings, other than those shown on the approved plans, shall be constructed at first-floor level in the north-east or south-west facing side elevations of the two-storey side and rear extension hereby approved.

Reason

To protect the privacy of neighbouring occupiers in accordance with the aims of policies SD4 and SD14 of the Gloucester, Cheltenham and Tewkesbury Joint Core Strategy (Adopted December 2017) and emerging policy A9 of the Gloucester City Plan.

Condition 4

The two-storey side and rear extension hereby approved shall not be occupied or brought into use until a minimum of three off-street car parking spaces (excluding garage spaces) have been provided within the curtilage of the site.

The parking spaces shall be hard-surfaced, to minimum dimensions of 2.4 metres (width) by 4.8 metres (depth) and shall be located to enable vehicular access to the public highway. The hard-surface shall be constructed using porous materials, or provision shall be made to direct run-off water from the hard surface to a permeable or porous area or surface within the curtilage of the dwellinghouse.

Thereafter, the car parking spaces shall be maintained within the curtilage of the development site.

Reason

To ensure the development does not result in the loss of off-street car parking spaces and to prevent increased flood risk to adjacent land in the interests of the residential amenities of future occupiers of the site and to protect highway safety in accordance with the aims of policies SD4 and INF2 of the Gloucester, Cheltenham and Tewkesbury Joint Core Strategy (Adopted December 2017) and emerging policy A9 of the Gloucester City Plan.

Note 1

Your attention is drawn to the requirements of the Building Regulations, which must be obtained as a separate consent to this planning decision. You are advised to contact the Gloucestershire Building Control Partnership on 01453 754871 for further information.

Note 2

Your attention is drawn to the Party Wall Act 1996. The Act will apply where work is to be carried out on the following:

- Work on an existing wall or structure shared with another property.
- Building a free standing wall or a wall of a building up to or astride the boundary with a neighbouring property.
- Excavating near a neighbouring building.

The legal requirements of this Act lies with the building/ site owner, they must find out whether the works subject of this planning permission falls within the terms of the Party Wall Act 1996. There are no requirements or duty on the part of the local authority in such matters. Further information can be obtained from the DCLG publication Preventing and resolving disputes in relation to party walls – explanatory booklet.

Note 3

In accordance with the requirements of the NPPF the Local Planning Authority has sought to determine the application in a positive and proactive manner by offering pre-application advice, publishing guidance to assist the applicant, and publishing to the council's website relevant information received during the consideration of the application thus enabling the applicant to be kept informed as to how the case was proceeding.
