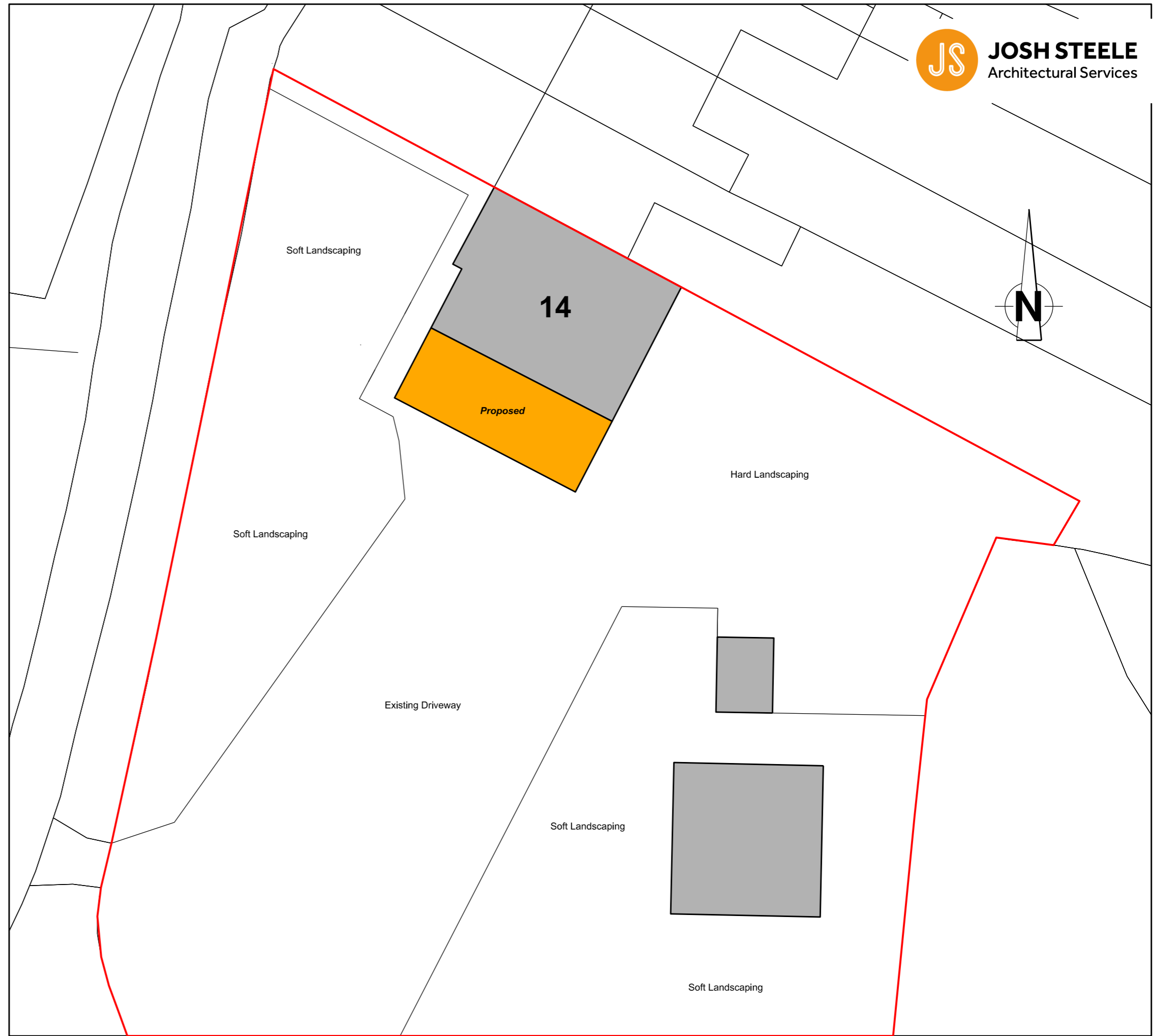

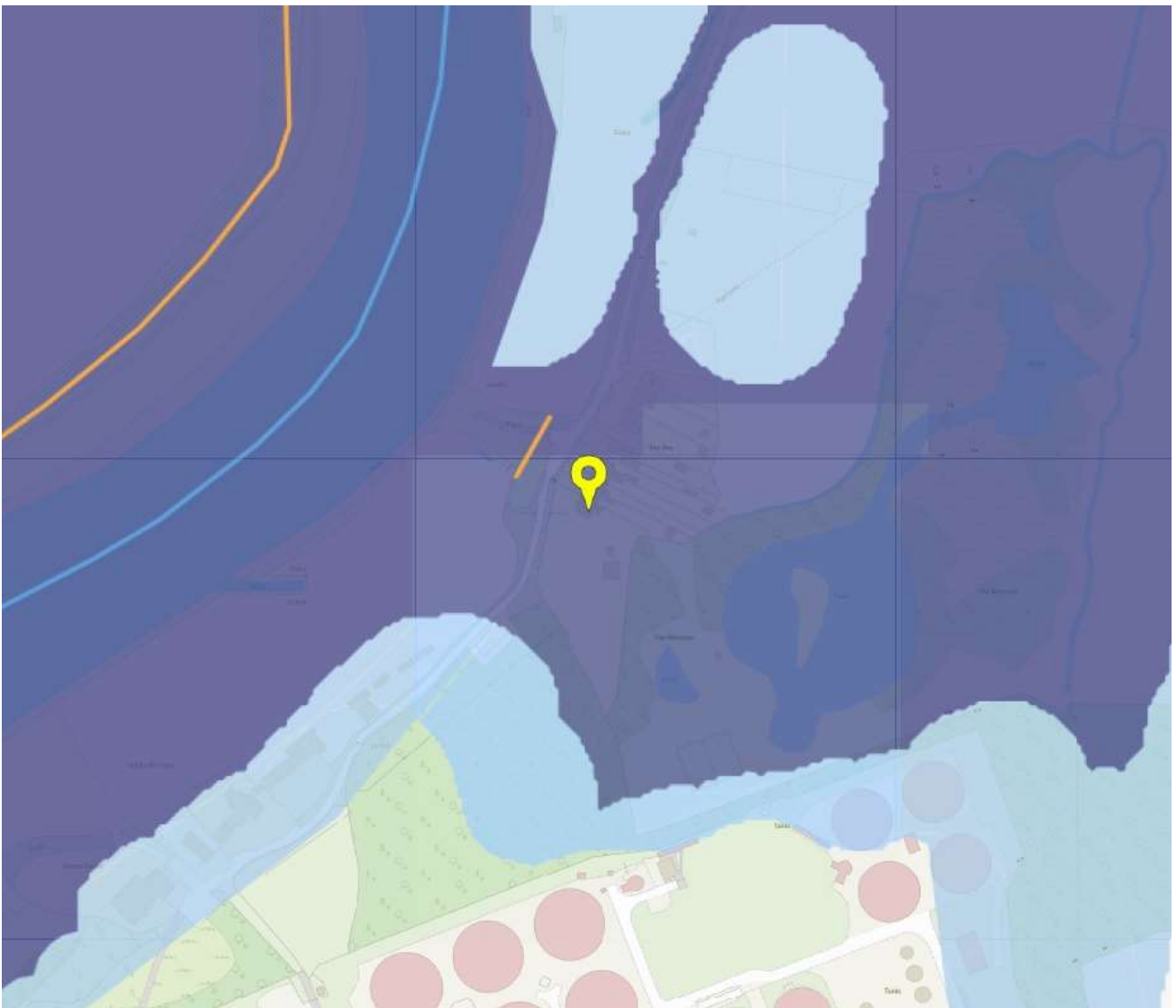


Flood Risk Assessment For Single Storey Extension

LOCATION:

14 Upper Rea
Hempsted
Gloucester
Gloucestershire
GL2 5LR

The application is set within the environmental agencies zone 3 for flood risk, see map extract below.



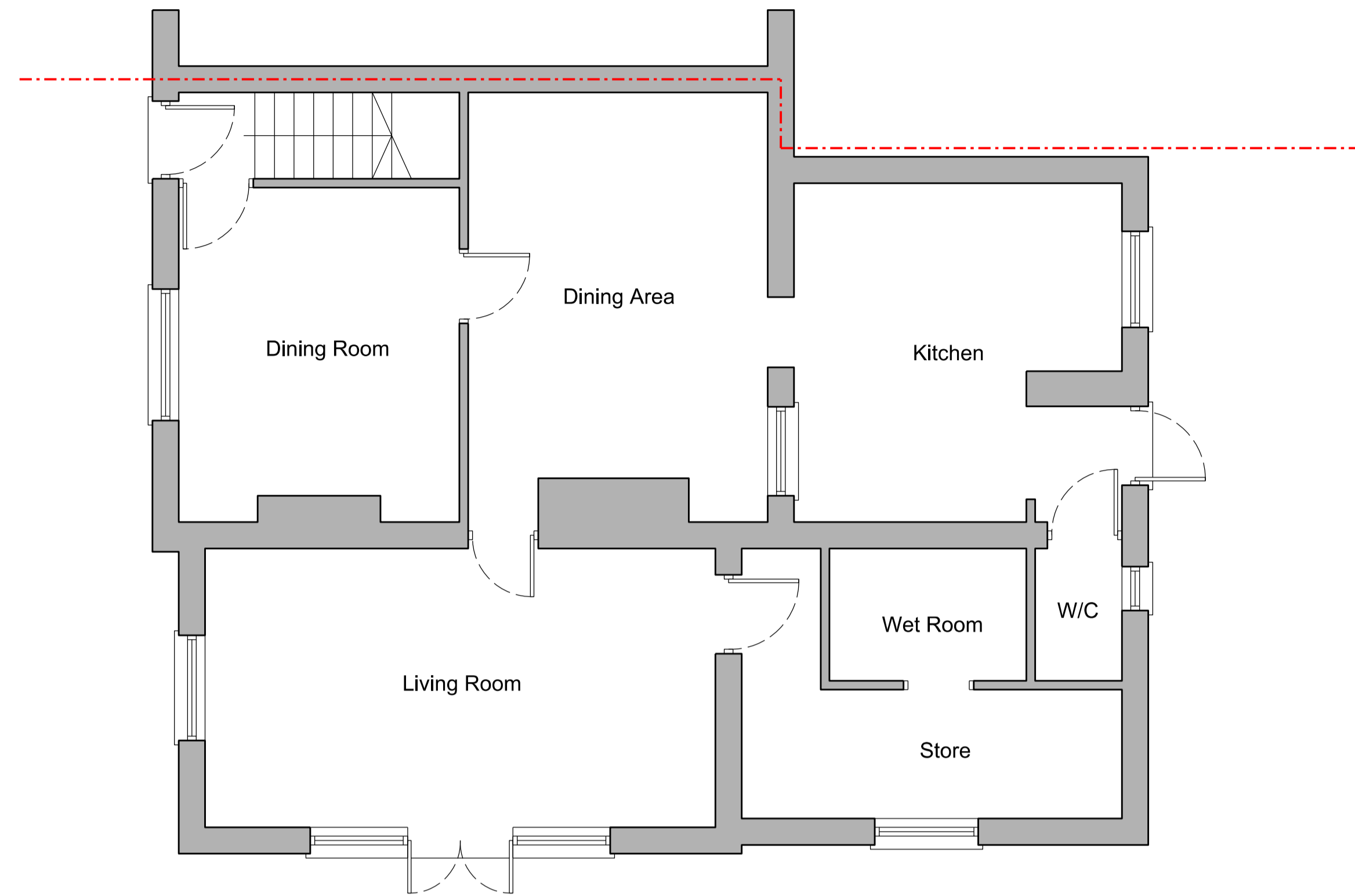
The proposed extension is less than 50 m² and will have no adverse effect on the flood risk. We confirm that the Environment Agency's standing advice will be followed. The following flood mitigation measures are proposed:

FLOOD MITIGATION MEASURES:

- The proposed extension is single-storey, with the proposed increase in area being 44 m². The current area to be extended into is hard standing.
- The floor level of the proposed extension and new building are to match the existing buildings which are set greater than the required 300 mm above estimated flood levels.
- The rooms used will be living spaces and not used as Bedrooms. All services will be at high level above estimated flood levels.
- The construction of the proposed extension and new building will comply with recommendations set out by the environmental agency for such construction.

CONCLUSION:

The proposed extension will have a very insignificant impact and with the above measures and should not require further consultation or investigation by the Environment Agency, as the proposals clearly have no adverse effect on the flood risk to the surrounding area or existing buildings.



Existing Ground Floor Plan



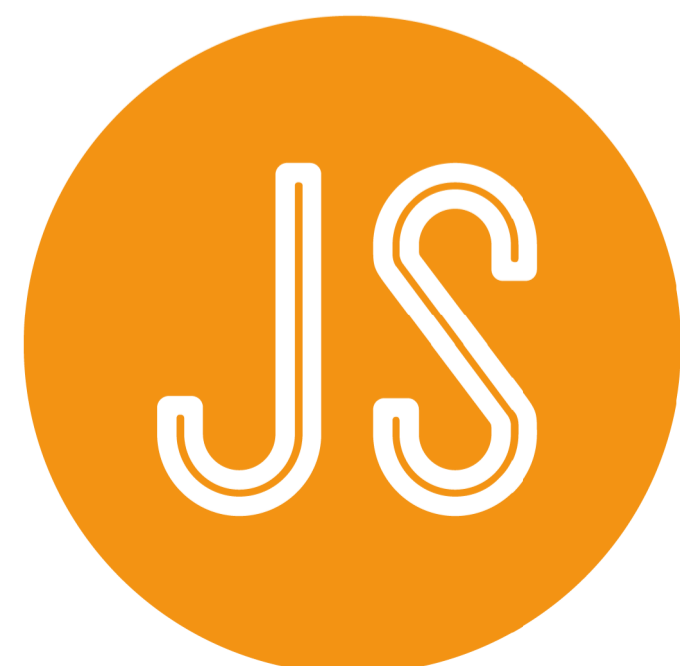

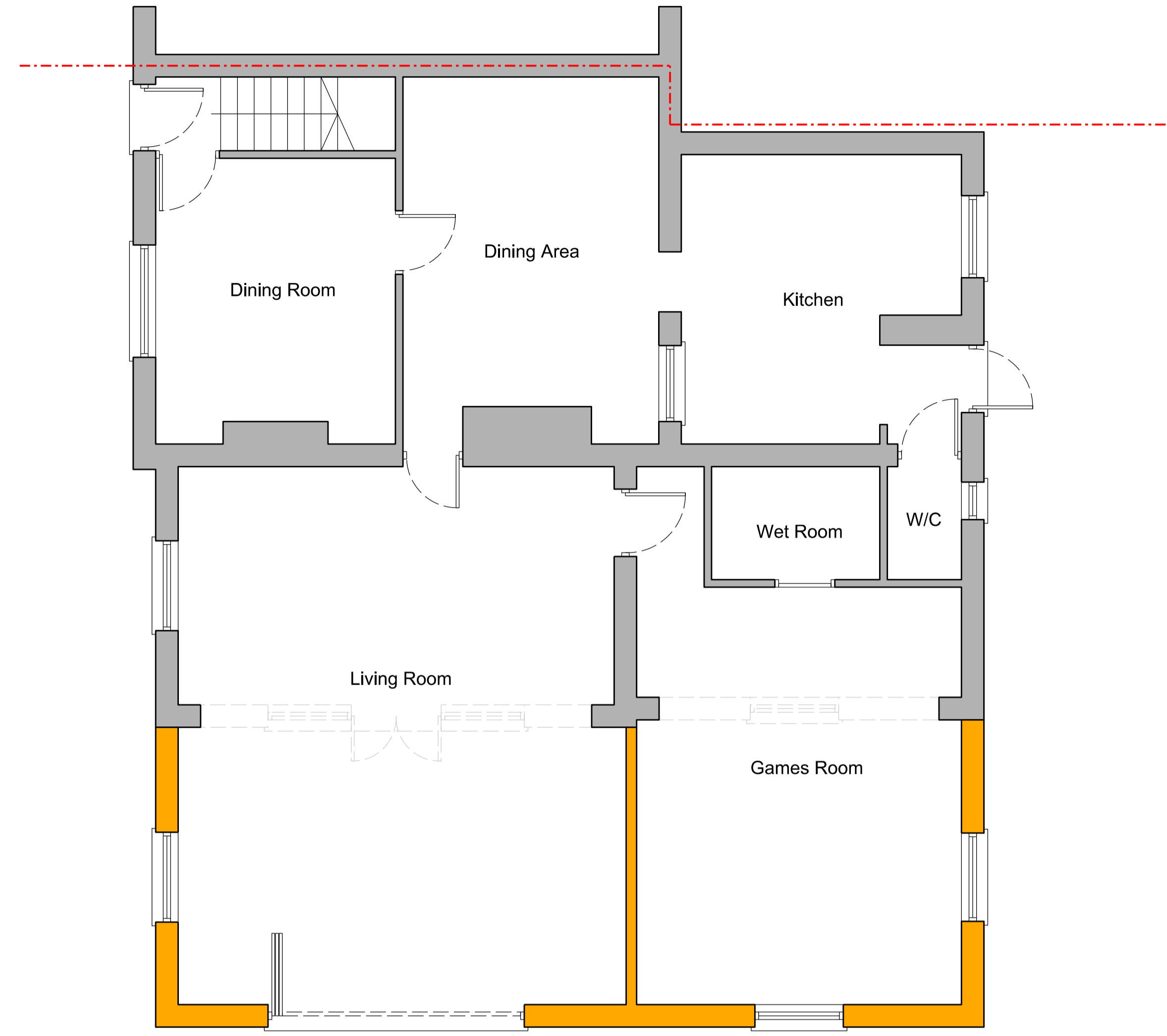
