Parking courts should be avoided, using the space to carefully design the dwellings, street layout that incorporates residential parking and public spaces.

Where parking is provided in front of the property, in a garage or a defined space; the dimensions for the parking spaces should increase to allow for larger vehicle sizes. Over the years vehicles have increased, as an example the modern Mini is nearly 30% larger than the original; yet parking spaces have remained the same.

If spaces are too small they won't be used effectively or efficiently, vehicles will be damaged and alternative parking locations will be used.
