The Direct Debit Guarantee

- If there are any changes to the amount, date or frequency of your Direct Debit **Gloucester City Council** will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request **Gloucester City Council** to collect payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by **Gloucester City Counci**l or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- If you receive a refund you are not entitled to, you must pay it back when **Gloucester City Council** asks you to. You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
