#### What you will need to know about Charitable Rate Relief

Charitable Rate Relief of 80% can be given provided the following criteria are met:

#### 1. Occupied Properties

The property must be occupied by a charity or trustees of a charity, and wholly or mainly used for charitable purposes.

#### **Unoccupied Properties**

Where properties are unoccupied, but the future intention is that it will be used for charitable purposes, then again relief may be given.

- 2. A 'Charity' is defined as follows:
  - "An institution or other organisation established for charitable purposes only or any persons administering a trust established for charitable purposes only".
- 3. Registration under the Charities Act 1960 is conclusive evidence of charitable status. Organisations which are exempt from the 1960 Act, are also eligible for relief.

### **Discretionary Rate Relief**

The City Council has a policy on awarding Discretionary Rate Relief. Normally, we award the 80% Charitable Rate Relief we will not give the remaining 20% of rates payable under our discretionary policy. We will, however, consider each case on the merits of the application.
