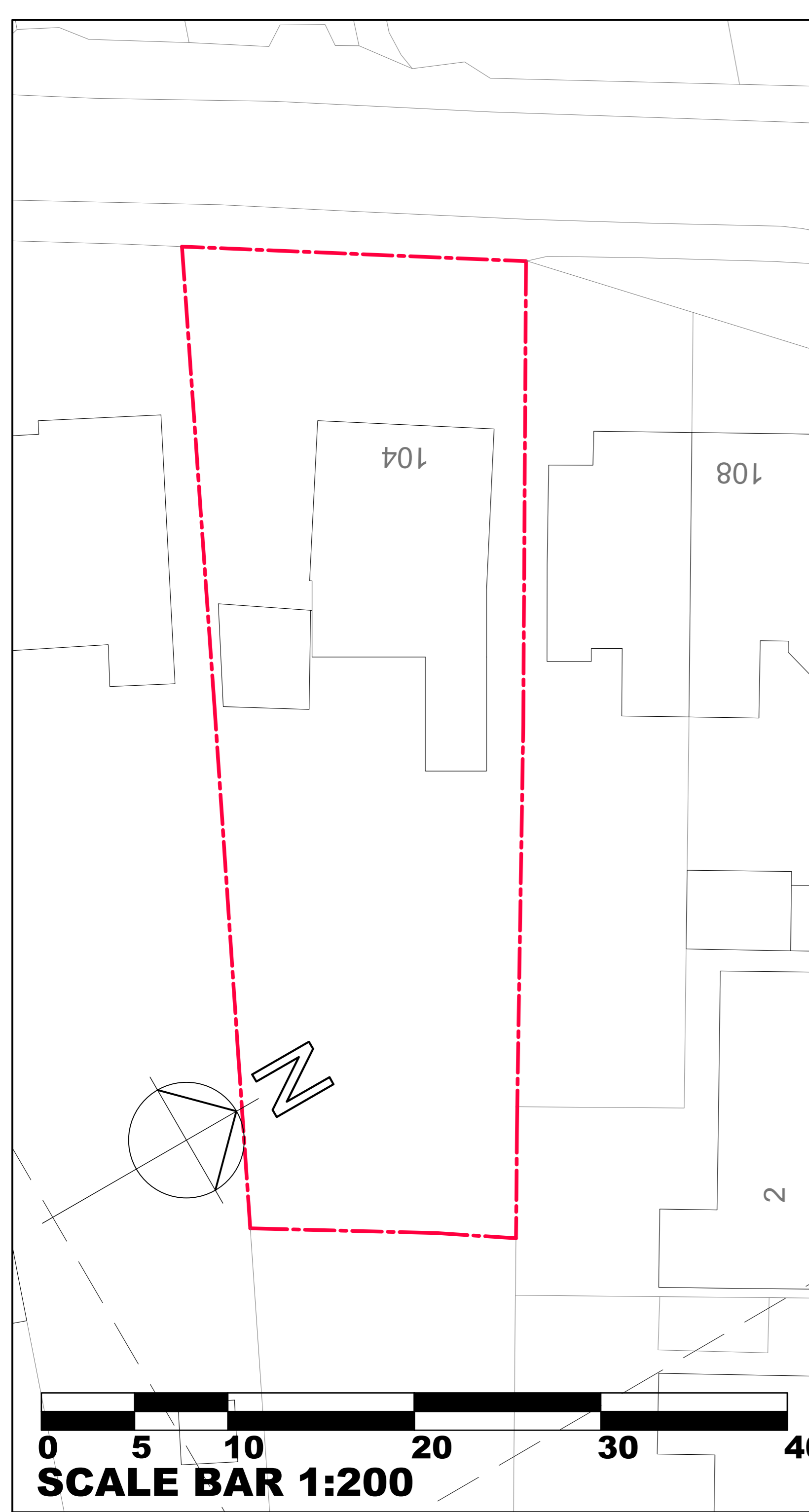

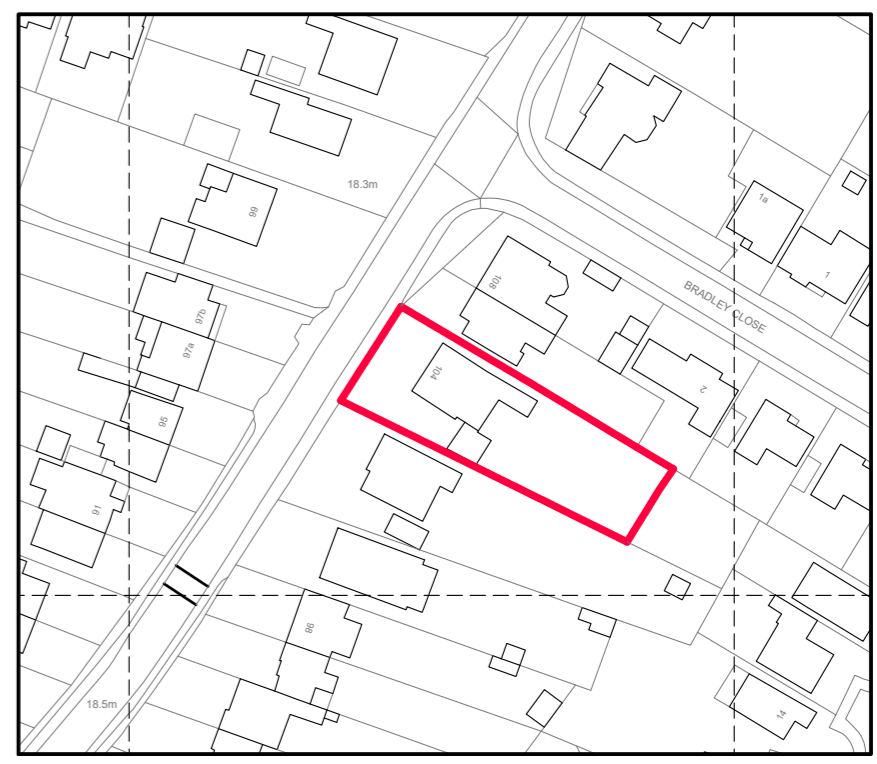

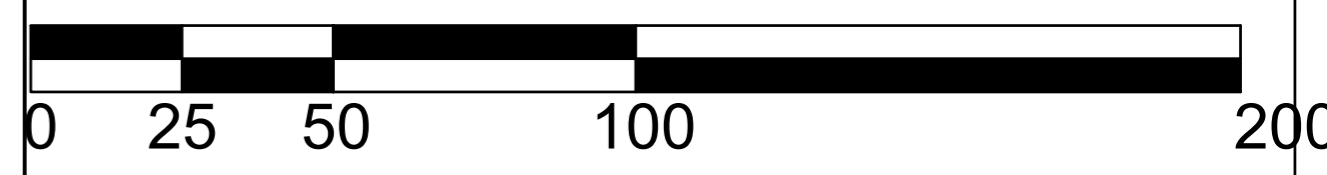
SITE BLOCK PLAN AS EXISTING 1:200



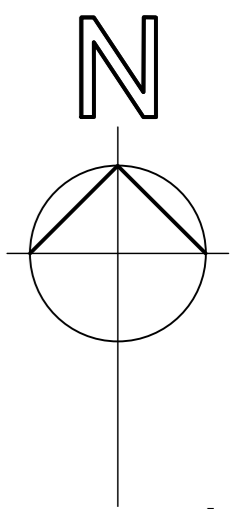
SITE BLOCK PLAN AS PROPOSED 1:200

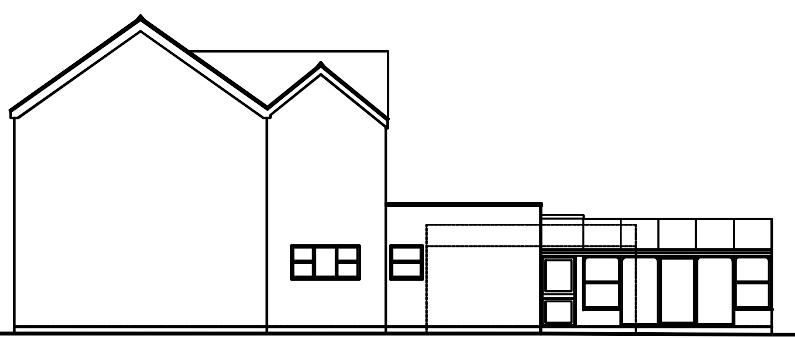

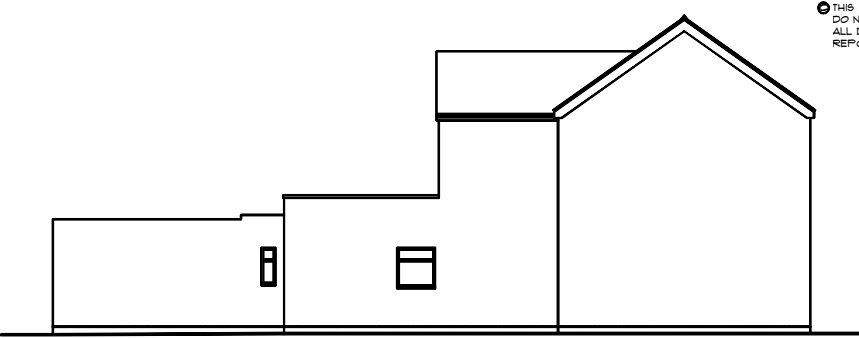

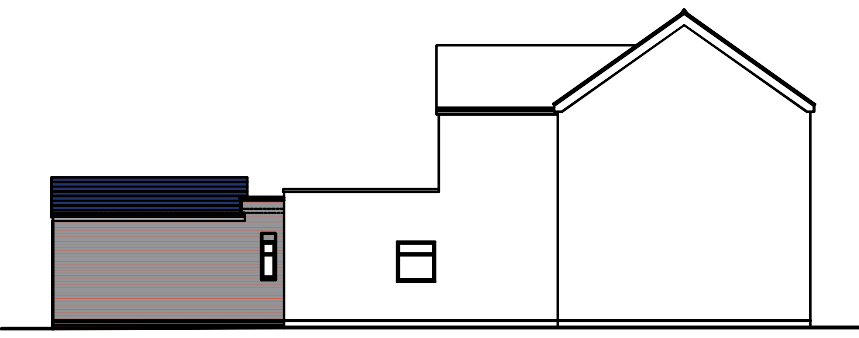

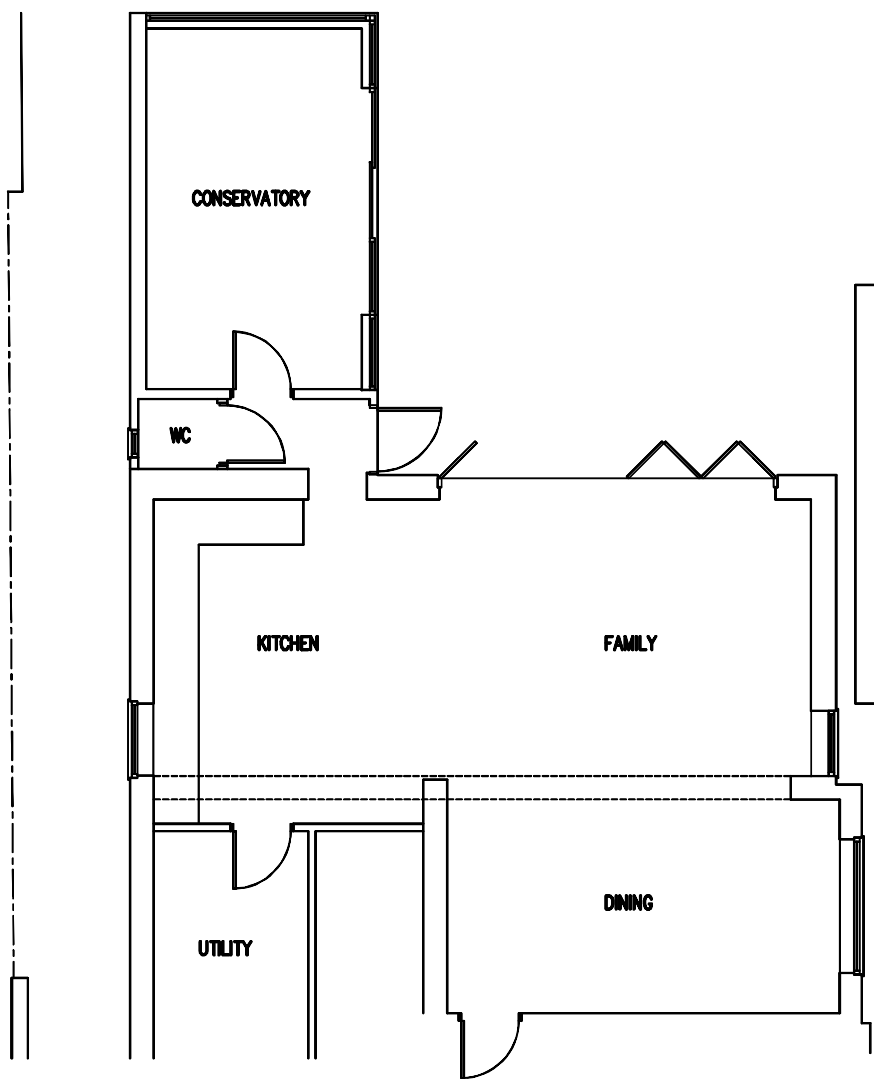

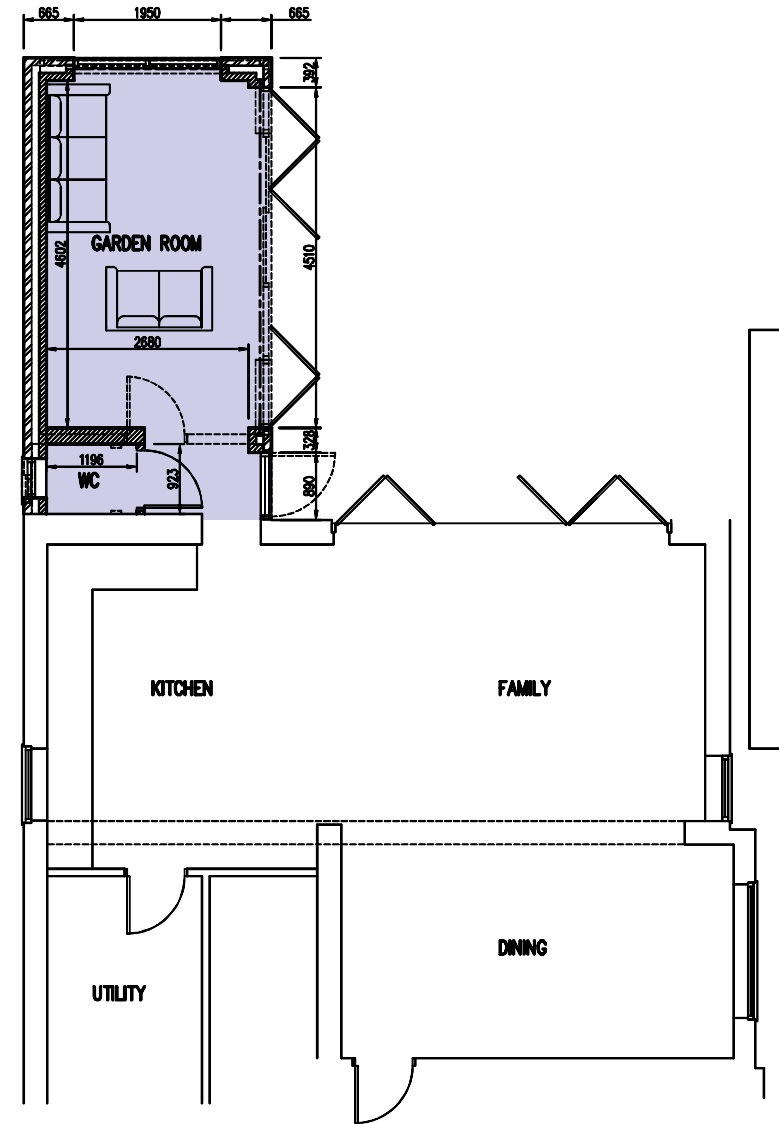
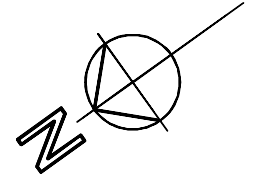

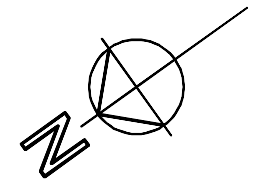
PROPOSED NORTH EAST ELEVATION
