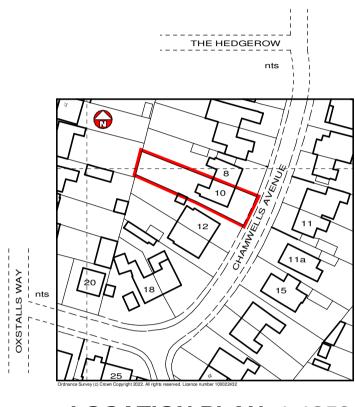

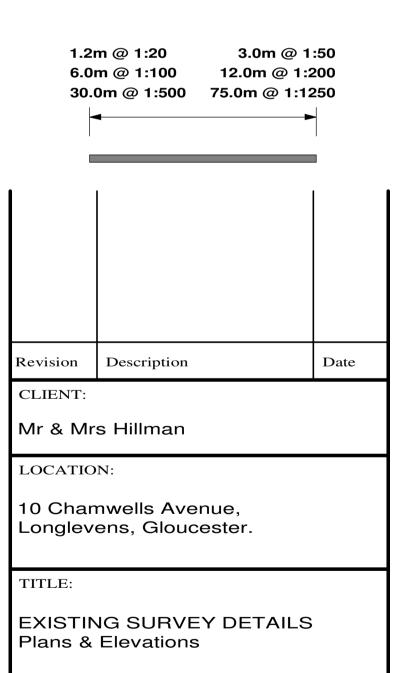




EXISTING SITE BLOCK PLAN 1:500

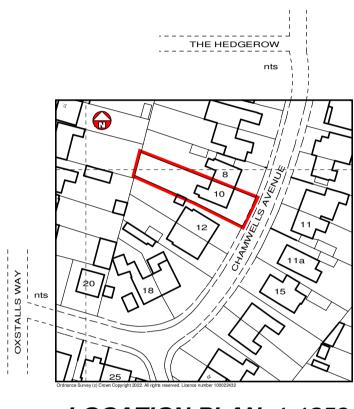








PROPOSED SITE BLOCK PLAN 1:500
