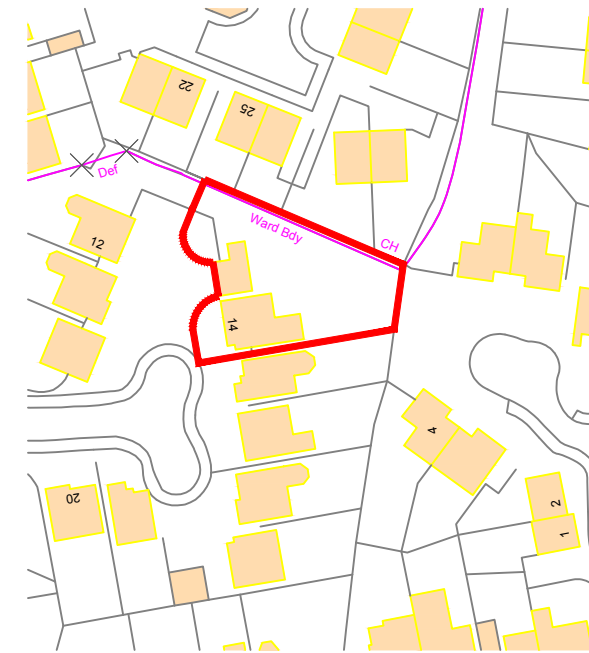

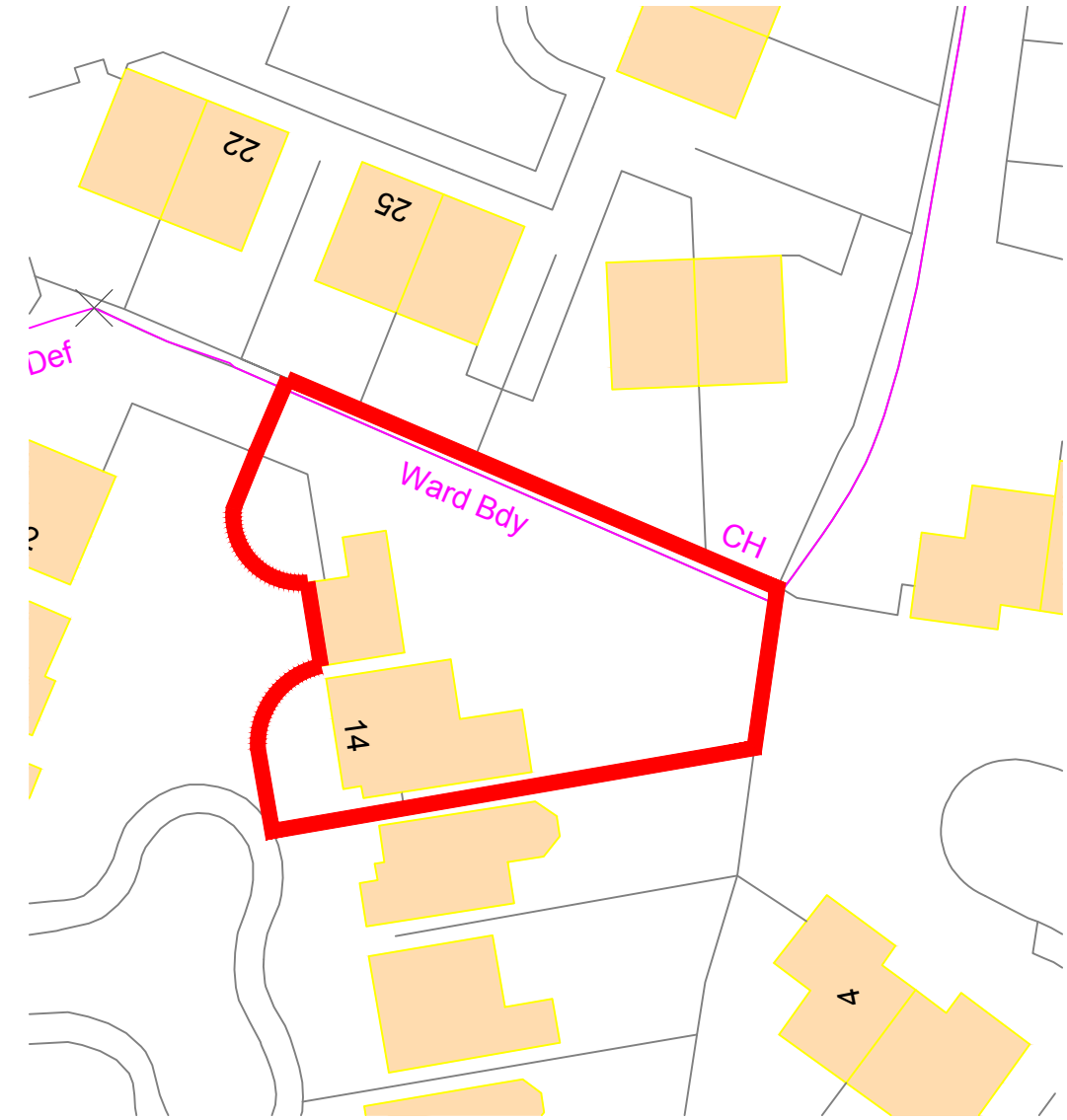

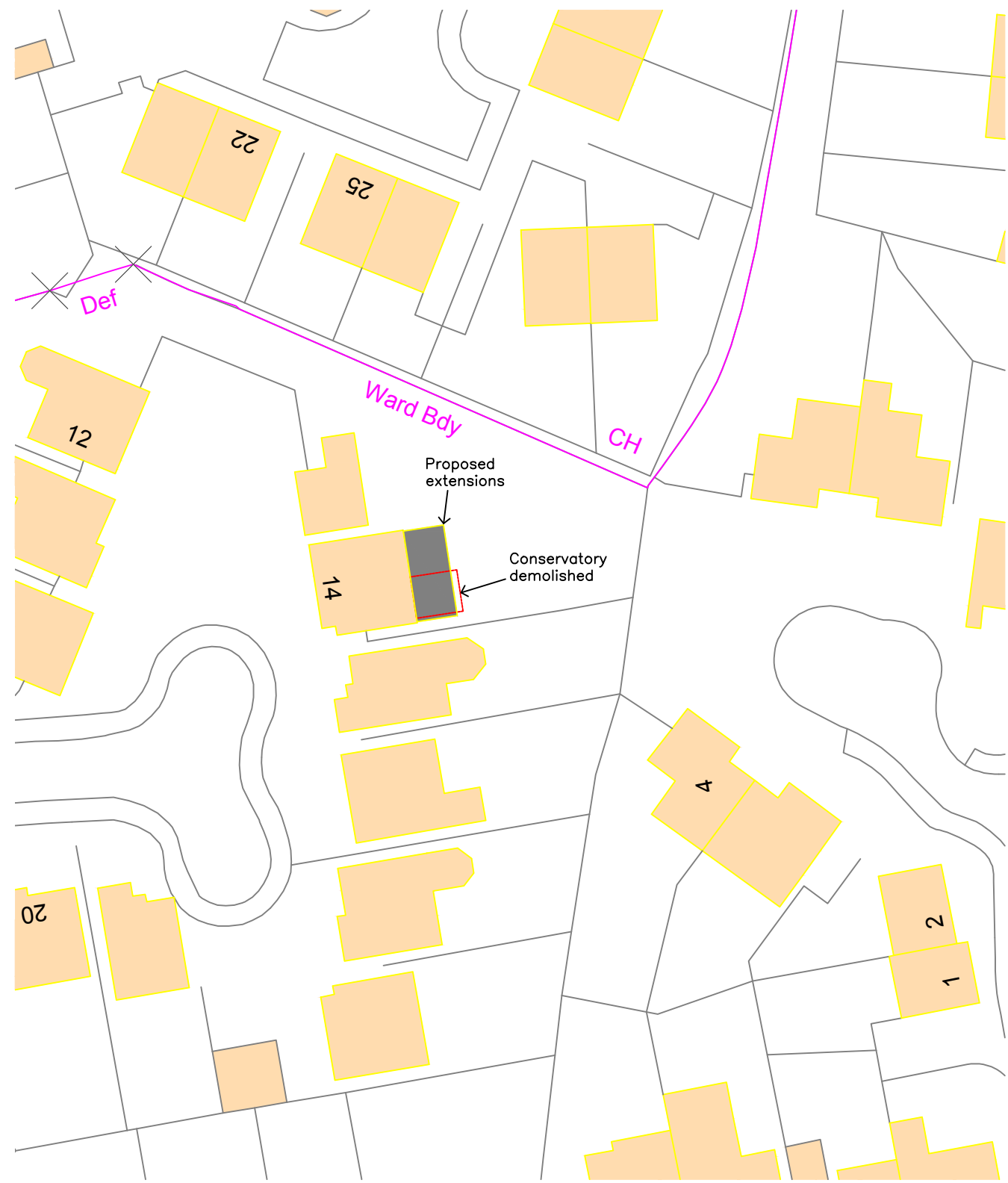

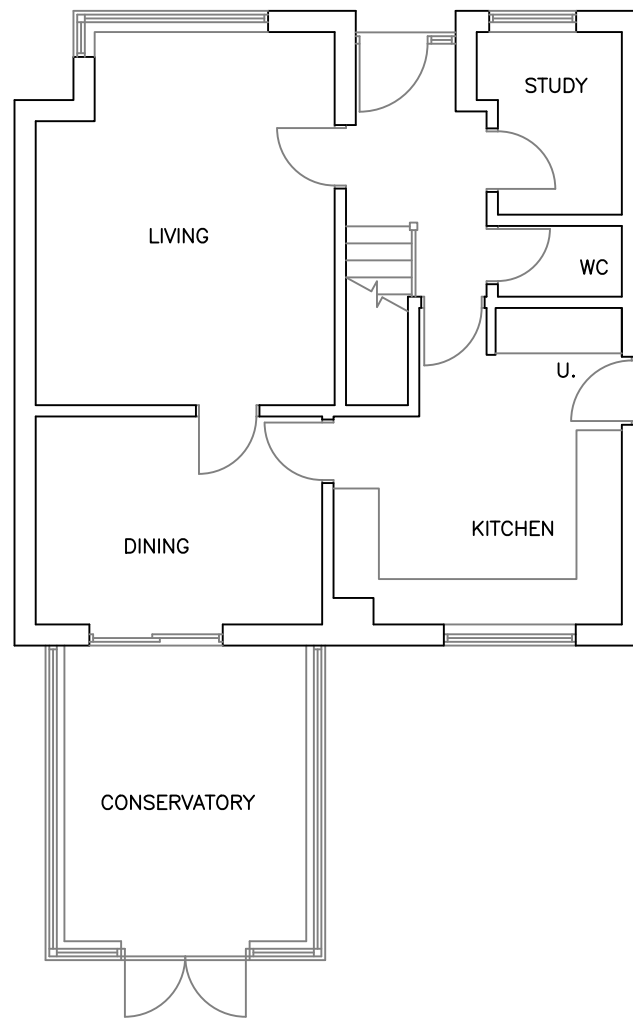
SIDE ELEVATION



REAR ELEVATION

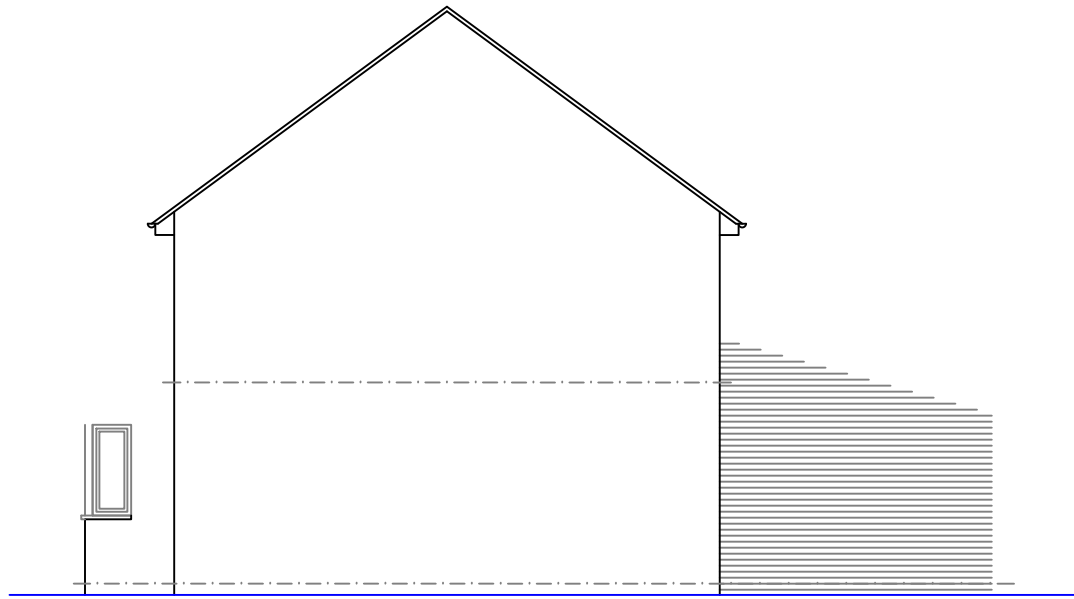

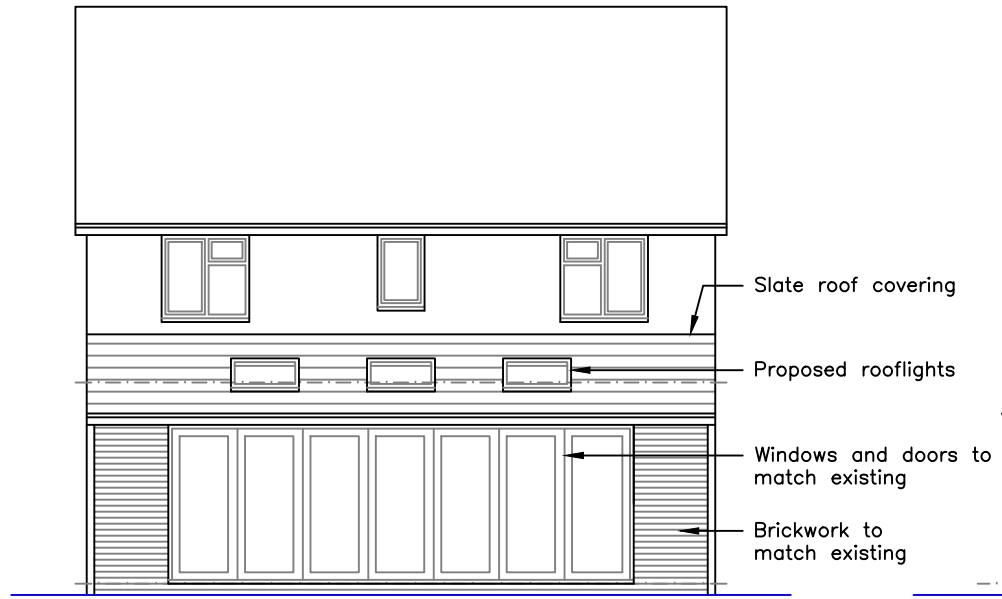

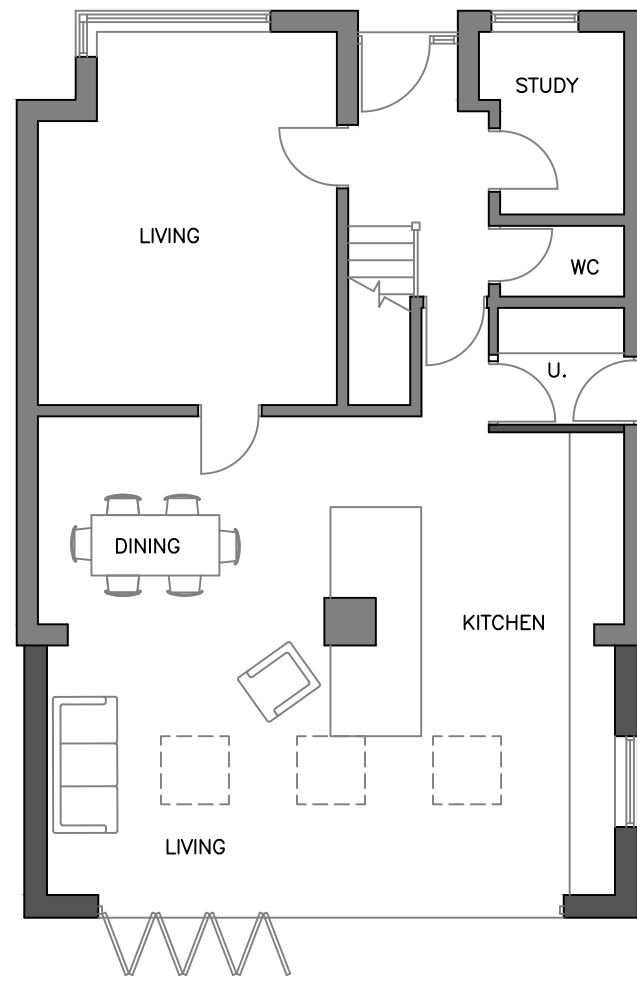
