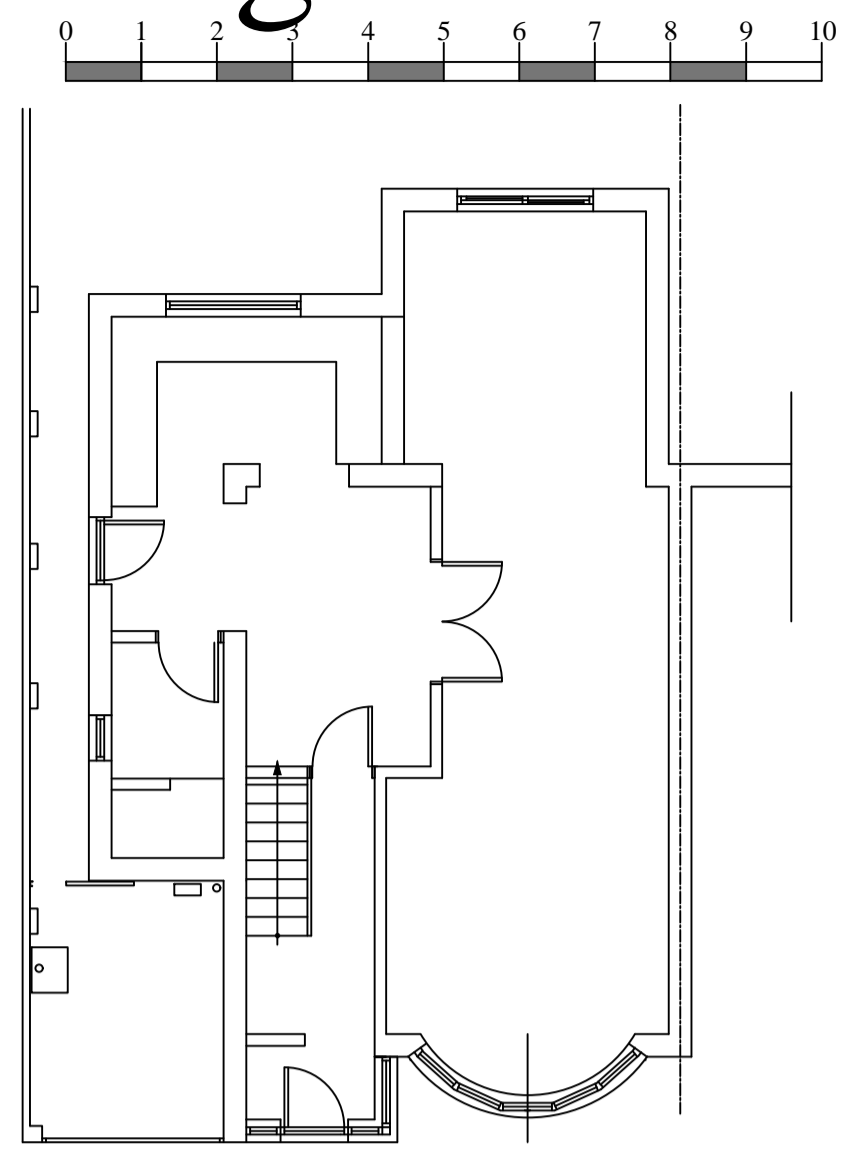

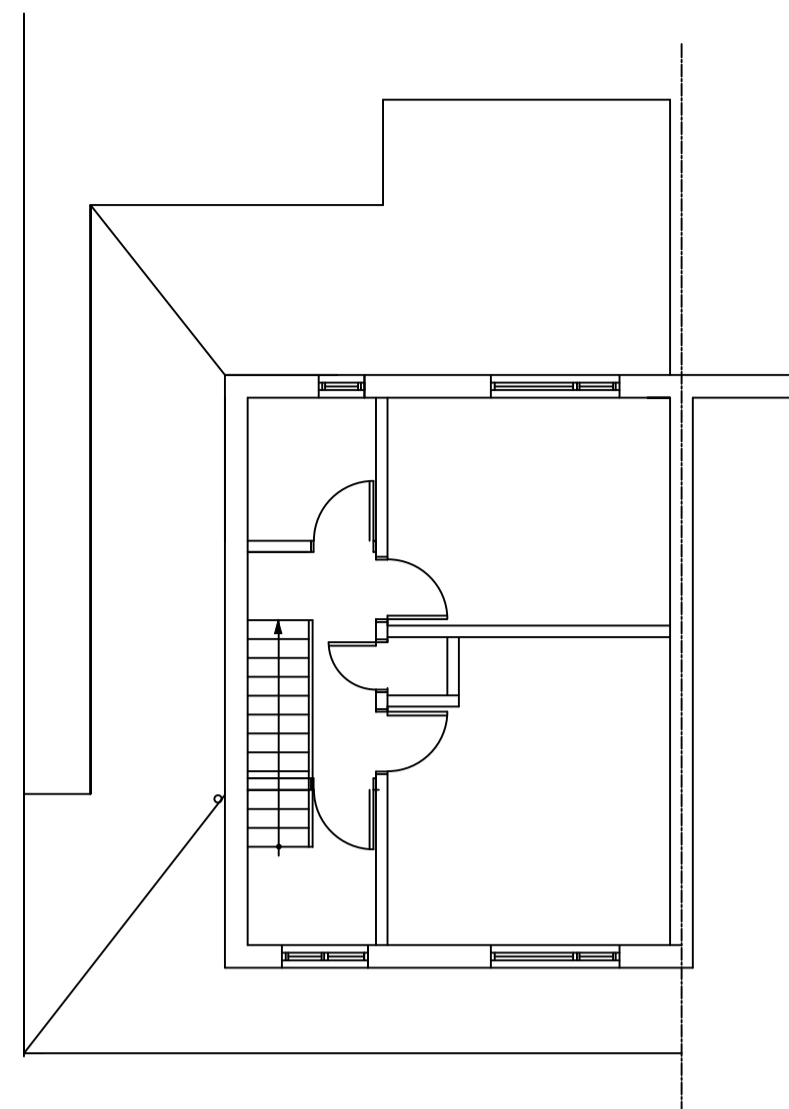

Ground Floor



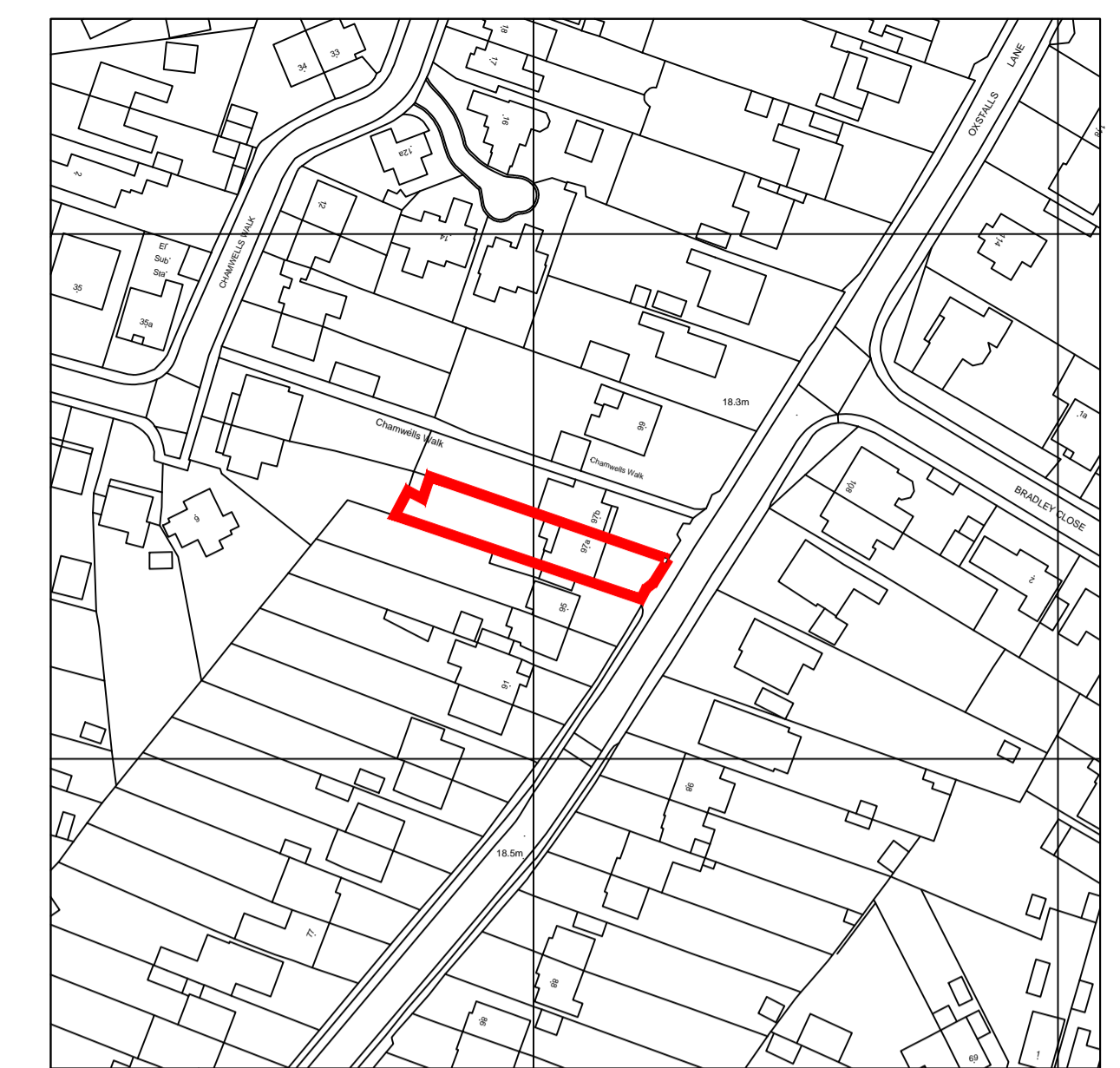
First Floor



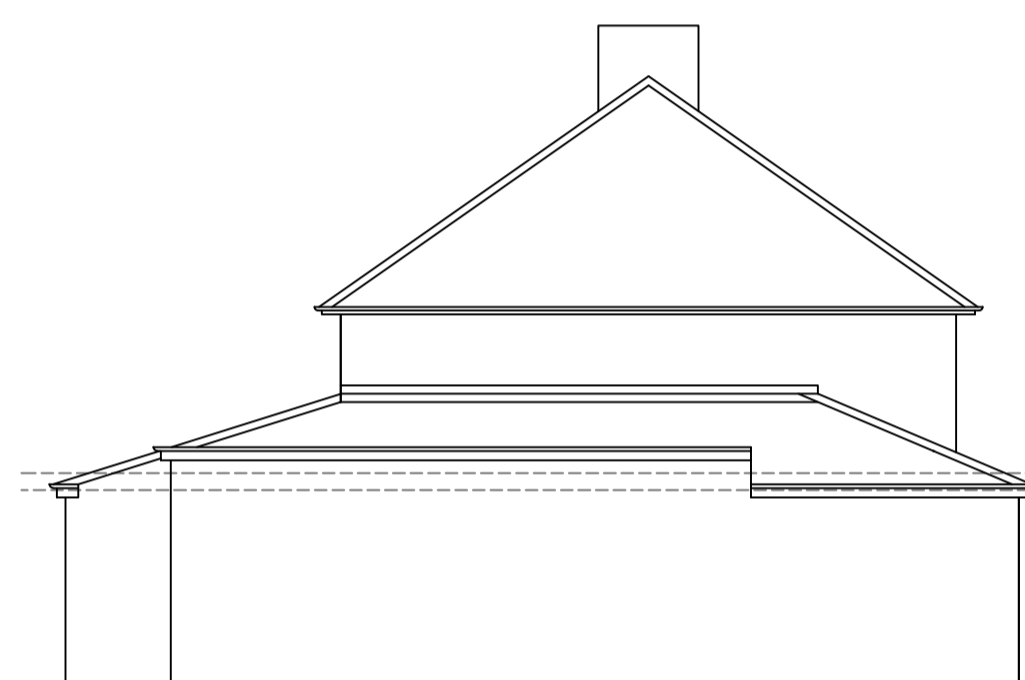
Proposed Block Plan 1:500



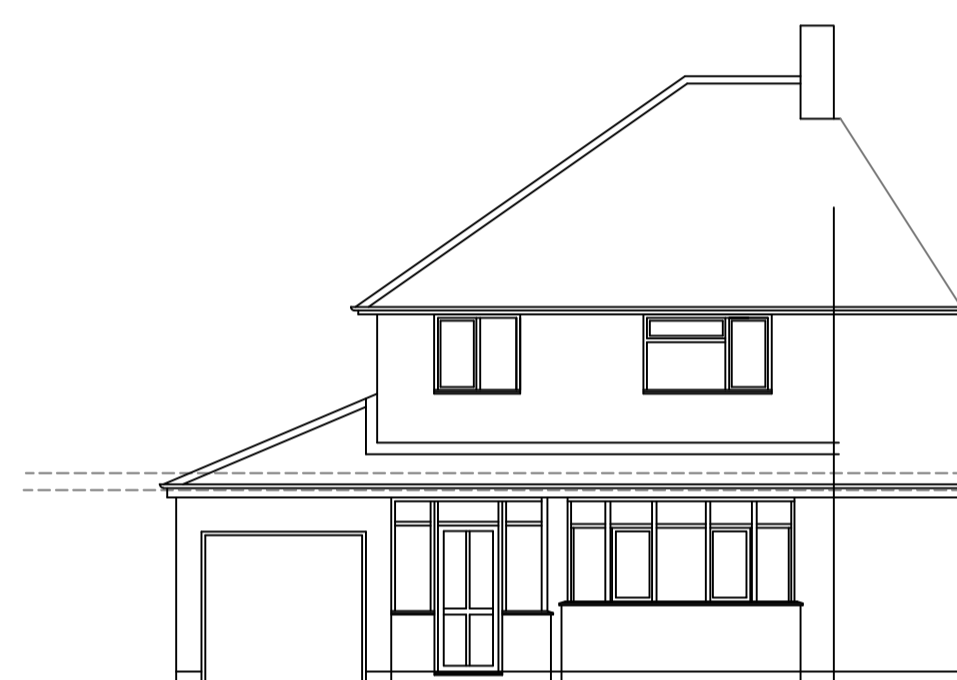
Existing Block Plan 1:500

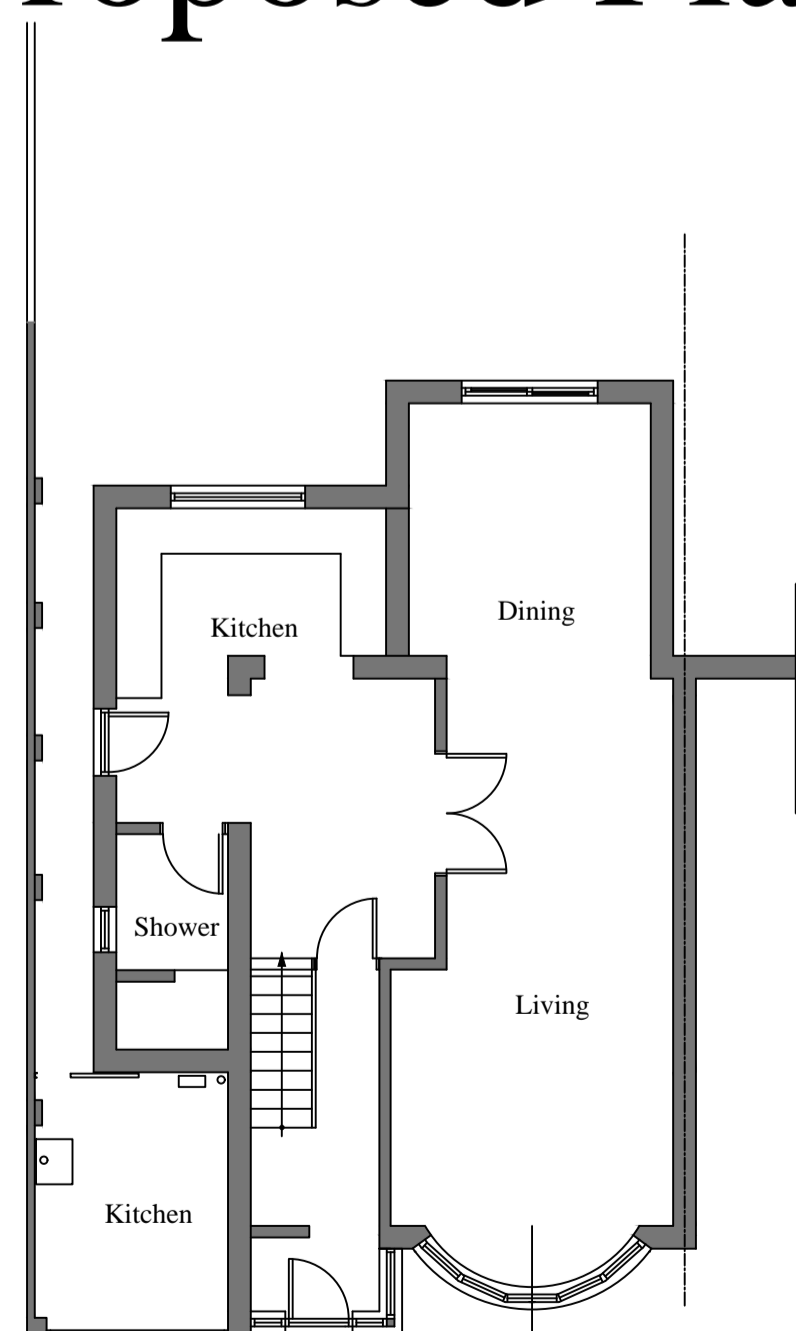


Front Elevation

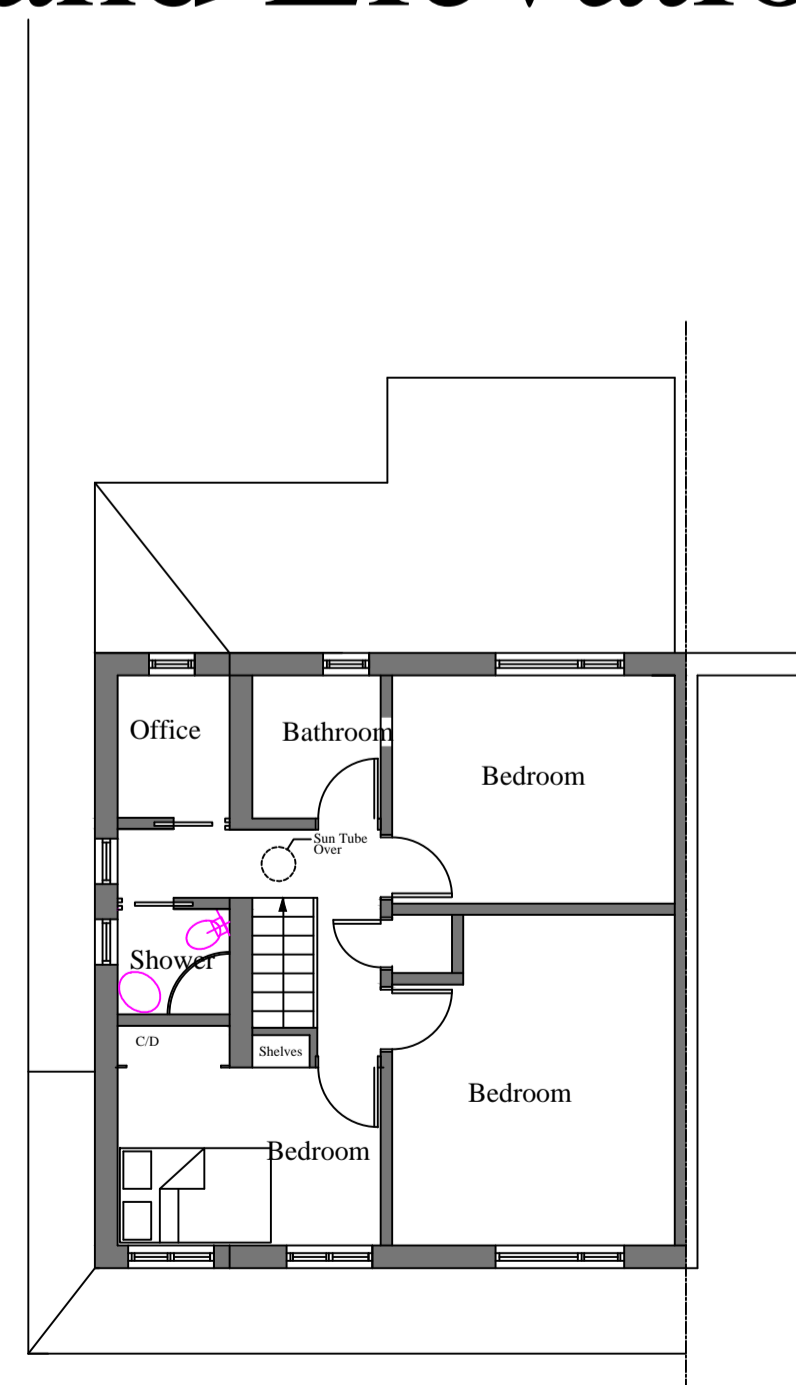


Rear Elevation

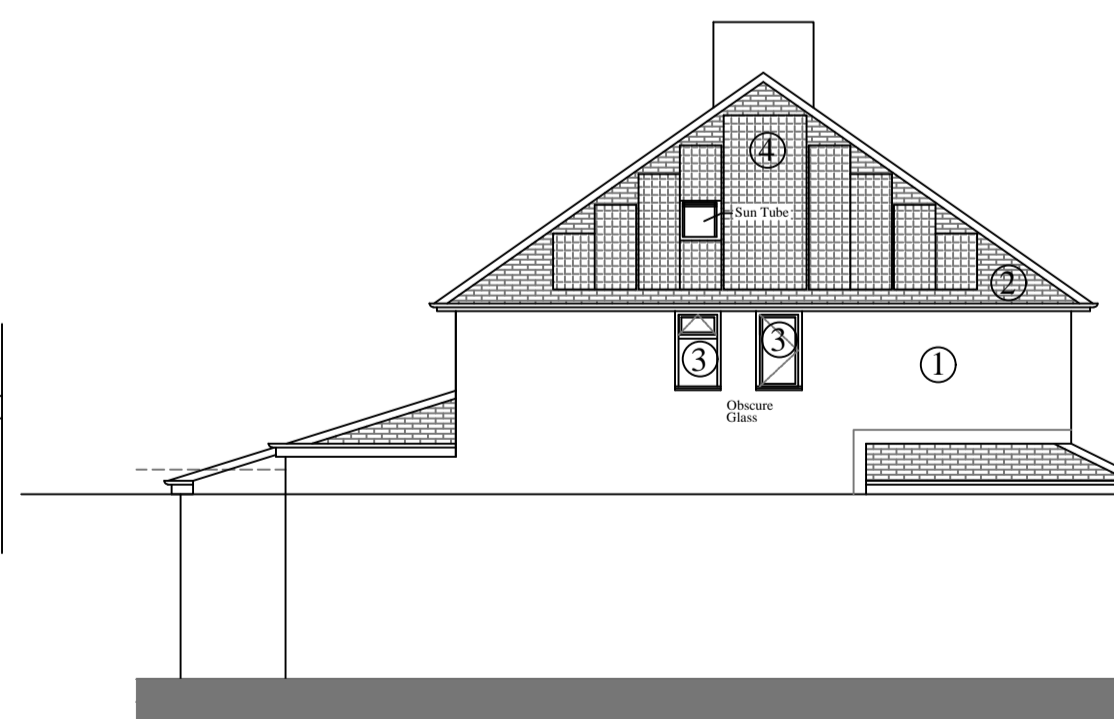
