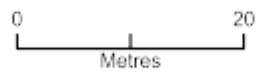

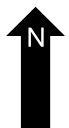
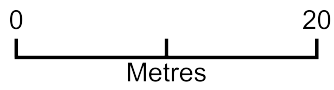
Existing Block Plan

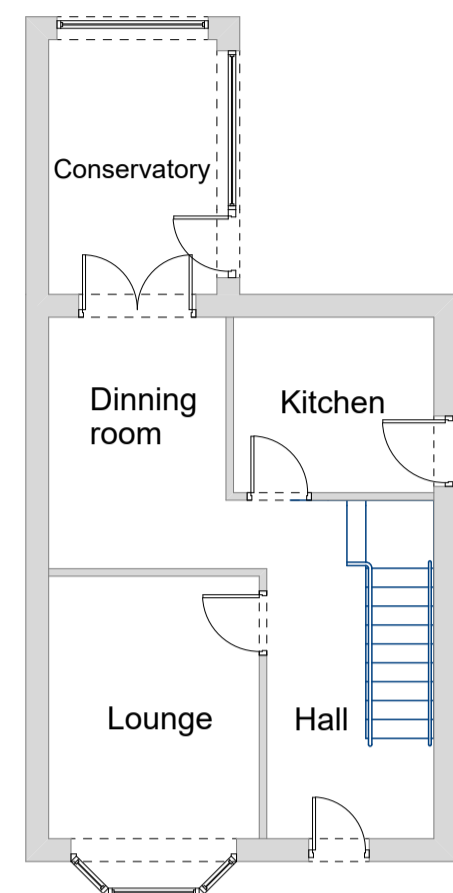

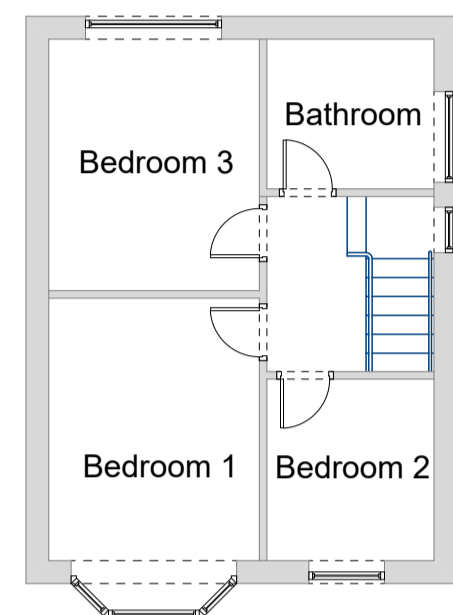

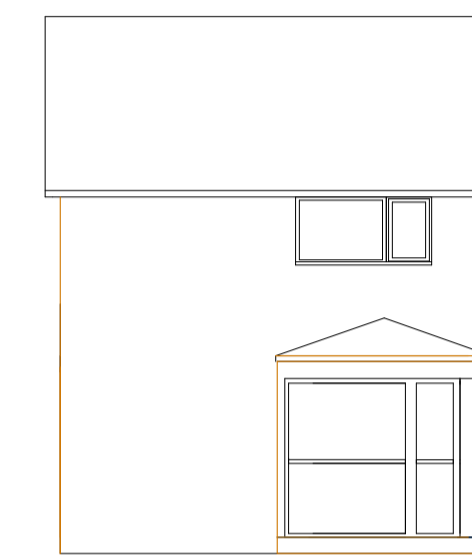

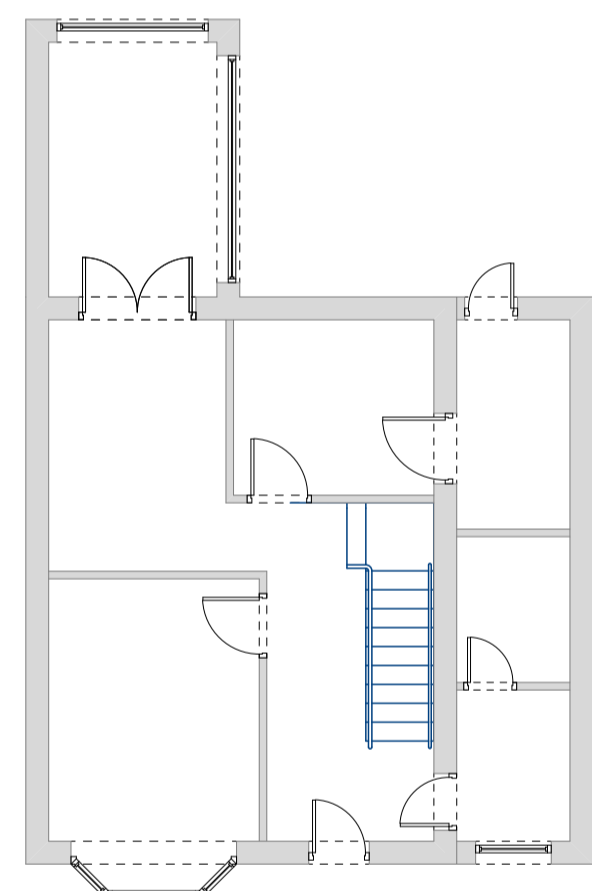

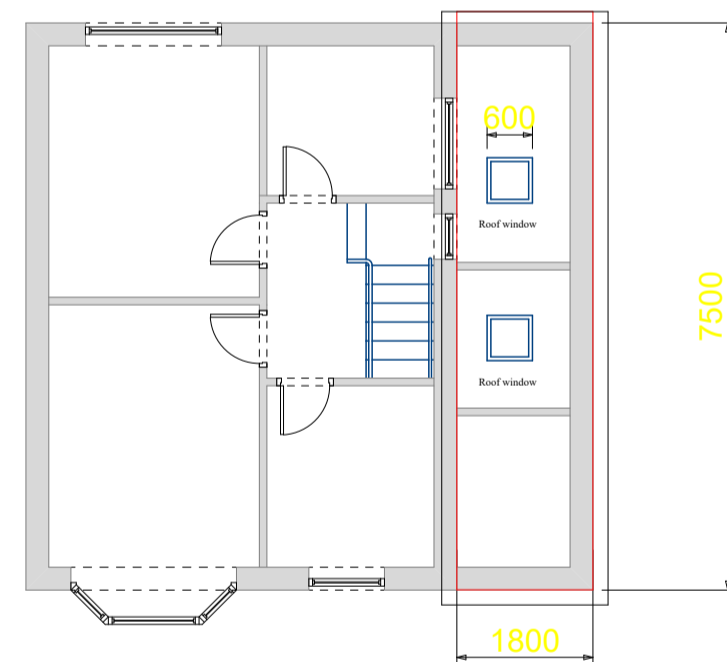
Existing Elevation



Existing Rear Elevation



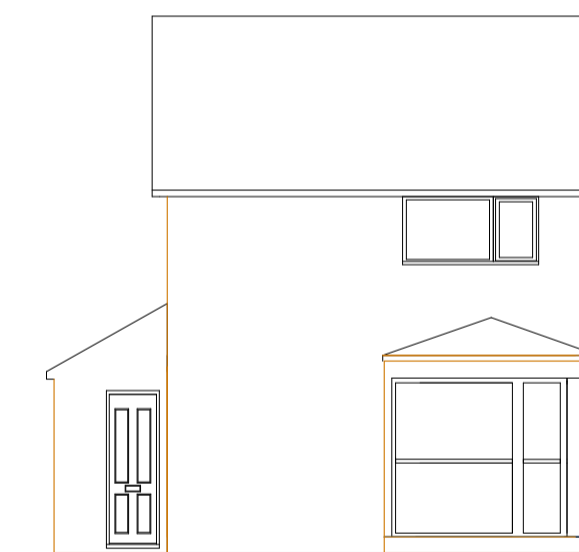
Proposed Ground Floor Plan

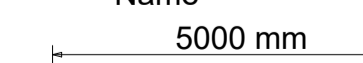
