

**THE COUNCIL OF THE CITY OF GLOUCESTER
(ORGAN'S ALLEY) (GATING) ORDER 2014**

The Council of the City of Gloucester ("the Council") under arrangements made pursuant to Section 19 of the Local Government Act 2002 in exercise of the powers of the Gloucestershire County Council under Section 129A of the Highways 1980 ("the Act") and of all other enabling powers hereby makes the following Order:

1. This Order shall come into operation on the 8th day of April 2014 and may be cited as "The Council of the City of Gloucester (Organ's Alley) (Gating) Order 2014"
2. The public right of way over the highway known as Organ's Alley that runs from its junction with Eastgate Street between 97 and 99 Eastgate Street in a northerly direction terminating at its junction with Russell Street between 20 and 24 Russell Street ("the Highway") is restricted at all times to all persons with the exception of those persons set out in Article 3. The Highway is shown coloured pink on the plan attached to this Order.
3. All owners and all occupiers of premises adjoining the Highway, the Police, Fire and Ambulance emergency services, statutory undertakers with equipment situated under, over, along or in the Highway, Council officers and other persons authorised in writing by the Council or Gloucestershire County Council for the purposes of carrying out works of repair or maintenance to the Highway or adjoining premises shall be exempt from the provisions of this Order.
4. The alternative route for pedestrian access to Eastgate Street and Russell Street is via Nettleton Road.
5. The installation, operation and maintenance of two Gates by the Council between 97 and 99 Eastgate Street and 20 and 24 Russell Street to enforce the restriction of the public right of way is hereby authorised.
6. The maintenance and operation of the Gates shall be the responsibility of Gloucester City Council at Herbert Warehouse, The Docks, Gloucester GL1 2EQ (Contact Neighbourhood Management Services on 01452 396396)
7. The Council is satisfied that the conditions set out in Section 129A(3) of the Act have been met in relation to the Highway.




