DESIGN AND ACCESS STATEMENT

Proposed New Dwelling at 20 Chatcombe Road Matson

December 2021

Revision C

1.0 Purpose

This Design and Access Statement has been prepared to accompany the full planning application 1no. New 2 bedroom dwelling on land adjacent to 20 Chatcombe Road. The statement describes the proposed site, assesses the context an immediate setting and subsequently explains the response to these contextual issues.

Drawings in this report are for illustration purposes only. The drawings which constitute the application have been submitted separately and should be referred to in all manners of record.

2.0 Background

The site is located off Chatcombe Road in Matson and the proposal is to reduce the amenity space for no.20 and relocate the parking to the front of the property to allow an end of terrace property to be erected almost identically to the scheme approved on Badminton Road - 21/00494/FUL | Construction proposed 2-bedroomed house on the land at 55 Badminton Road | 55 Badminton Road Gloucester GL4 6AZ

3.0 Use

The site is currently residential amenity space and a change of use is not relevant for this application.

4.0 Amount

The full application is for 1 no. end terrace 2 bedroom property with a study. A site layout has been produced with to show the adequate parking and amenity arrangements. Each property has a private driveway to provide parking, whilst retaining generous sized gardens which have the possibility to be enhanced with planting.

5.0 Access

Vehicular and pedestrian access is to remain in its existing position with a new access to the existing dwelling taken off Chatcombe Road. Consideration has been given to the visibility splay when positioning the access.

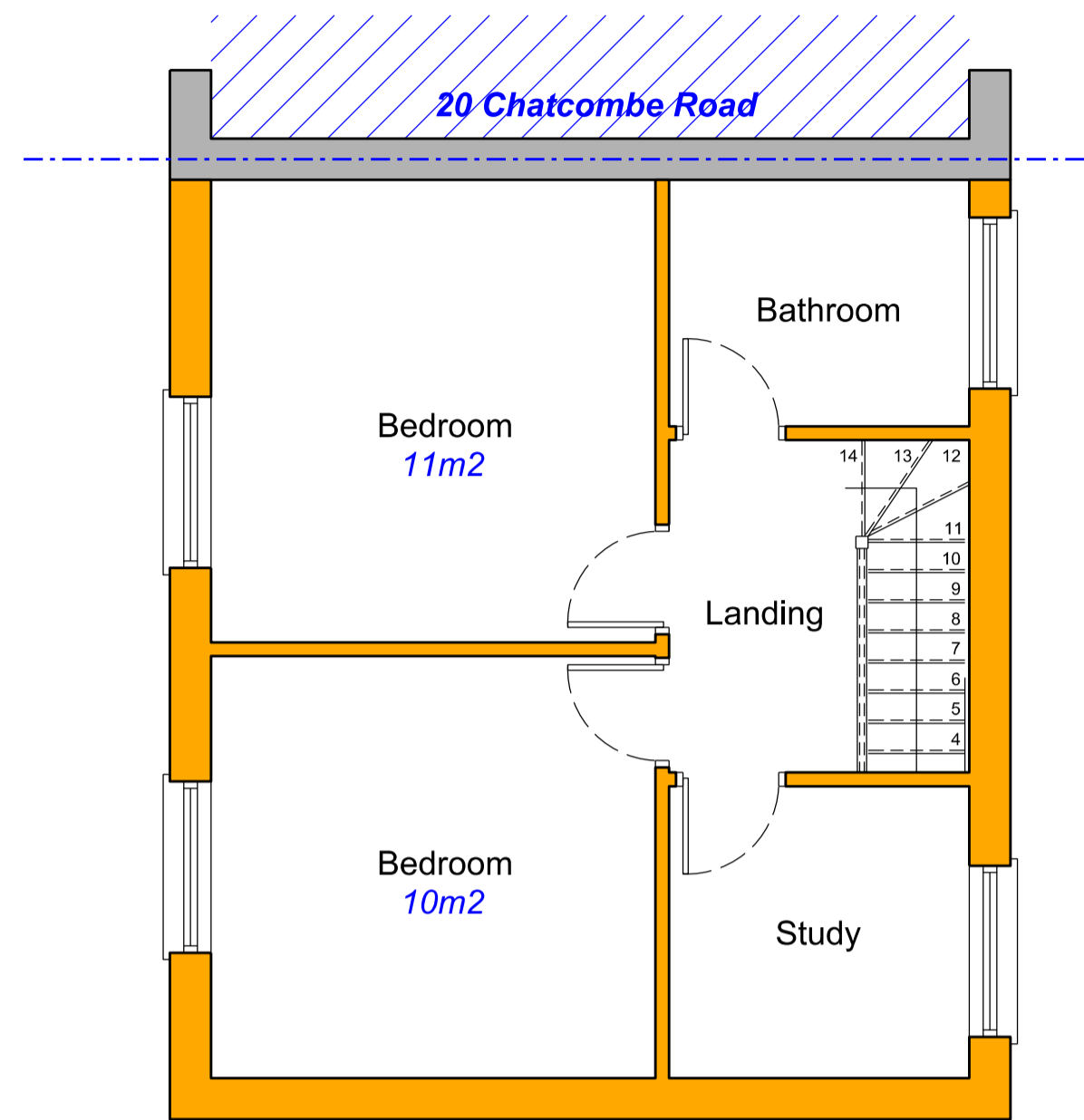
6.0 Scale/Mass and Appearance

The overall design of the proposal has been based on the recently approved scheme at 55 Badminton Road which is an identical size and location in relation to the public highways. Our site is actually larger than the approved scheme which offers greater amenity space. The height of the proposed dwelling has been designed to reflect the heights of the surrounding context, which are predominantly two stories with pitched roofs and finished in render.

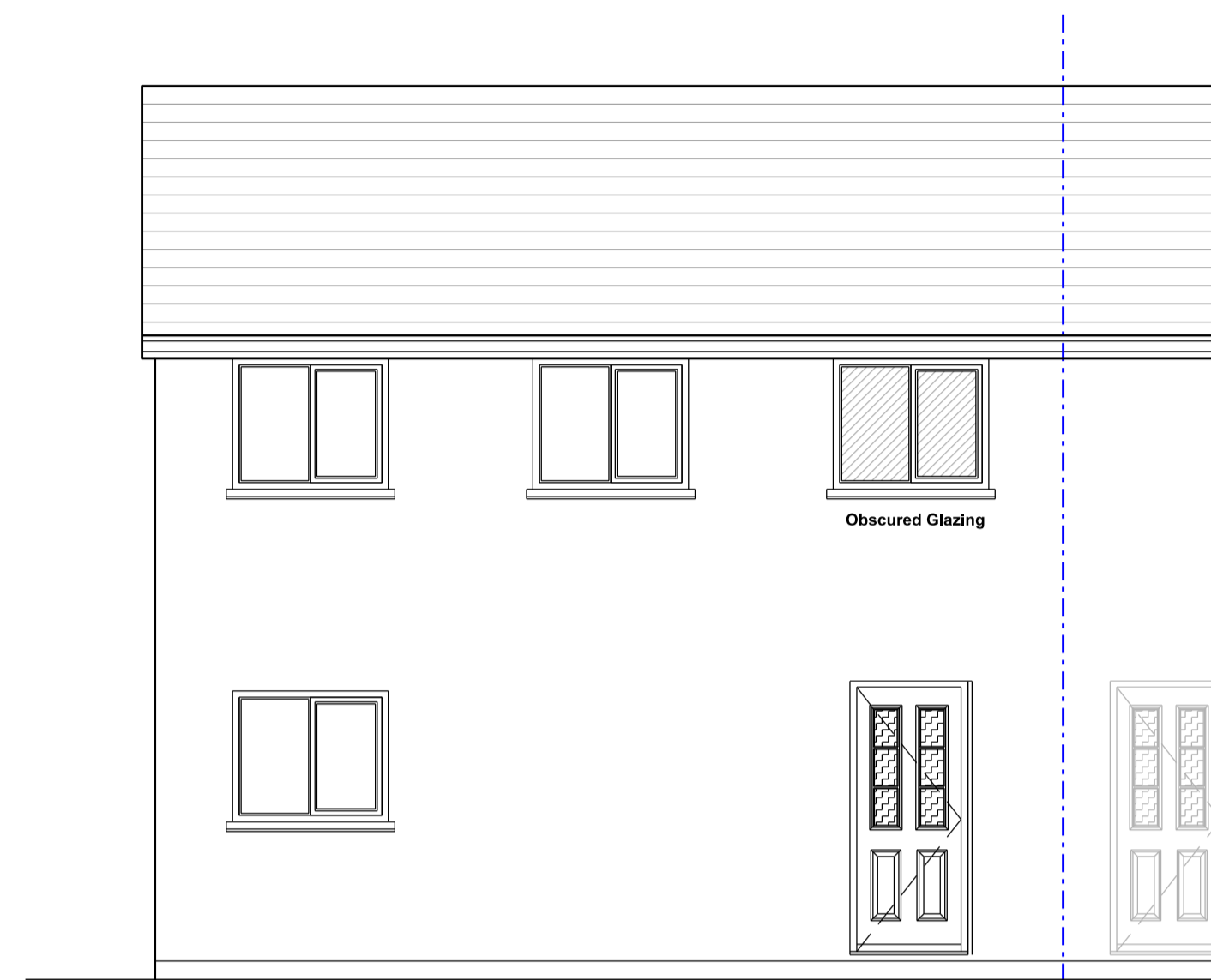
7.0 Conclusion

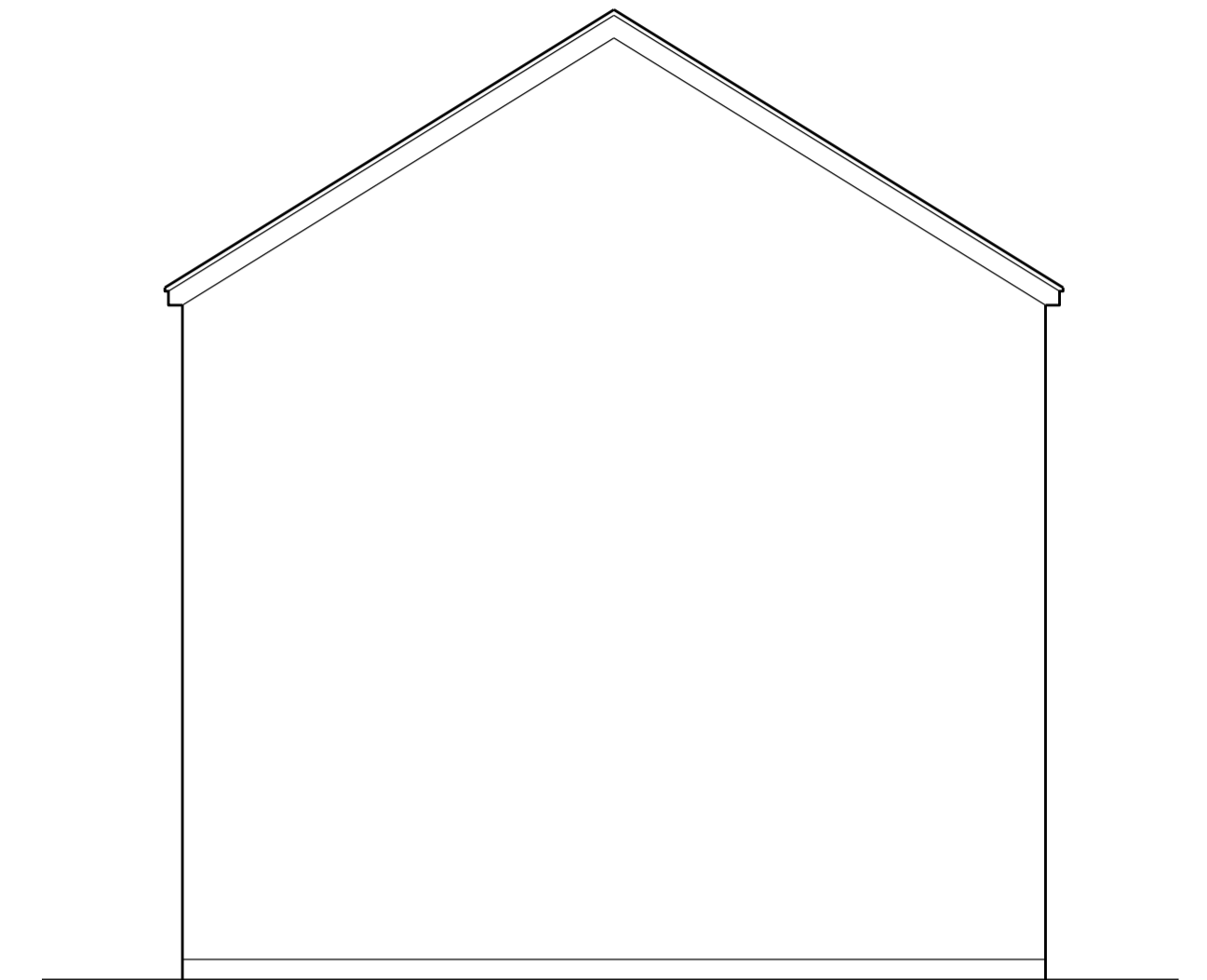

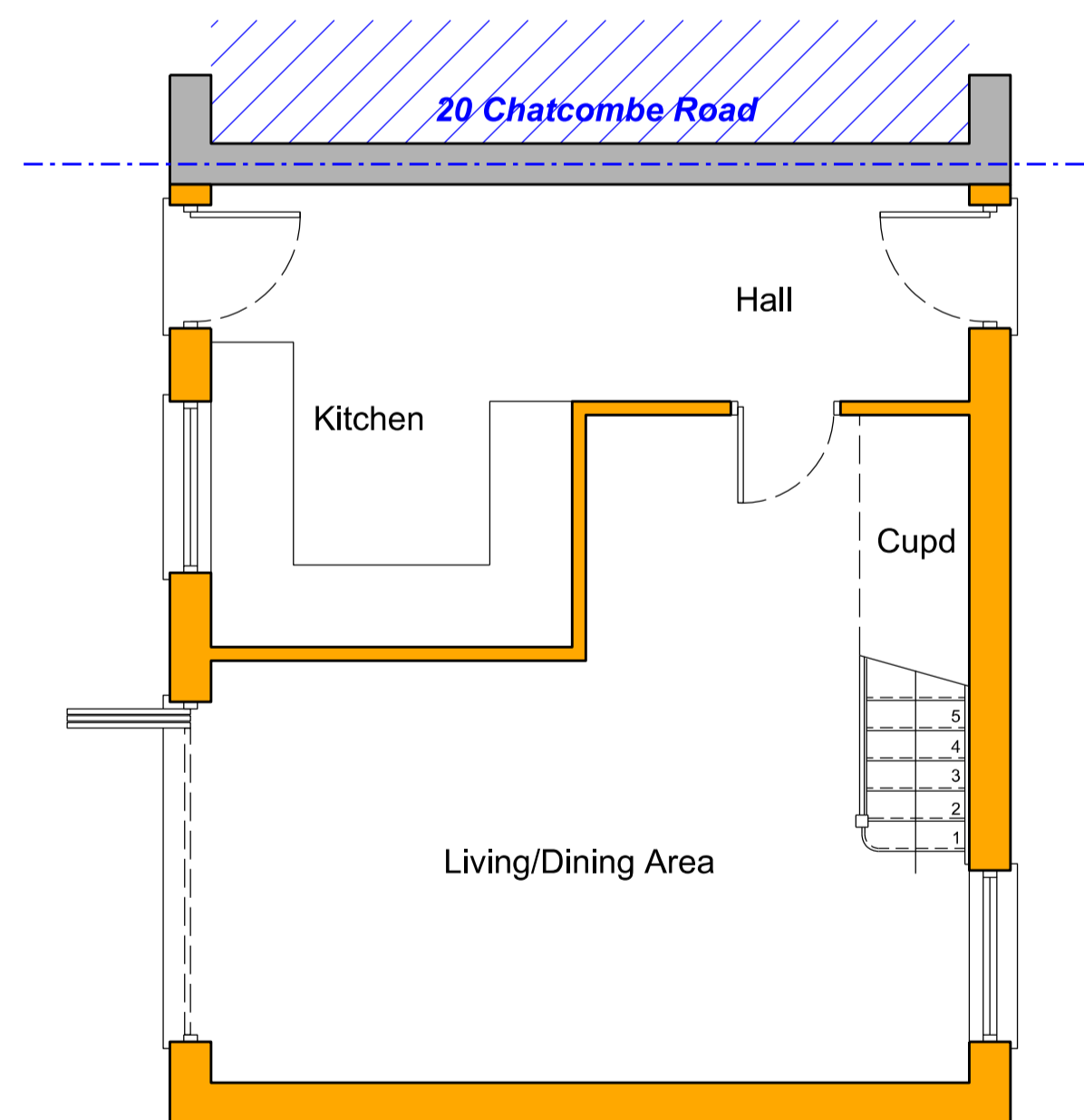
Proposed First Floor Plan



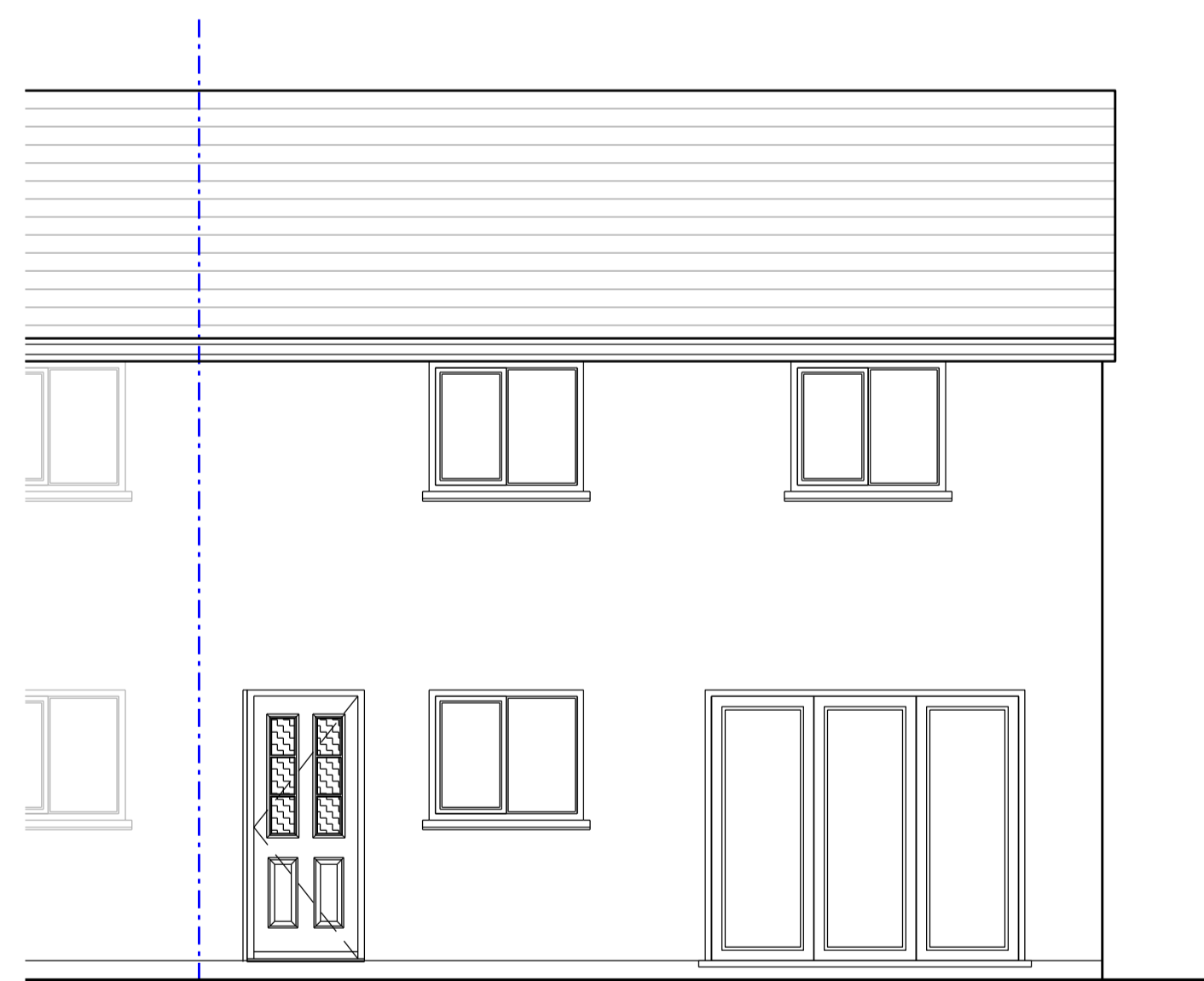
Proposed Front Elevation
