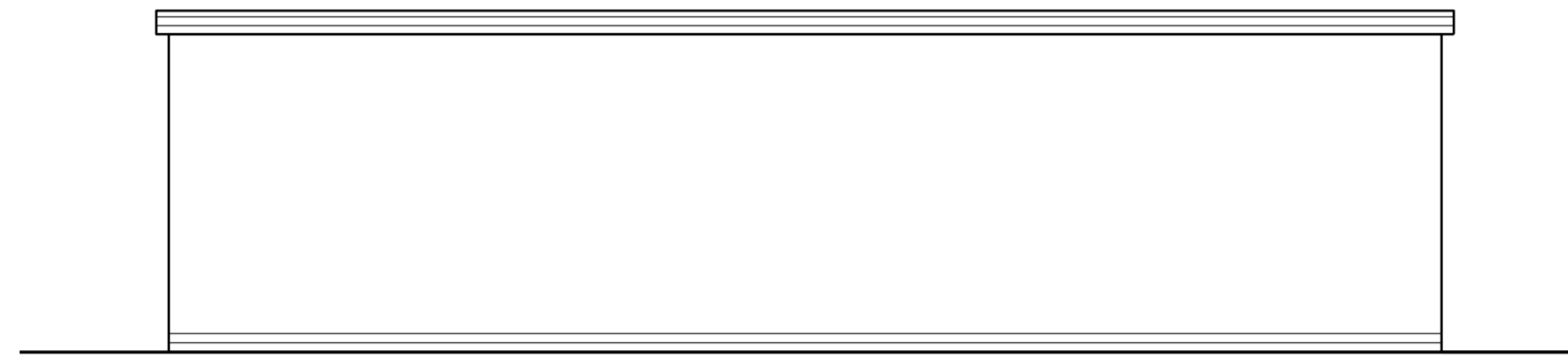

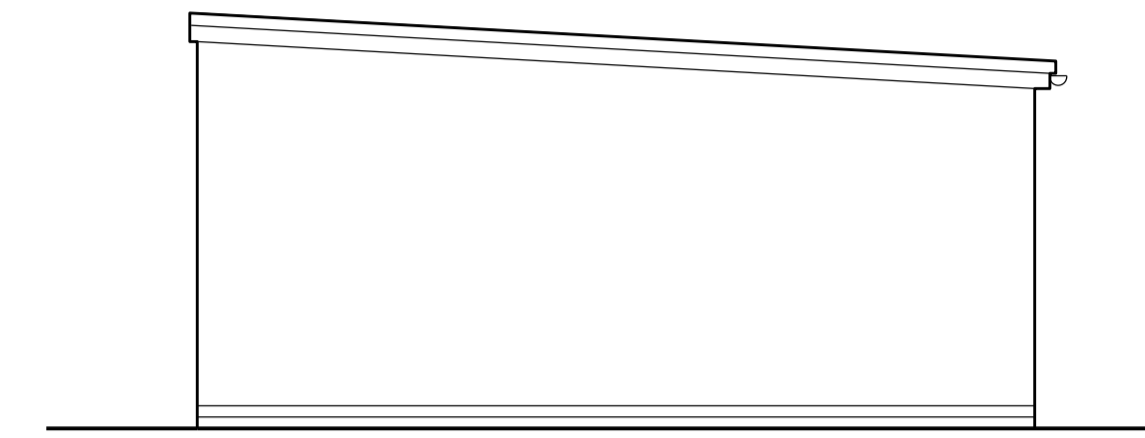




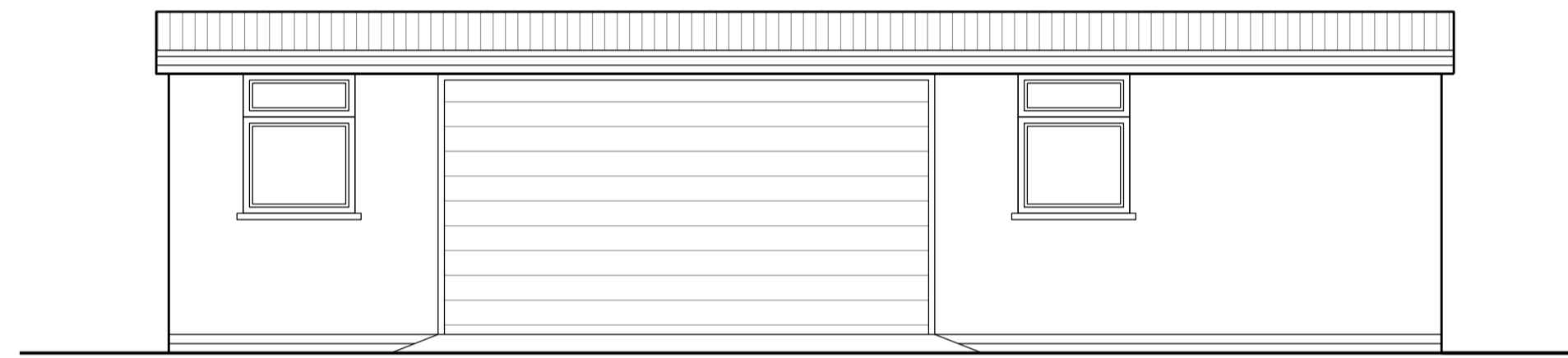

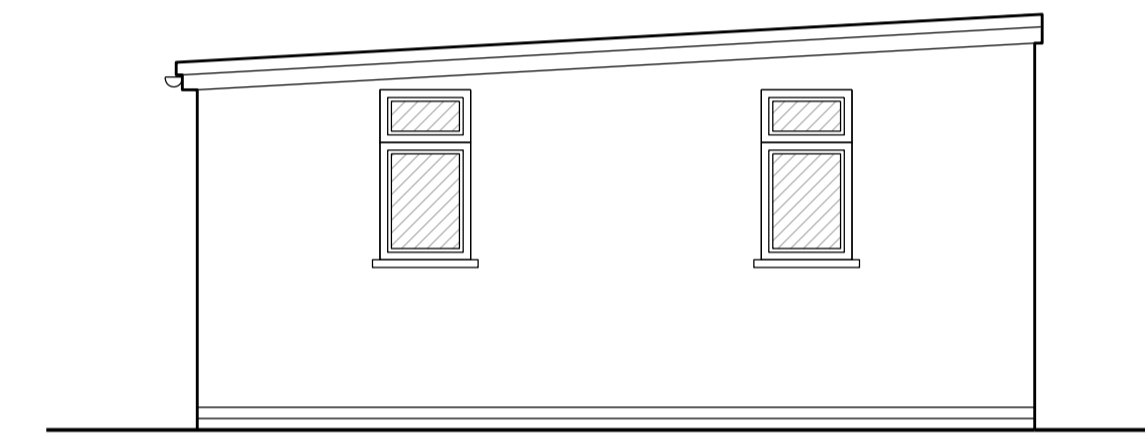
Rear Elevation



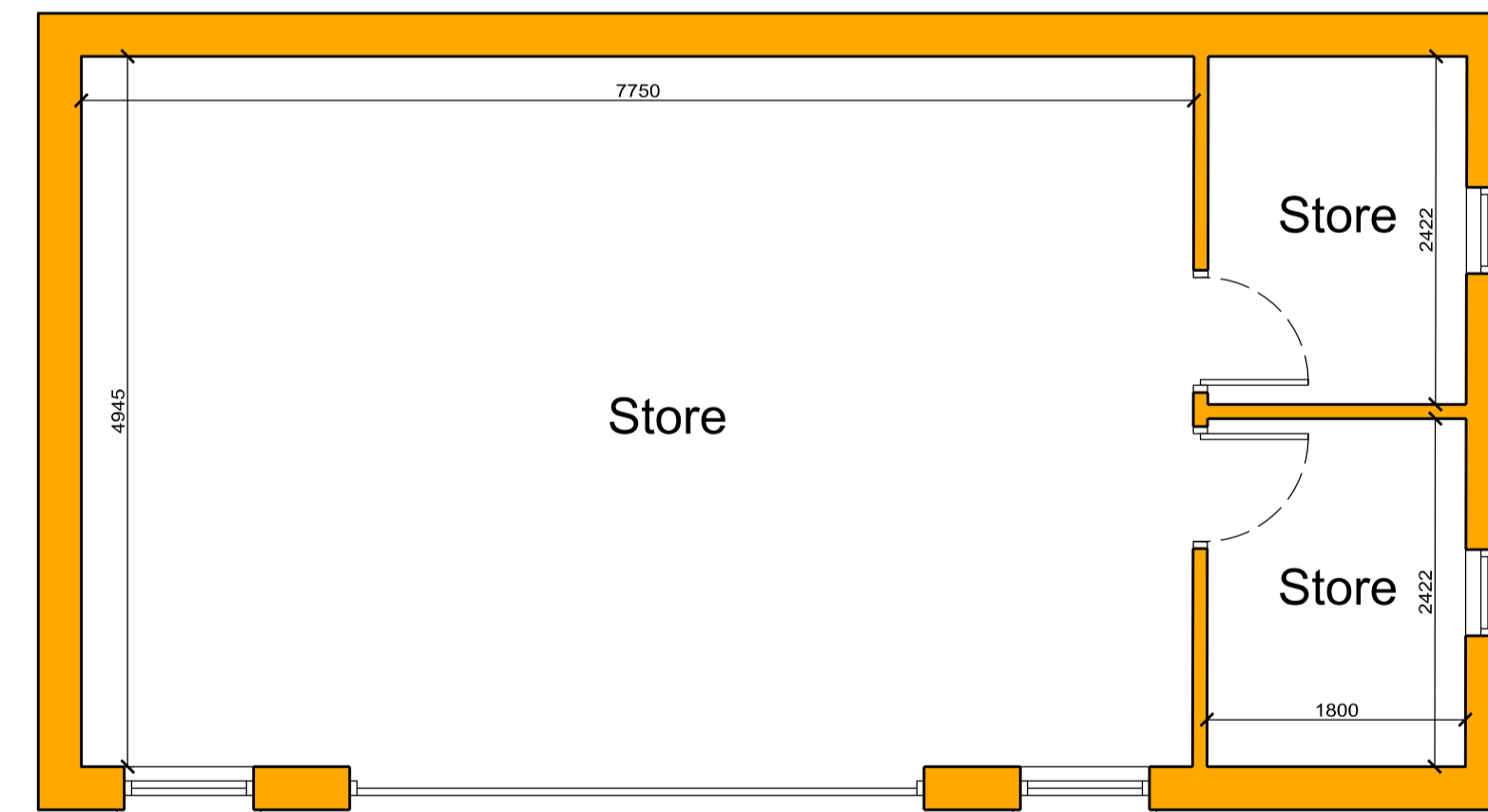
Side Elevation
