The emerging proposals for the next phase comprise student accommodation, a multi storey car park and associated public realm. The student accommodation will provide circa 200 beds and the multi storey car park circa 400 spaces with a total of circa 450 spaces across the site.

MM51 Policy G1 Sustainable Transport addresses Car Parking at para 4.7.17. The emerging proposals for the Quayside site include a multi storey car park to meet an identified need and respond to a deficit of parking in the City Centre. A multi storey car park accords with the uses permitted in the adopted LDO for Quayside and Blackfriars.

The emerging proposals for the MSCP are that a proportion of the spaces would provide a dedicated facility for GCC staff and reduce the likelihood of GCC staff parking in other Gloucester City Centre car parks. This will alleviate the existing Gloucester City Centre car parks from the demand from GCC staff, improving access for retail users through the weekday and provide an additional facility during the evenings and weekends.

MM82 proposes amendments to Site Allocation Statement SA07: Former Quayside House, Blackfriars. The added text is 'Opportunities to improve flood protection along the River Severn as part of a wider regeneration scheme should be explored in consultation with the EA.'

The proposed modification is supported in that liaison with the EA is good practice and will be valuable to inform emerging proposals for the site. However, it is essential that any strategic scheme which may emerge from EA work to support flood protection along the River Severn does not prejudice the timely delivery of Phase 2 of the Quayside House site. This is essential to meet an identified need for student accommodation at the site from 2023.
