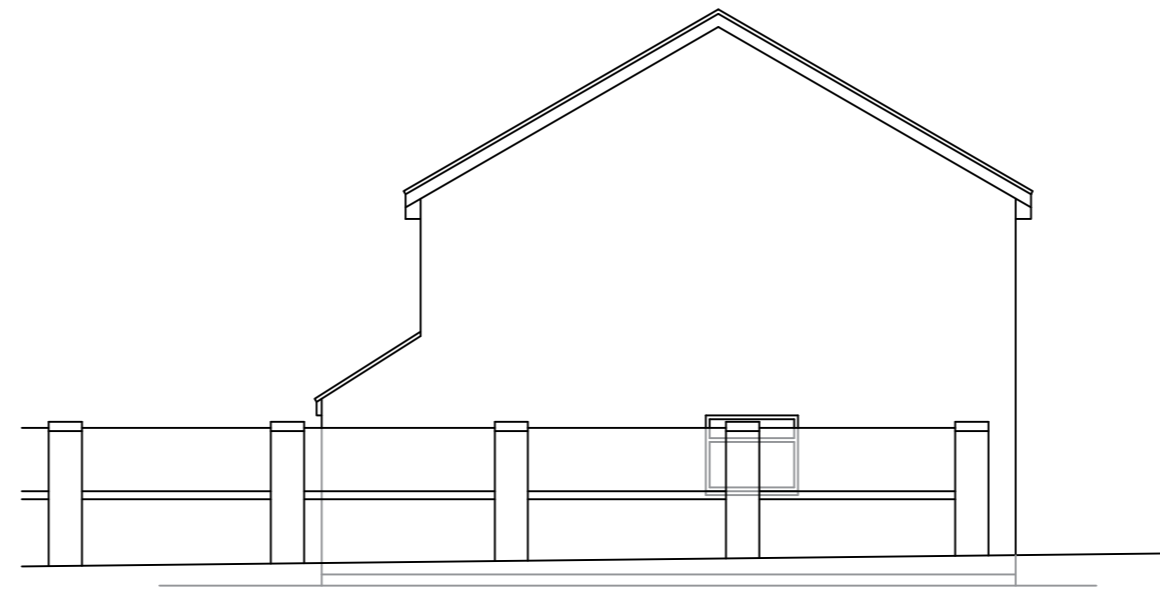

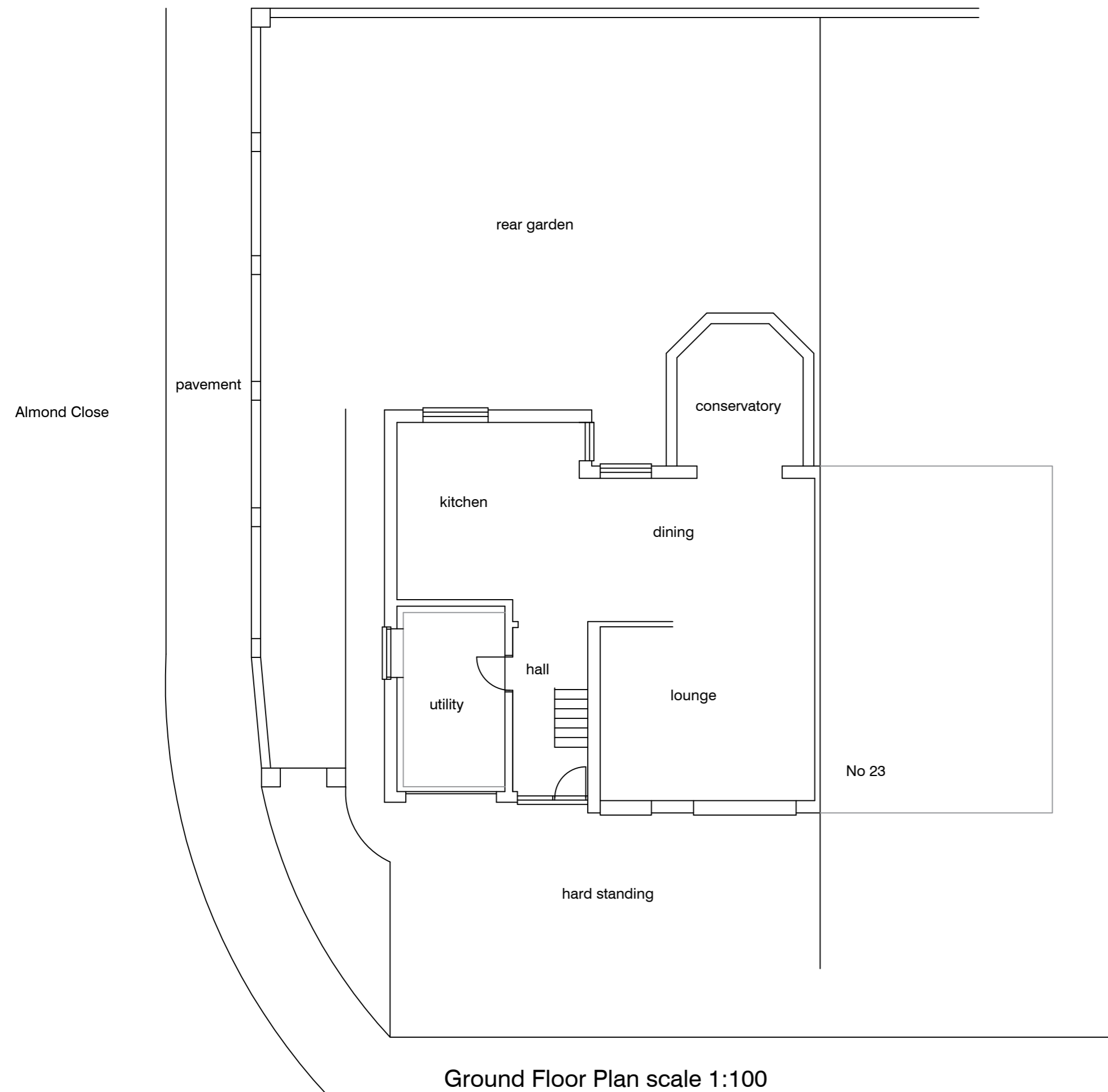
Front (north-east) Elevation

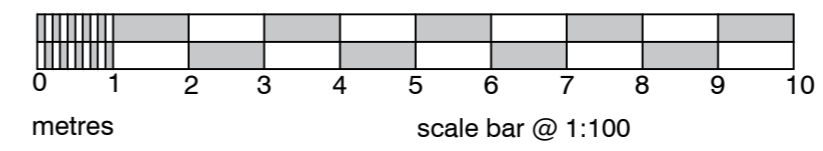
Side (south-east) Elevation

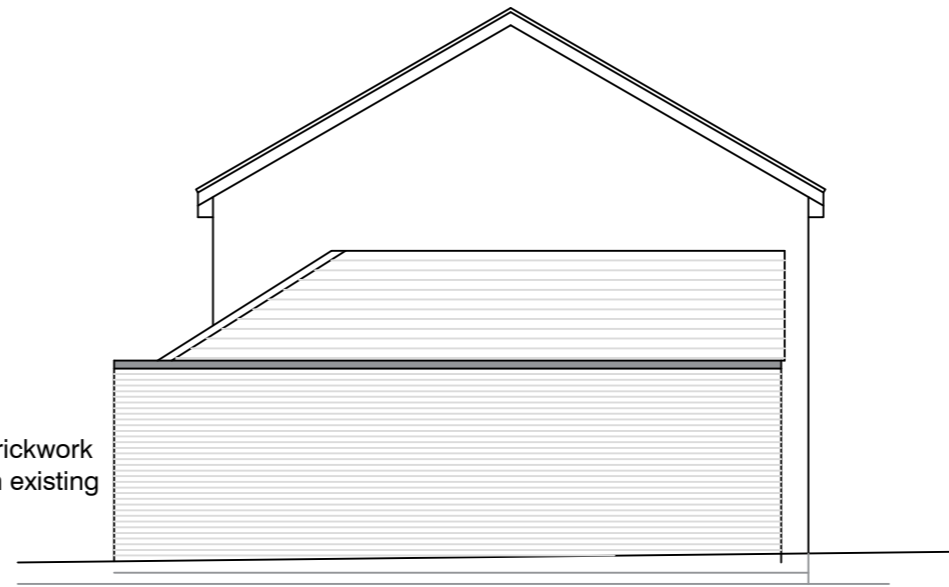

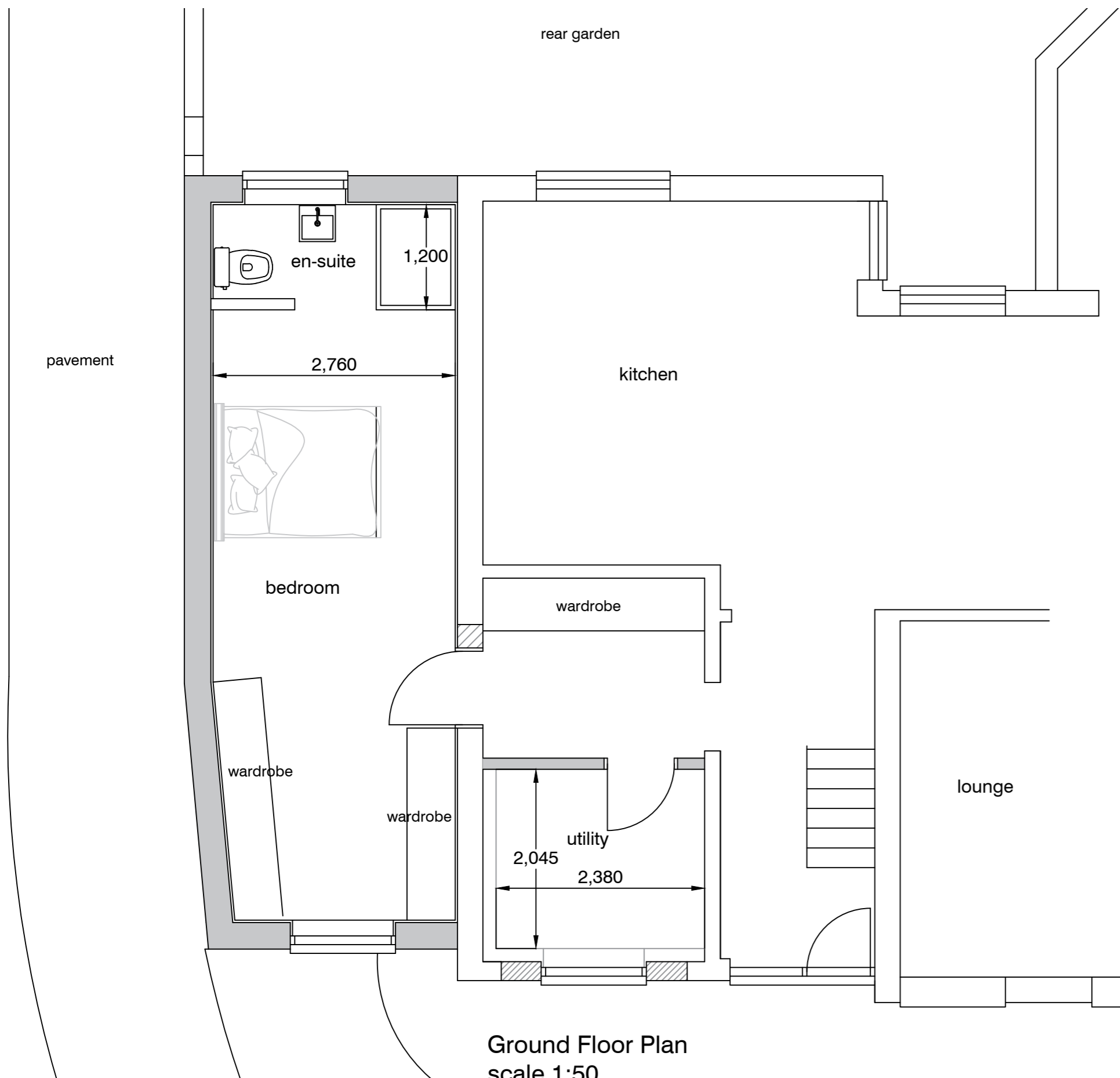

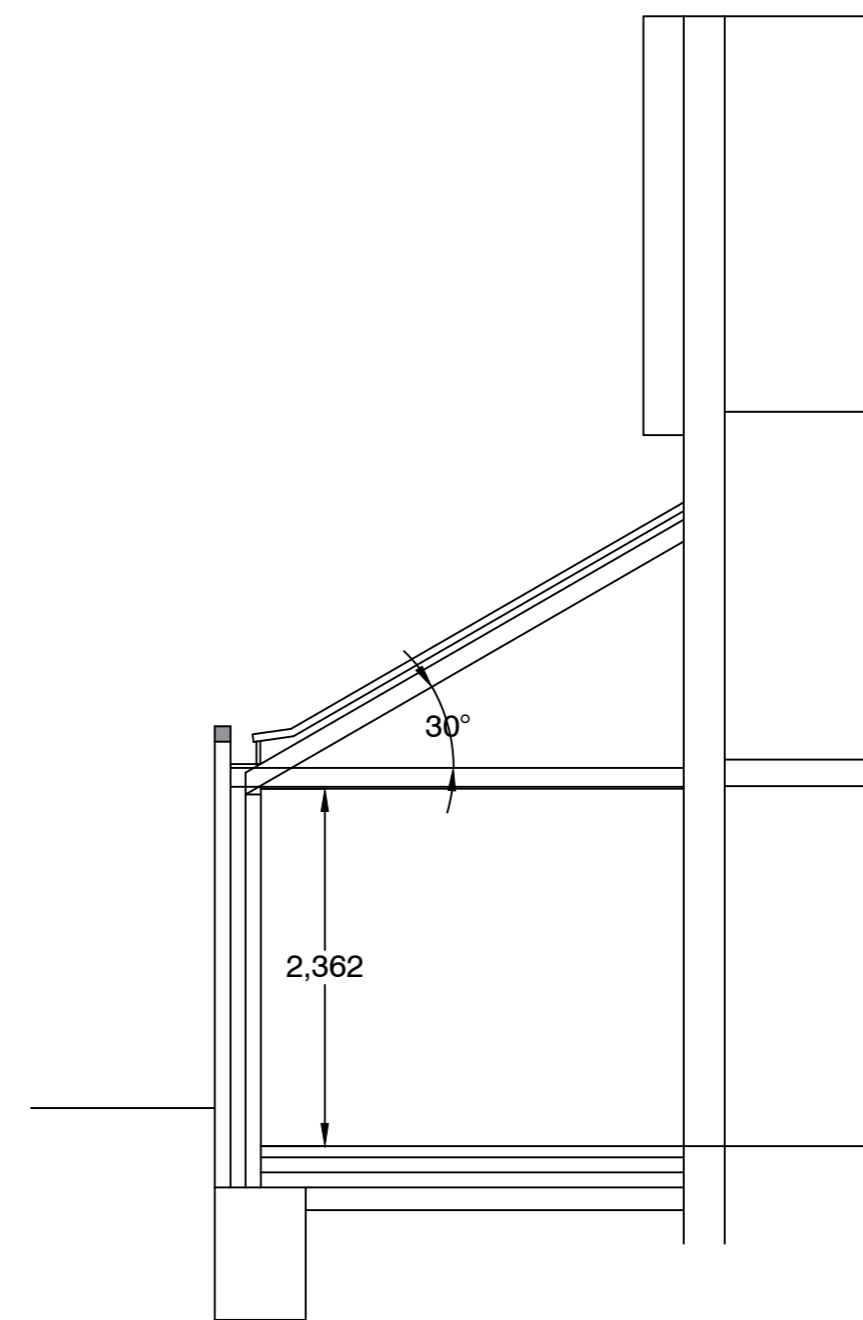

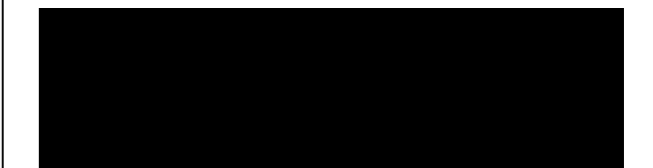

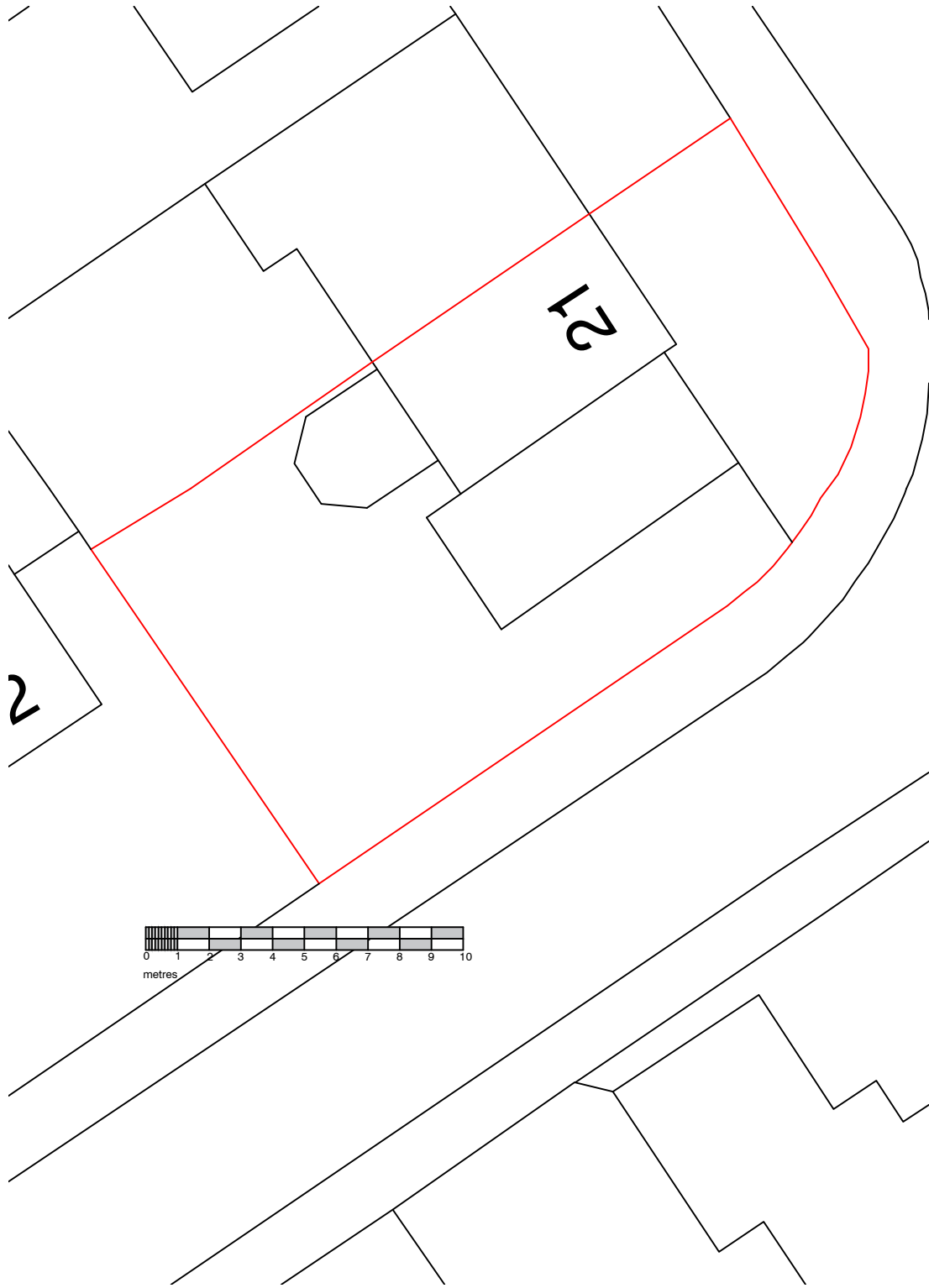

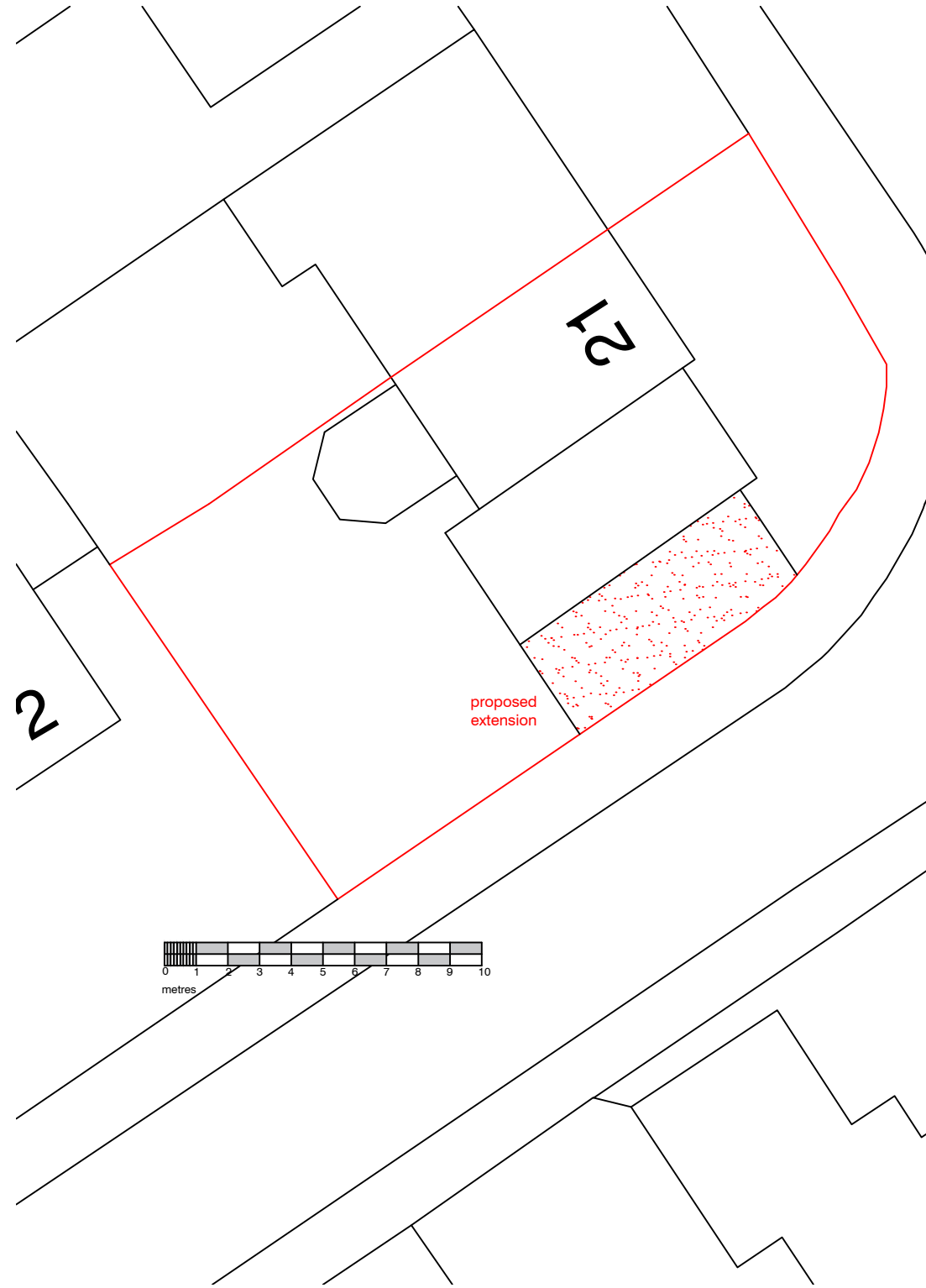
