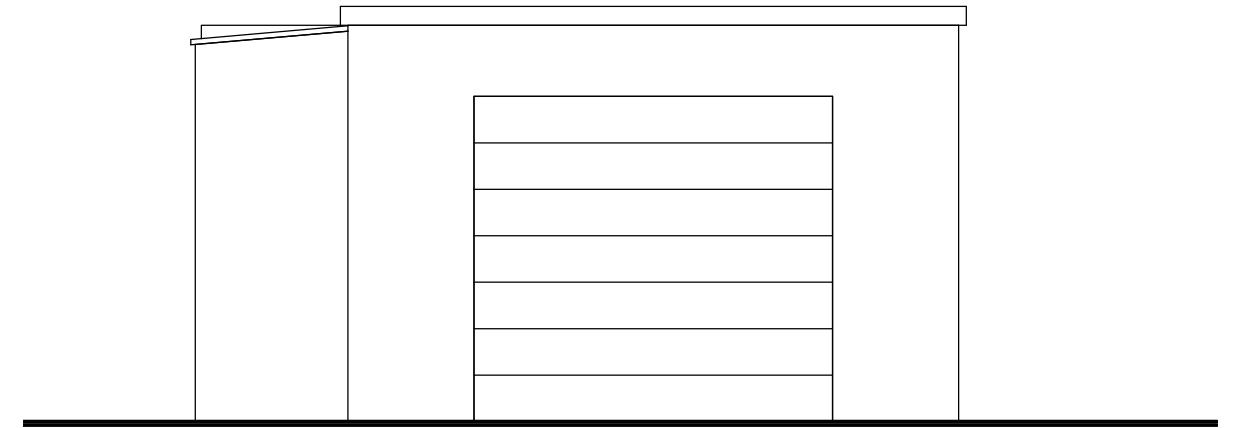

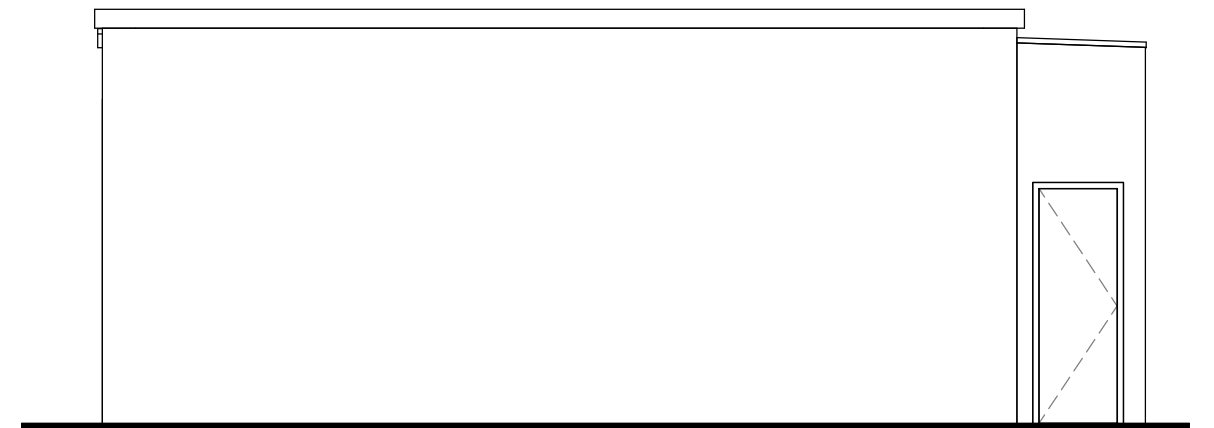


GARAGE FLOOR PLAN

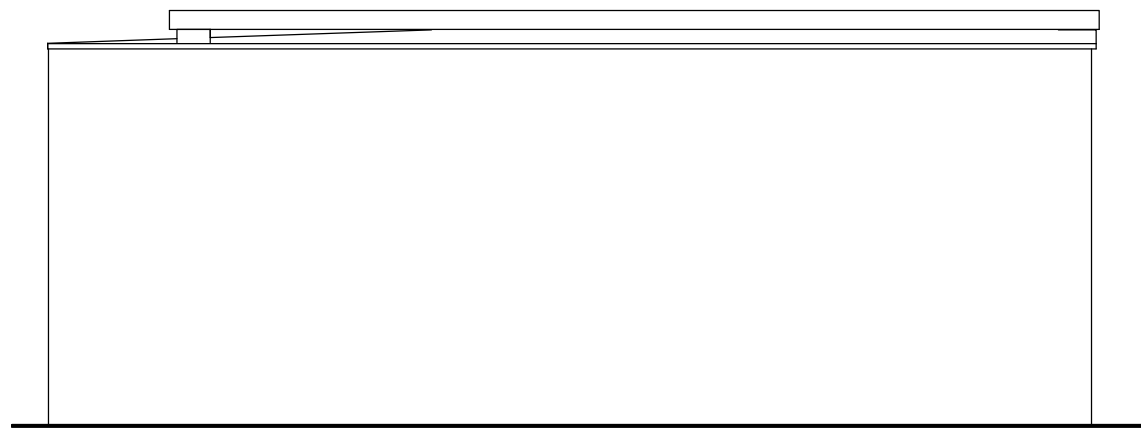

EXISTING HOUSE ELEVATIONS



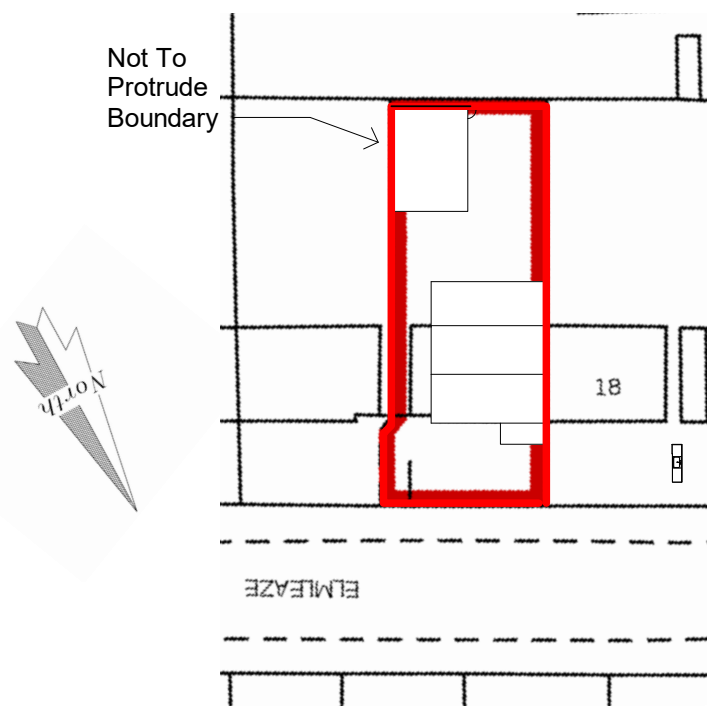

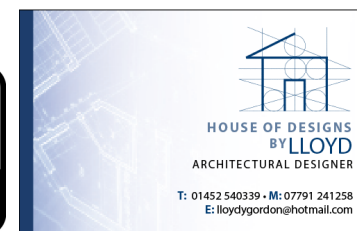


3D VIEW OF FRONT

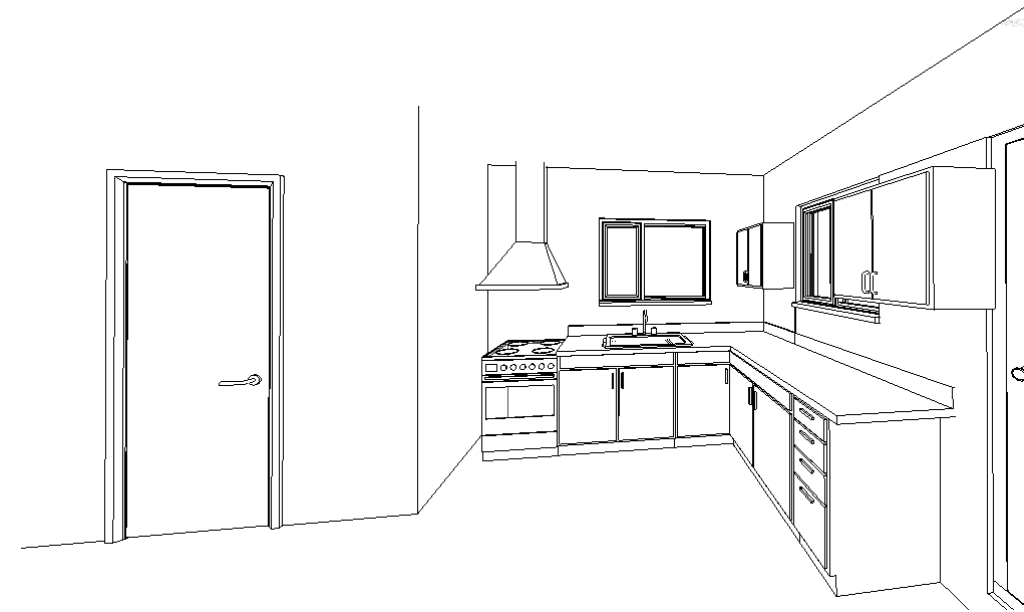

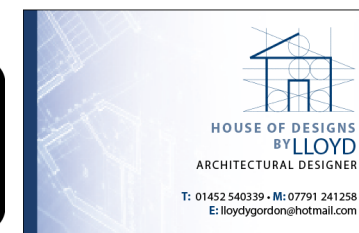


3D VIEW OF KITCHEN

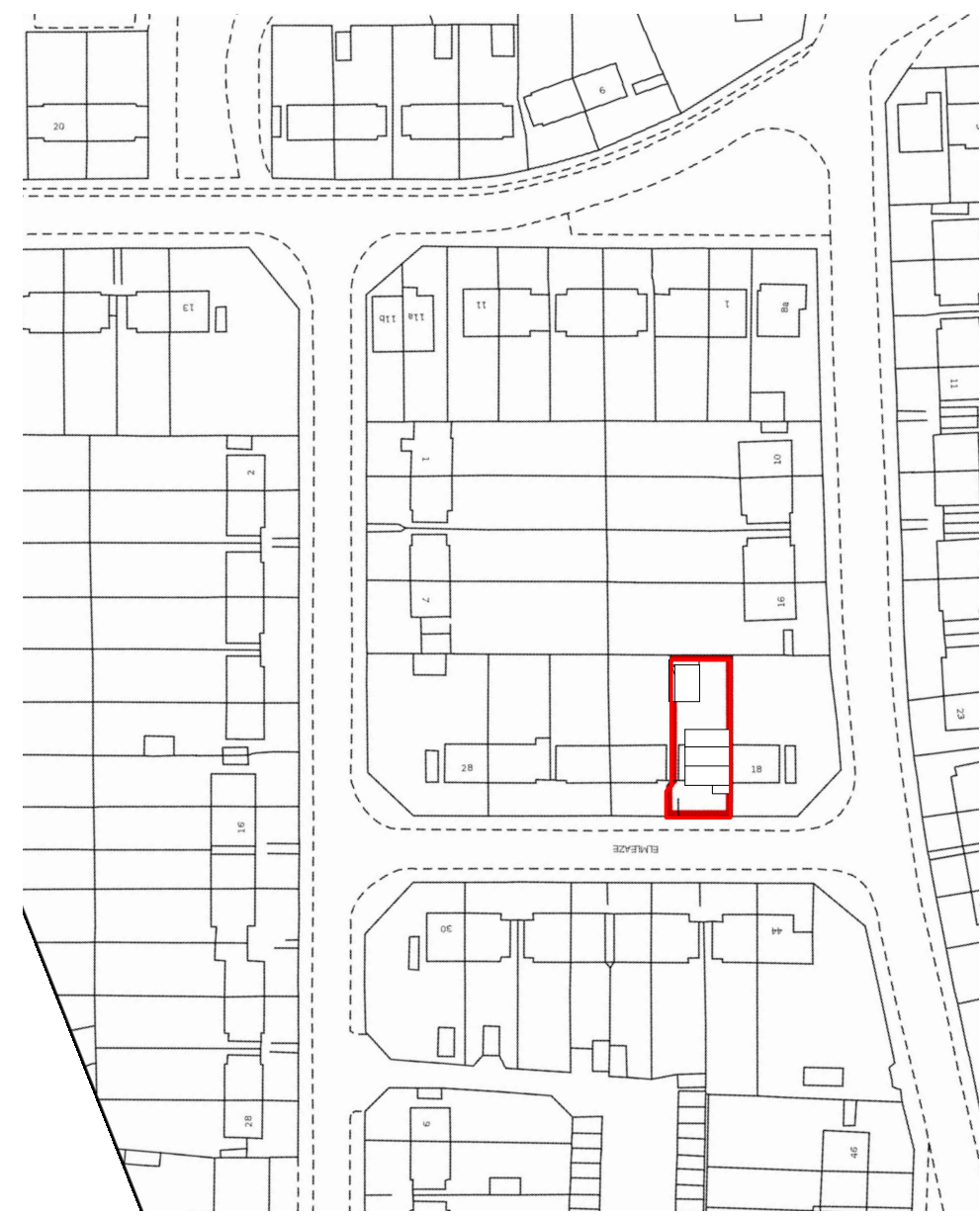
