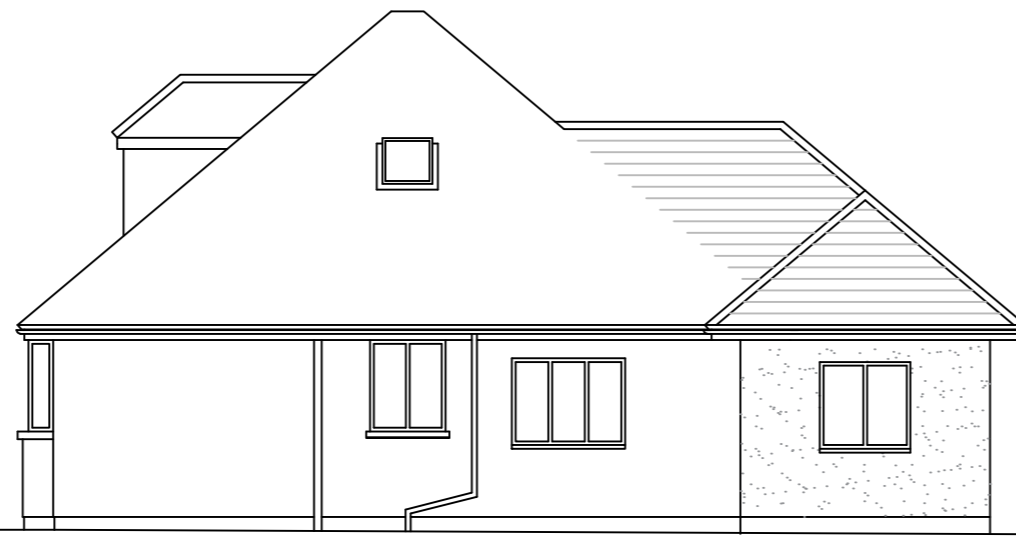

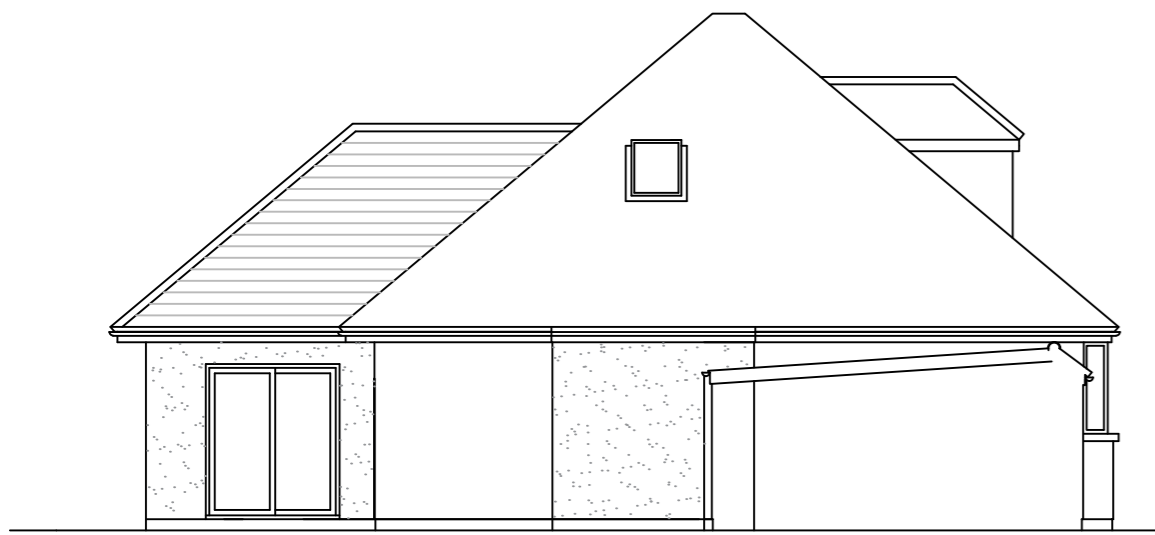
Front Elevation

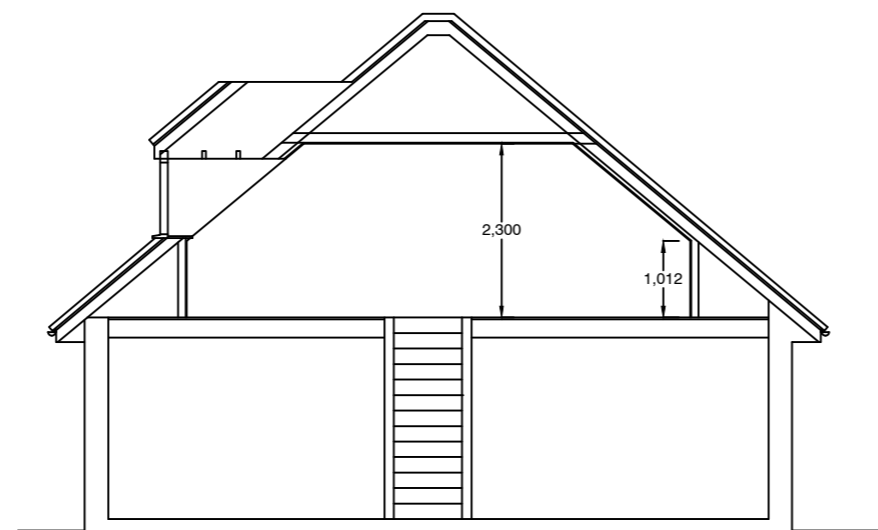
Side Elevation



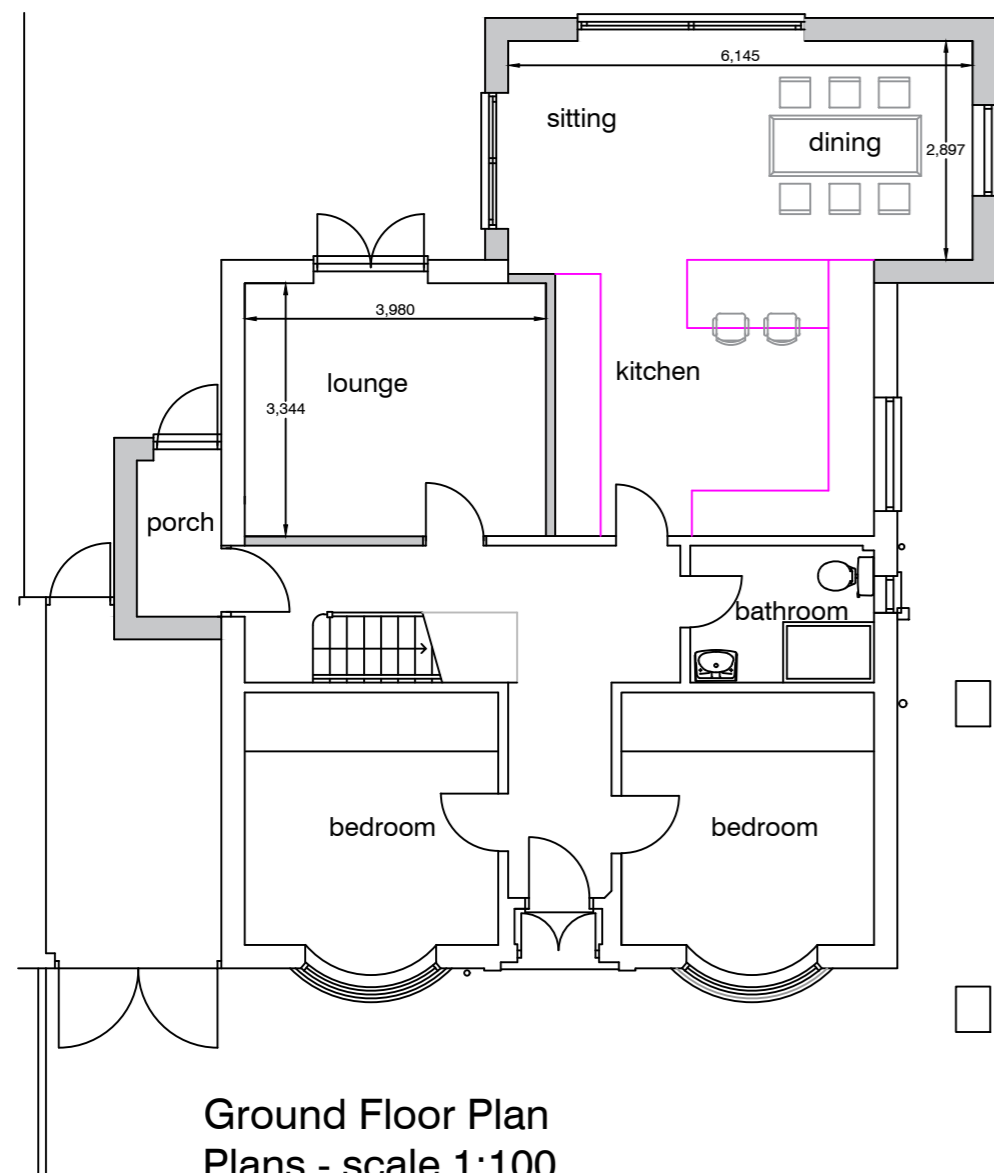
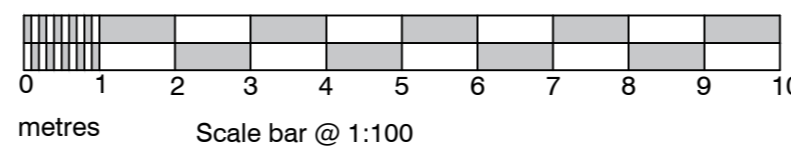
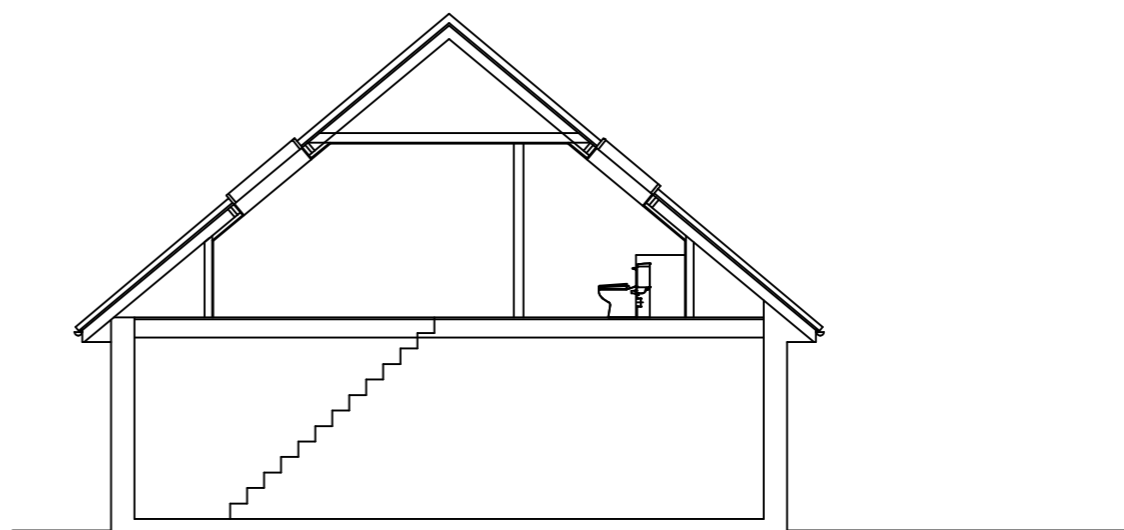
Rear Elevation



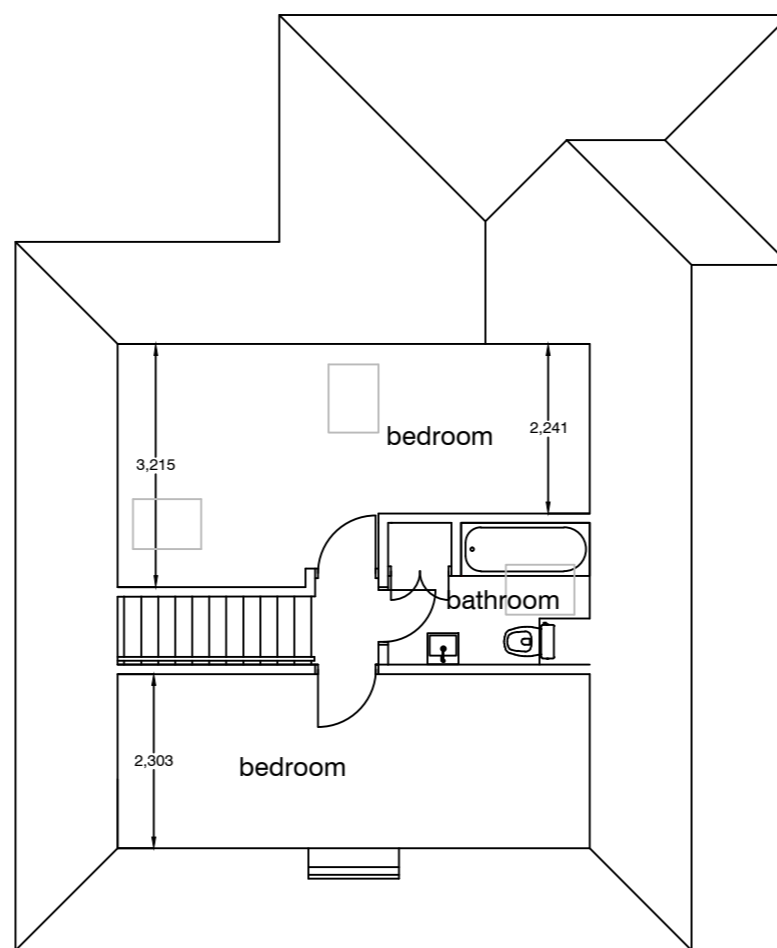

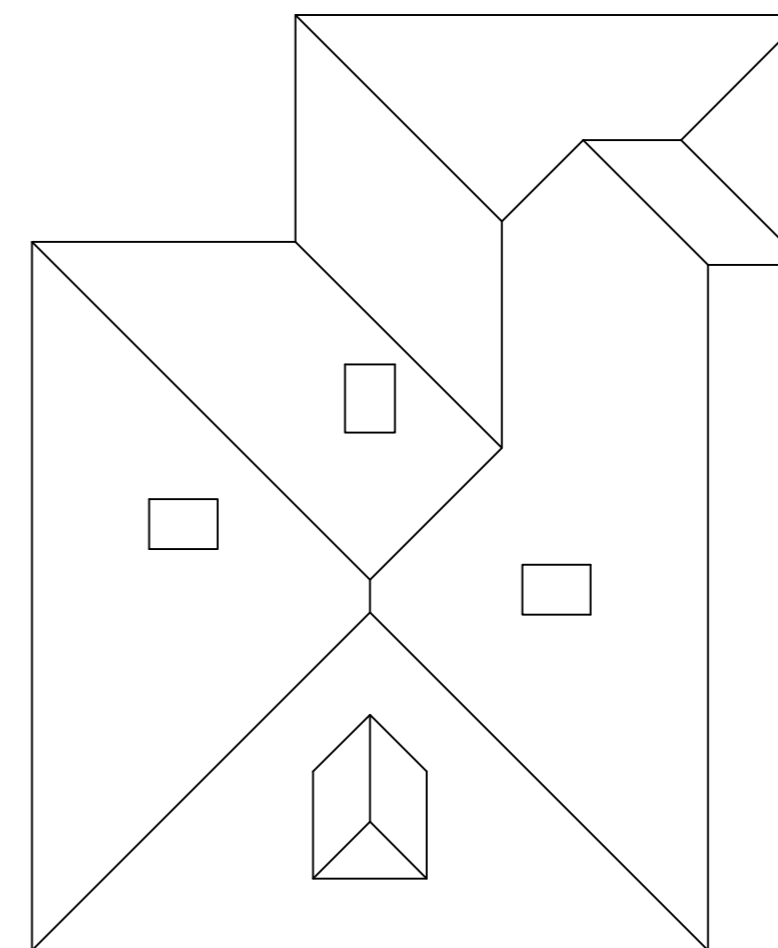

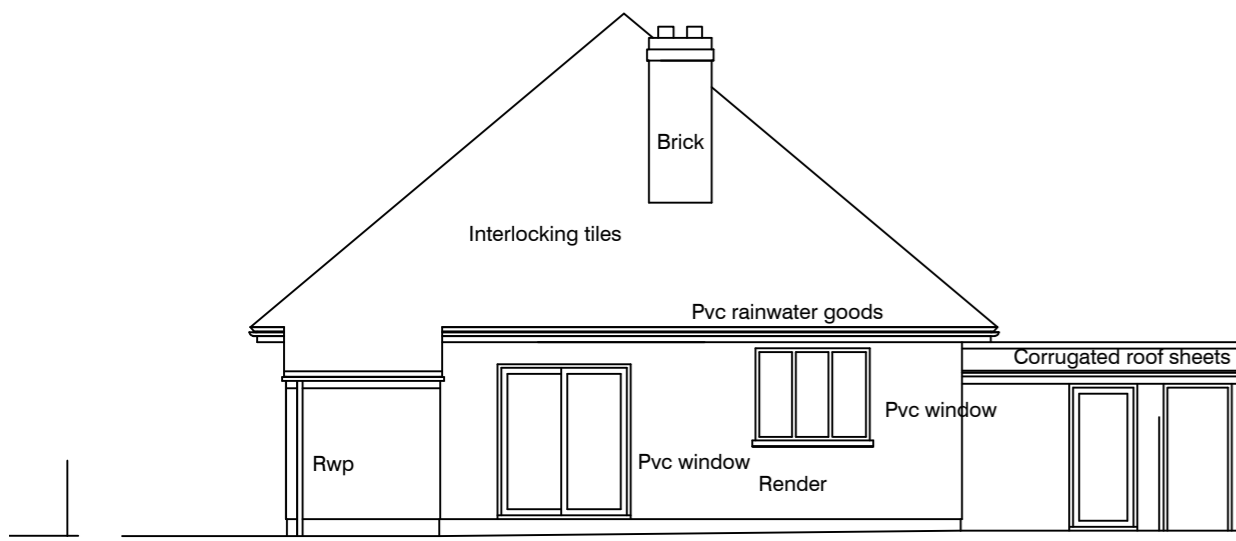

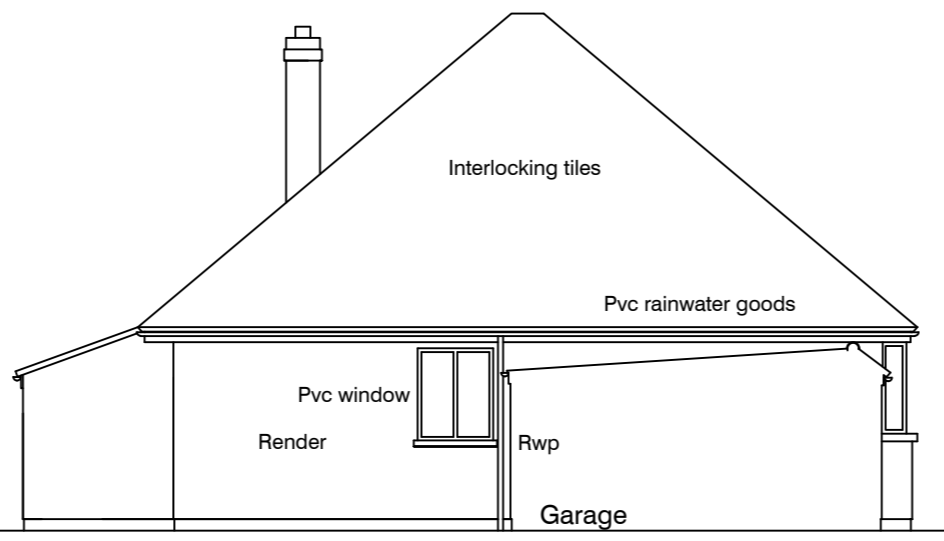
Front Elevation

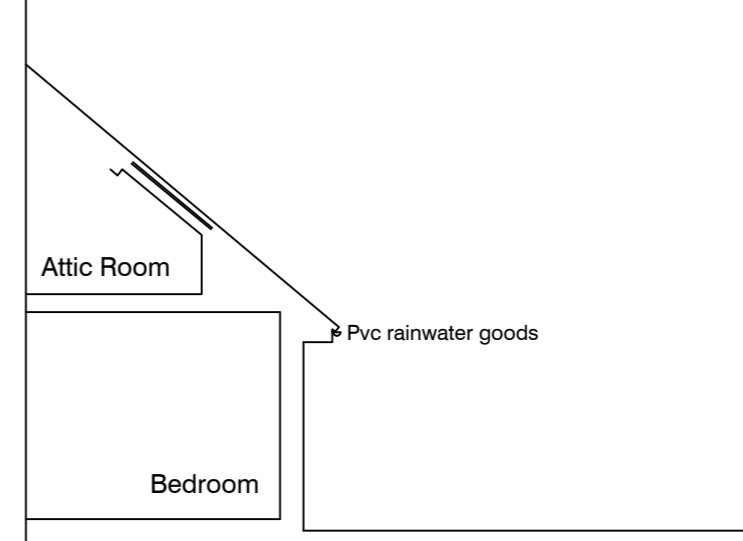
Side Elevation

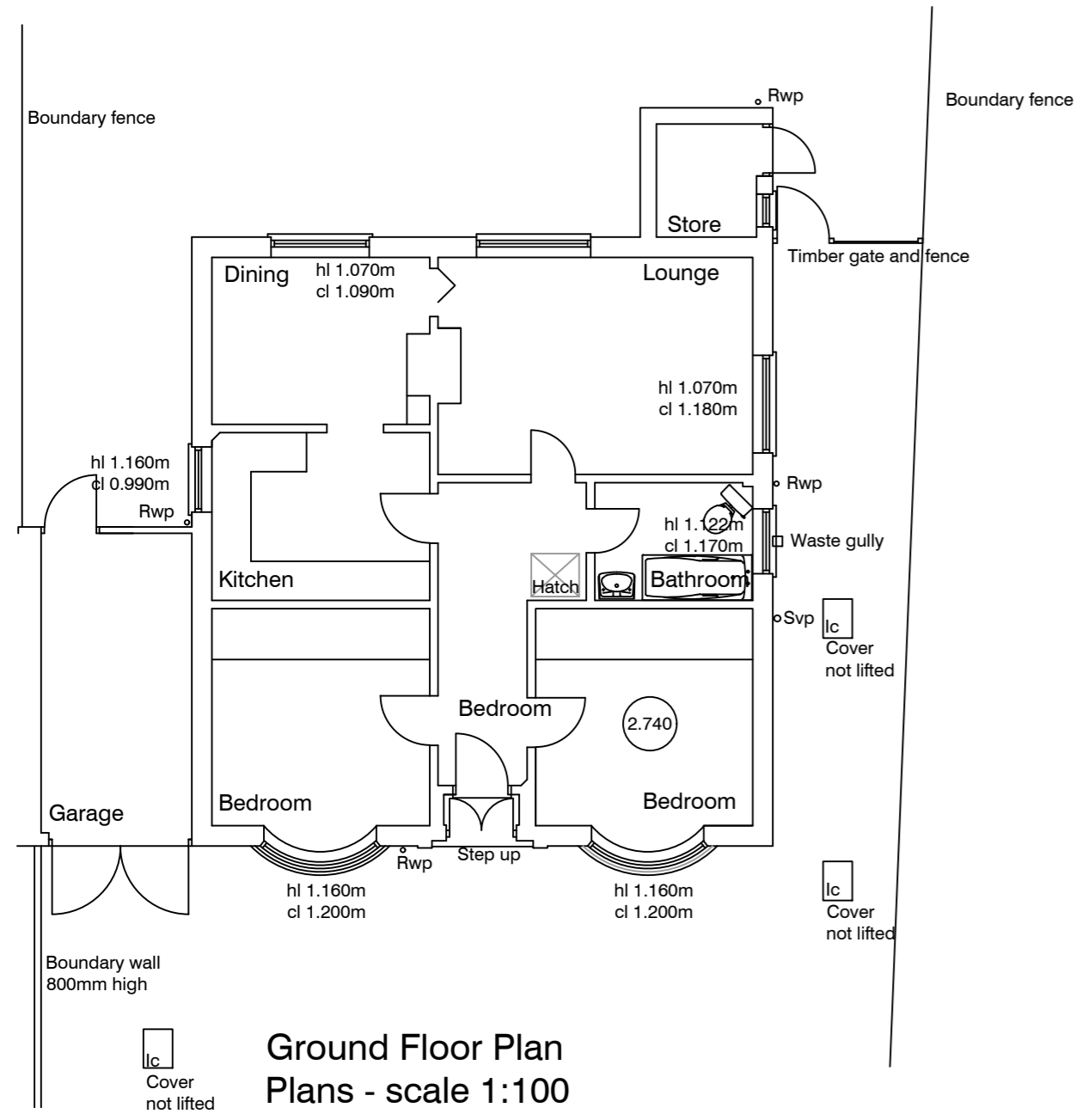

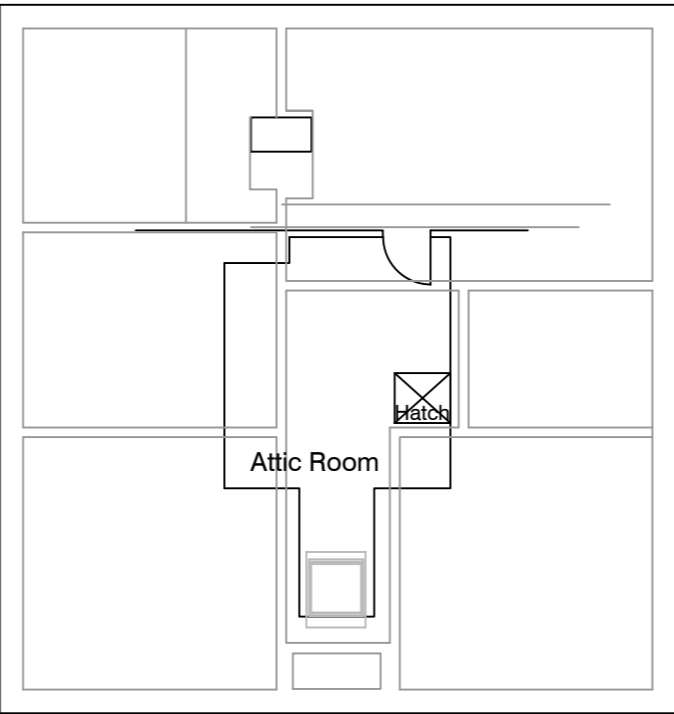

Plans - scale 1:100



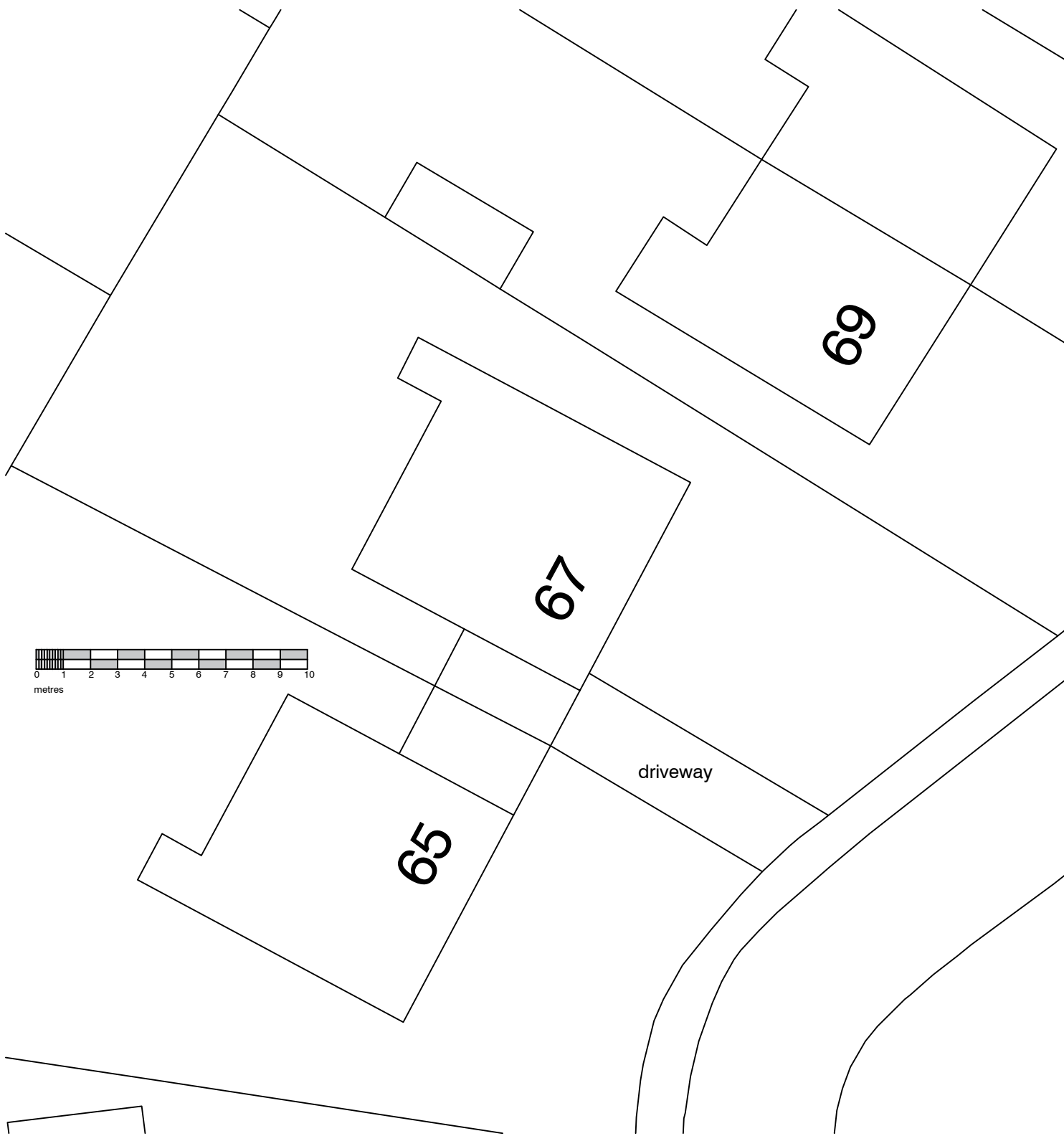
Attic Plan



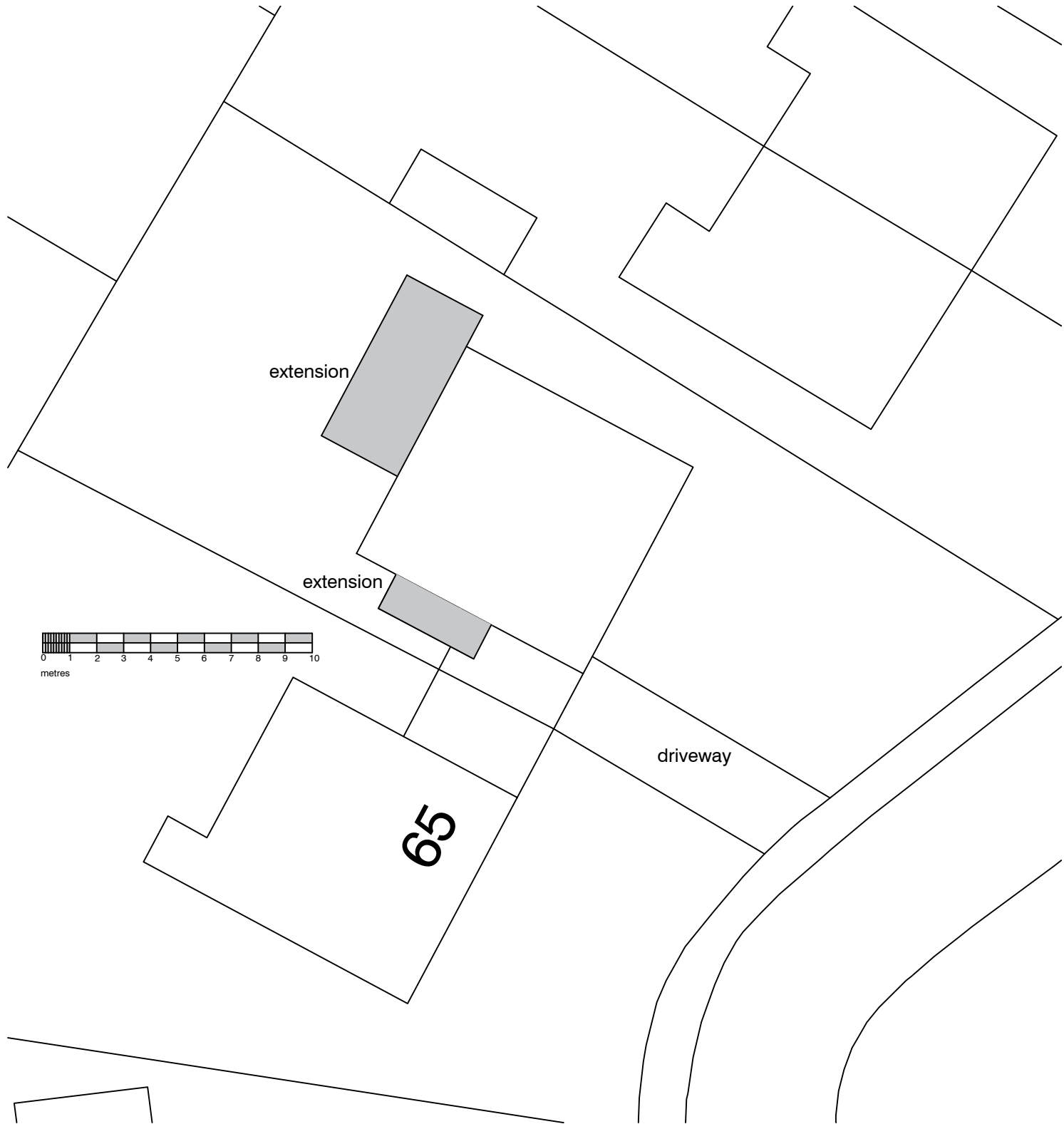
