The proposal has been assessed against the above criteria and falls within the limits of 'permitted development' by virtue of Schedule 2, Part 1 Class A of the Town and Country Planning (General Permitted Development) (England) Order 2015. The proposal therefore constitutes Lawful Development and as such a Certificate of Lawful Development can be issued
