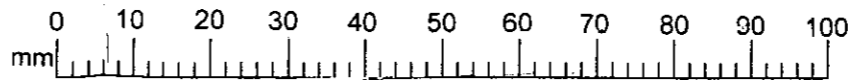
Existing Block Plan

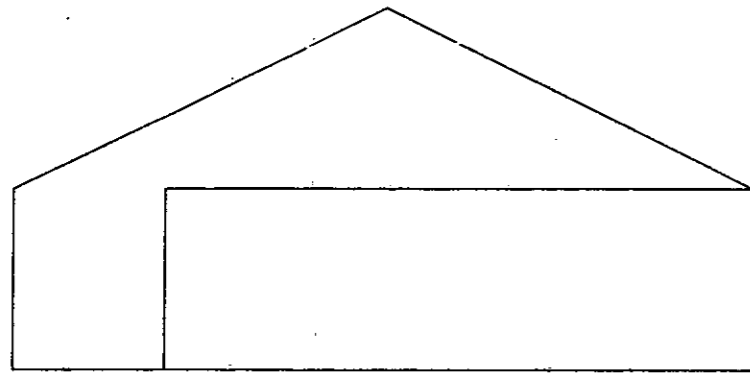

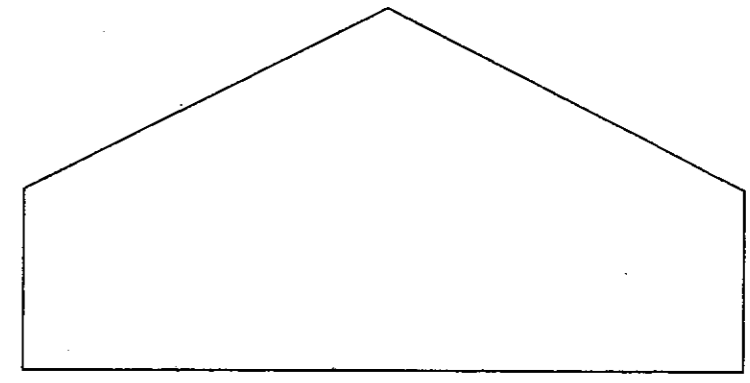

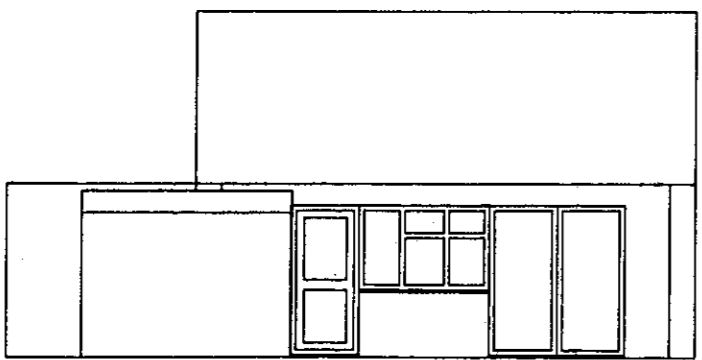
Existing East Elevation

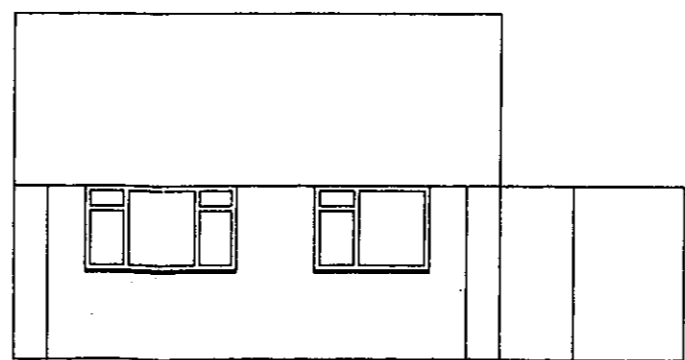
Existing West Elevation

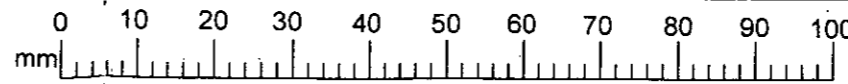


Existing North Elevation

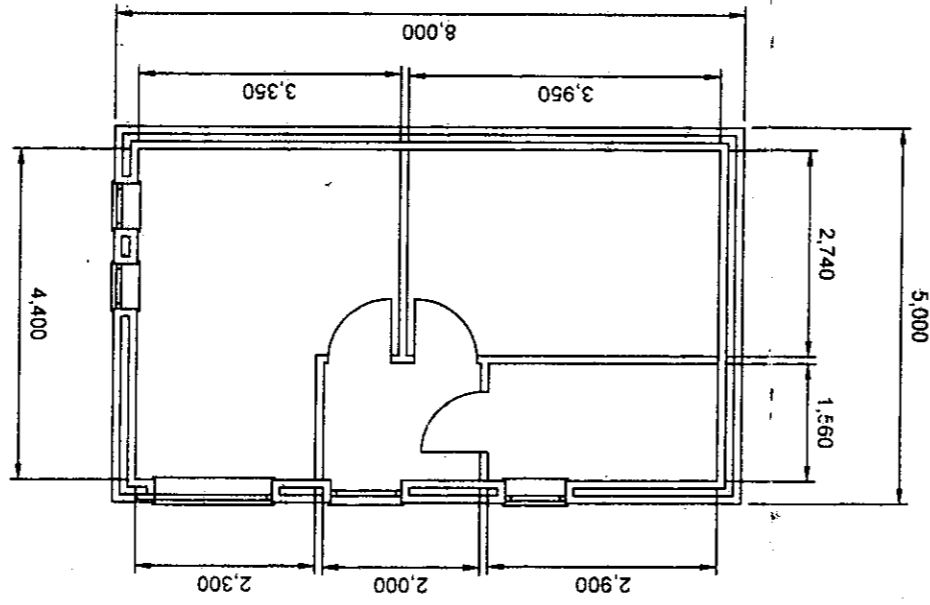

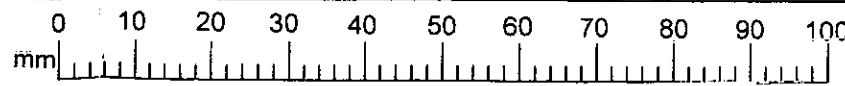


Proposed Annexe Floor Plan

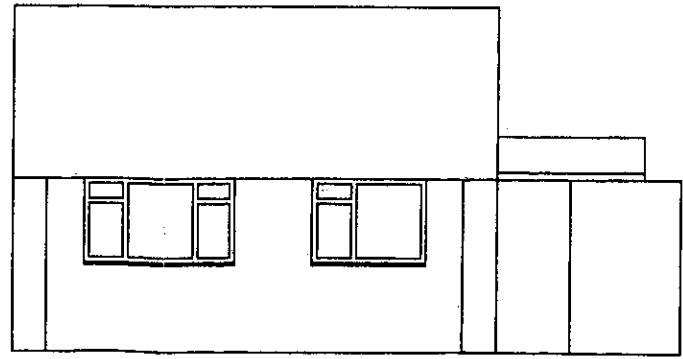
Proposed East Elevation

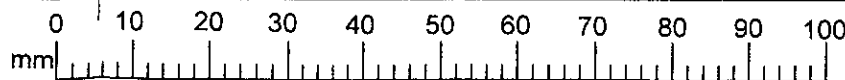
Proposed South Elevation

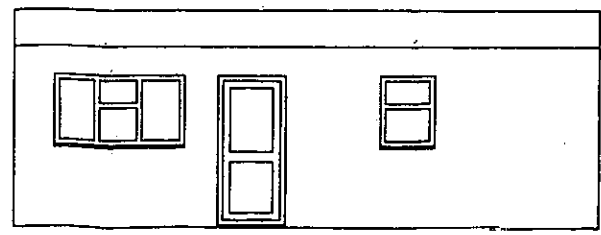
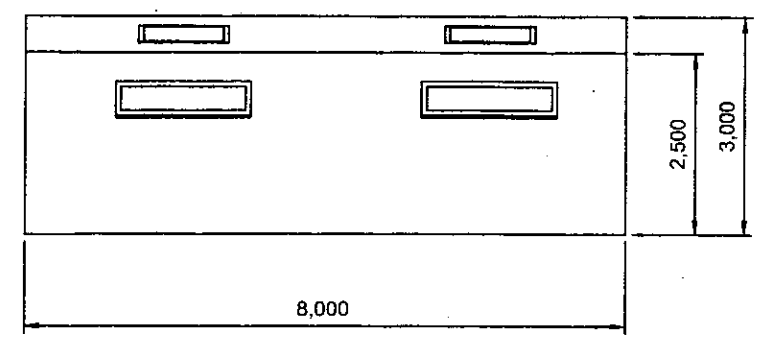
Proposed West Elevation
